 - a. At every point of sale/supply a sign detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises;
 - A sign prominently displayed at the premises, which identifies by name the manager for the time being on
- The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - Intoxicated persons and minors are not to be served or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.
- 6. Alcohol may only be sold in sealed containers for consumption off the premises

The recommended conditions are consistent with those associated with an off-site special licence.

DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for Greytown Country Market to be held at 113 Main Street, Greytown, and known as Stella Bull Park where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Reason for decision:

I have considered this application on the basis of the reports received from the Licensing Inspector, the Police and the Medical Officer of Health, who do not oppose the issue of the licence.

The South Wairarapa District Licensing Committee Chair, acting pursuant to s.22 of the Act, therefore accordingly grants the Special (off site) Licence to Marlborough Wines Limited, subject to the following Conditions 1 - 6.

Accordingly, we set the following conditions under s147 on the licence:

Sunday 19th January 2020, 9:00am to 1:00pm Sunday 16th February 2020, 9:00am to 1:00pm Sunday 15th March 2020, 9:00am to 1:00pm

- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises
- 3. A certificated manager must be on duty at all times when the premises are open for the sale, supply and consumption of alcohol.
- 4. The Licensee must display signage as follows:
 - a. At every point of sale/supply a sign detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and

 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.

 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.
- 6. Alcohol may only be sold in sealed containers for consumption off the premises
