1. Introduction

The following is a submission from the Wairarapa Whanau Trust to the South Wairarapa District Council (SWDC) regarding the 2019/20 Annual Consultation Document.

Wairarapa Whanau Trust is a registered, not for profit, charitable trust whose purpose is to coordinate social services in the Wairarapa Region, allowing a more coordinated approach to community engagement, development and care with specific focus on youth (12yr – 24yr).

The main goal of the Trust is to break down barriers to success for youth in the Wairarapa in a sustainable manner, and to build positive bridges with the community. This is achieved through providing youth with a safe place to belong, enabling them to experience a wider scope of opportunities through connecting with the wider community, engaging in community projects and volunteering at key events.

2. Executive Summary

This submission outlines how the work that the Trust is doing addresses the key priority area of SWDC of building the Best & Healthiest Community Partnerships, along with most of the five Community Outcomes listed in the SWDC Long Term Plan (LTP) 2015-2025:

- Healthy and economically secure people
- Educated and knowledgeable people
- Vibrant and strong communities
- Sustainable South Wairarapa
- A place that is accessible and easy to get around

The impact that the Trust has had in the area is well documented, especially in Featherston. With the placement of two youth workers in Kuranui college, we are now getting youth from Martinborough, Greytown and even Carterton coming to and engaging with our community youth group. Instead of trying to resource multiple youth programs, we collect and drop them to their home towns. We have multiple young people engaged in active learning around running groups, leadership development and mentoring. This is key for increasing capacity and the ability to grow in a sustainable way, in particular with the addition of an additional intermediate youth program.

Our young people take pride in being part of our town and have assisted in community events, done clean up working bees, helped at the Featherston Expo and the charity bike ride in Martinborough.

We currently have well over 80+ young people actively engaging with our youth groups in South Wairarapa. We have two youth workers operating in the local college that connected with the 460 students regularly. This has enabled us to connect to even more youth and identify the challenges they face both in and out of the college. Kuranui engagements: Term 1

Our Trust has a unique opportunity where our youth workers can connect with the young people in the four key areas of social engagement – school, social, whanau/home and community. This allows our workers to have a much greater connection with the young people and the environments they exist in, and by doing so, be able to encourage and influence more positive outcomes.

There has been significant change in the region, with many new first home buyers moving to the area. We became aware of a significant increase in the amount of intermediate age children there were moving to the area (Featherston in particular). In response to this, we introduced an additional intermediate program for them, as we noticed many starting to "wander" the streets – too old for "Friday Club" and too young for the senior group. Our

intermediate group now has over 40 young poeple on the roll, with four senior students assisting who are doing youth development training. We have been able to connect with, and assist when needed, a significant amount of homes over the summer period, by partnering with Food Bank, Waiwaste and other places to ensure many families did not struggle over the Christmas period.

In order for this to be successful we need continued financial support from SWDC. With the increased costs relating to the youth workers in the college and in the community, we would like to apply for \$40,000 in grants.

We also believe that further opportunities can be developed with council assistance to make the Boundary Rd site a leading youth hub in the Wellington Region.

3. Background

Our key focus is on the main barriers listed below:

- Lack of "starter jobs" which allow them to get work ready and earn money to get a drivers licence, car etc.
- · Isolation through lack of transport options/car or limited train availability.
- · Lack of access to internet or after school facilities.
- A safe space for young people to work on projects, develop ideas and connect with the wider community.

We are continuing to work with the community, youth and partners to deliver positive outcomes.

The Trust is providing a range of opportunities for young people as they are identified including:

- basic carpentry including pallet furniture making
- light engineering and motor mechanics
- digital and computing skills
- creative arts
- work ready skills
- leadership development
- mentoring

4. Feedback on the Annual Plan 2018/2019 Annual Plan

The Councils' vision is for the SW to be "an open and energetic, unified community" by having 'the best and healthiest community partnerships, best care and use of natural resources, best care and use of assets and infrastructure, best council staff and officers.

The outcomes we are seeking support the achievement of the above priority to build community partnerships for the South Wairarapa through providing a structured, co-ordinated and supported approach that focuses on developing pathways for our youth to become engaged in meaningful education, training and/or employment.

Our connections with community and whanau and collaborative approach with service providers and agencies, has had significant outcomes in achieving a healthier community.

Our activities also support the Community Outcomes set out in the SWDC LTP:

- Healthy and economically secure people
 - > Healthy and well housed people who are economically secure, active and involved in their community.
- Educated and knowledgeable people
 - > Educated and knowledgeable people who feel confident that they can achieve their aspirations.
- Vibrant and strong communities
 - > A place where people feel safe, are proud to live and have a sense of belonging.
- Sustainable South Wairarapa
 - A sustainably managed district where economic development and environmental management go hand in hand.
 - A place that is accessible and easy to get around
 - Well served by a range of transport options (including roading), local and regional services and telecommunications.

We have been able to give individuals basic automotive education and driving lessons, fundraise for individuals and group trips. Helped several young people find employment and trade apprenticeships.

The purchase and operation of the bus has had a huge impact on what we can do. Youth are able to connect and attend more events, get to camps and do trips that we would not have been able to do. The bus is available for schools to hire at a very low rate to enable schools to transport students to events – a key barrier identified by all the local schools. It is used regularly by several schools to get students to events.

We have developed key relationships with other organisations such as SW Rotary, Kuranui College, Fab Feathy CLDP, Lions, Waiwaste, Food Bank, Youth Services, local businesses, all of them share the same goal of a vibrant and positive community.

5. Conclusion

This submission outlines the challenges facing youth in our region and the work that Wairarapa Whanau Trust is doing to help address these challenges.

In light of this we request that the SWDC continue to support all the trust is doing with a grant of \$40,000 to go towards the costs of our youth workers in school and community, and the operational costs of Boundary Road.

The trust also will be raising additional funds through events such as regular car boots, hangi fundraisers, and selling items from the site such as pallet furniture, recycled items such as drums, and operating food stalls at events such as the Martinborough Fair.

The Wairarapa Whanau Trust has key funding partners which also contribute to the wider costs of employing the youth coordinator and youth workers in the area, the vehicle costs, office costs, cell phone, insurance etc.

Crime has dropped by about 20 per cent in Wairarapa in the past year, with community leaders saying the region has seen dramatic changes since the bad old days of a couple of decades ago-

Wairarapa may feature New Zealand's "most beautiful" city and town but it basn't always been a desirable place to raise a family.

Over the past few decades, the region has been known for its gang population and being centre stage in some of the country's most shocking murders.

But Wairarapa punches above its weight these days on multiple fronts, and the crime rate is steadily dropping.

Police say this could be down to a change in how they deal with first and second-time offenders, nipping a life of criminal activity in the bud. And a youth leader says it's about making young people feel valued and creating an engaged community.

Youth work in New Zealand is very unrecognised and uncoordinated, some areas like Christchurch and Auckland succeed because resources (funding) are prioritised into making sure youth work is working effectively and sustainably. Providers such as the Canterbury Youth Workers Collective and Canterbury Youth Services show us how a model in the Wairarapa can happen and provide a solid platform for youth work to happen and youth to be empowered, not just entertained.

Youth need significant others in their lives, the youth worker has built a team to engage with young people that will allow the need to be met. leasing the facility at Boundary Rd has provided the Trust with a turangawaewae (a place to stand), not just for the Trust, but for the community, its not just a place, its a place with purpose that will meet many community needs through a home work centre, creating jobs and meeting needs.

We believe in a strength based model of youth engagement and as such in a process described as the theory of change. We work with young people that are "hard to reach" begin a journey with them and take them to a place they can't get to on their own. We also work with young people who are not so disengaged and help them set goals and provide a positive model of youth engagement for them. Its not always about the hard to reach, but a balance for all young people, in The Theory of Change starts with a goal, all young people need goals, we work with them to reach that goal, the end goal is about them giving back to their community, no matter what the goal is, we want them to give back and be a productive member of the community, a role model for others.

We believe in empowering and encouraging young people through mentoring and leadership development to effect change within their group social settings.

Submission on SWDC LTP May 2019

The documentation given for the 2019/20 Annual Plan is of very poor quality as it does not give the information required to make an informed decision, some of the information is in contradiction to other information.

In the Annual plan supporting documentation 2019/2020 it states that "a rating review was also completed during the 2018/19 financial year". At last years Annual plan hearing Council state a review was to be done next year and that they would consult with me. Council have not lived up to their word.

The review was done in Council in private, this shows Council is not open and transparent in such an important issue. It was a whitewash.

It states in the supporting documents "under representation" "explain Council reasoning behind a particular decision or policy to those who might be interested" Council has not done this.

Council continues to over rate the rural area for the benefits they receive from Council services. The only reason is so as urban rates can be kept low.

On page 17 of the supporting documentation it shows the general rate for Featherston, Greytown, Martinborough and Commercial all went up by 0.6% whereas rural all went up by 17%. The rural general rate went up 28.33 times that of urban.

Page 18 it shows that the General rate Commercial, Urban in dollar of land changed an increase of 0.56% whereas rural changed an increase of 1.66%. Three times that of urban – commercial. This shows the unjust shift of the rate burden from urban to rural with no extra benefit. The objective is to keep urban rates low.

On page 5 - the populations in all three towns is predicted to grow at around 1% per annum for the next 25 years were as rural is only 0.3%. So over the next 25 years rural population will drop to about 25% and urban will rise to about 75%. So if Council continue allocating rates as they do now the day will come when (in the extreme event) one percent of the population rural will fund 75% of the general rate for the benefit of the 99% urban. This is unsustainable.

UAGC should be used to the full 30% allowed excluding water sewerage rubbish collection. As it was in the past. Most of the functions are for the benefit of the community (The people of the district) as the rural only have about 30% of the population they should only pay 30% of those functions. By using a UAGC it makes it fairer also and overcomes much of the problems with different land values between the 3 towns and rural (lifestyle and farmers). Councillors once elected are meant to represent all areas but again look after their voting base (urban) and fail the farming community (rural).

Library Expenditure

I oppose the extra expenditure on libraries as this function is funded by the general rate and as such the rural area will pay about 75%, well above the benefit they receive. Libraries should be funded by a UAGC as it accessable to all equally.

URBAN FOOTPATHS 1

I oppose the expenditure on footpaths, this is a non essential urban function and as it is funded by the general rate will see rural fund approx. 75%.

Urban footpaths street lighting cleaning/sweeping are all urban functions in the past were all funded by the urban area but funding was changed to all areas (e.g. urban and rural) so as to keep urban rates low.

Footpaths should be funded by urban as its an urban function. Last year Councillors showed their true colours by deferring some roading rehabilitation (must have) to funding footpaths (nice to have) to satisfy their urban voting base.

Pension flats

It is central governments responsibility not SWDC. Council should not be in this business. However, if Council is to keep the Pensioner flats then Council need to get real and charge a realistic rent. So as it covers all the costs of running and maintaining the flats and to create a reserve account for emergency expenditure. That may be needed in the future, the rent of \$100 per weeks is not a realistic rent to fund the above. Rents should be lifted to between \$150 and \$175 per week this is still a very low rent. At present any shortfall is funded by the general rate which sees the rural area pay a disproportion (75%) for the benefit they are likely to receive.

Worse, still it penalises those aged living in their own homes, many on the same income as those living in the Pensioner flats, they have to fund their own home and help fund any shortfall so as someone can live cheaper than them.

2. PROJECT OVERVIEW

Specific reason for grant application

To replace the Northern Turf cover at Clareville Hockey Complex.

The turf covers have a life of 12 to 14 years with a replacement cost of approximately \$280,000 each. We have programmed to replace one turf cover every 6 to 7 years so to spread the financial burden. The Northern Turf cover is scheduled to be replaced in 2020 at the end of the winter hockey season. This turf was commissioned at start of 2009 hockey season and will have had 12 years playing use at the end of the 2020 season.

Where and when will the activity/event take place or what is the anticipated completion date of the project (please note funds cannot be allocated retrospectively)?

The Northern Turf cover is scheduled to be replaced in 2020 at the end of the winter hockey season.

Why should South Wairarapa District Council (SWDC) support this project?

WSAST provides the only full size hockey playing surfaces for the whole of the Wairarapa Region. All 11-aside hockey is played at the Clareville hockey facilities including the junior six aside games on Saturdays. Without these surfaces, hockey would not be a viable sport in the Wairarapa.

Hockey here in the Wairarapa is a very strong sport and this in part is due to having good facilities which are well maintained.

The turfs not only carter for our Local and Premier competitions, but also Regional and International games for which the region can rightly be proud of.

Hockey Wairarapa catered for 1623 players using the turfs in 2018, which included a number of teams and players from South Wairarapa.

Sport is vital to a healthy community and the two turfs have an important role to play in this respect. In addition, the turfs bring about a positive economic impact to the Wairarapa Region by Hockey Wairarapa hosting regular tournaments, including two Black Stick International tests series in recent years.

WSAST is running a financial model to fund the replacement covers on the basis of; WSAST providing a 1/3, the Councils 1/3 and sourcing grants for the remaining 1/3. This has been an accepted model in the past by grant funders and Councils.

WSAST is happy to continue administering and help fund the turfs and ensure they are kept up to an acceptable standard, but we do require Council support when necessary. For this reason, WSAST ask that the SWDC help share the cost of replacing the turf covers and ensure funding is set aside in the Annual plan for a replacement turf cover in 2020.

Who will benefit from these funds and in what way?

The Wairarapa Region at large.

CHAIRPERSONS REPORT

Background to this report: The chairs of the SW Community Boards together with A. Rainsford (GCB), M. Shepherd (FCB) and Cr P Colenso (MCB) attended the LGNZ Community Board Conference in April 2019. Two major themes were community board/council engagement with Youth and Maori communities. We attended a number of workshops and plenary sessions on these issues and have some suggestions for council to consider which are in line with the SWDC LTP goals.

Engagement with Maori in South Wairarapa

The bi-annual LGNZ Community Board conference is very thoughtprovoking and gives attendees the opportunity to network with other community board members from across New Zealand. It gives you the ability to look at best practice throughout NZ and share ideas and projects that could be applied to South Wairarapa. Currently SWDC funds one community board member from all three community boards to attend the conference.

1. We would like to recommend to councillors that SWDC also fund one member from the MSC to attend the next LGNZ conference to be held in 2021

Shay Wright was a keynote speaker at the conference and also chaired several workshops. He was an outstanding and inspirational speaker and workshop facilitator.

Shay Wright is a Maori social entrepreneur named in the Forbes Asia list of '30 Under 30 Social Entrepreneurs' for his work as co-founder of two social enterprises - Te Whare Hukahuka and Nuku Ltd. Both enterprises help indigenous communities set up and grow world-class social enterprises to create community change. TWH has worked with almost 1,000 indigenous Maori leaders to develop their skills, including 130 young Maori leaders through their award-winning youth leadership programme, Ka Eke Poutama. The programme alumni now hold more than 120 governance roles between them across the community sector and have set up several social enterprises.

Shay also helped establish the teacher recruitment organisation, Teach First NZ; is a member of several Government Advisory Boards, and is a speaker, strategist and futurist, having appeared on the NZ television show 'What Next?' in 2017. He is a product of the rural Far North and his whakapapa connections are to Te Rarawa, Ngapuhi, Ngaruahine and Ngati Ruanui. Shay's particular interests and areas of thought leadership are around the connection between entrepreneurship and community, strategies to grow youth leadership in our communities and how indigenous concepts can help to reshape our relationships. https://www.shaywright.co.nz/

2. We would like to recommend a 1 day workshop facilitated by Shay Wright for Community Boards, Councillors, Maori Standing Committee and senior SWDC staff. This would be an opportunity to shape the way we engage with Maori and arm us with forward thinking inspirational strategies and ideas for the betterment of our Maori communities.

Engagement with Youth in South Wairarapa

A common theme amongst all community boards was a lack of engagement with youth. Some councils/community boards had almost no input from youth while a small minority had a robust and vibrant relationship. South Wairarapa do better than most CB's with two out of three community boards having a youth representative however this is really just the first step in the right direction and significantly more work needs to be done.

Another keynote speaker was Sarah Colcord speaking on the important role of youth voice groups locally and nationally.

Sarah has a strong desire to connect, support and empower the young people of Aotearoa and ensure they are part of the decision-making process. In 2016 she won her Local Body Election and was elected on to the Manurewa Local Board at 20 years old. She is the youngest member of Manurewa Local Board and one of the youngest politicians in Tamaki Makaurau. She leads the Arts, Community and Events Role on the Board and is a member and representative on numerous professional working groups.

Sarah is the co-founder of the Auckland Youth Voice - a network that supports the development of Youth Voice groups/councils in Auckland. Sarah also voluntarily supports the Manurewa Youth Council within her capacity as a Youth Worker.

While there is a Wairarapa Youth Council there appears to be little engagement with South Wairarapa Youth. Its Facebook page have very small numbers (there are no twitter or Instagram accounts) and it's website makes engagement difficult. Many young people would find it difficult to 2 travel to Masterton for meeting esp those from rural areas and those without cars.

We believe there is an opportunity to better engage with youth and propose an initial small meeting with our CB youth representatives, students from Kuranui, Solway, Rathkeale Colleges, Young farmers, Trade apprentices, and year 7/8 from Greytown Primary. This would be held at the side room at Circus Theatre with pizzas to encourage a relaxed and non-threatening environment. We would hope to have a group of up to 15 people to discuss ways to set up a SW Youth voice.

- *3.* We would like council to consider funding this. We anticipate the costs to be no more than \$1,000
- 4. After this initial first meeting we would like to plan stage 2 and have Sara Colcord come to South Wairarapa to have a workshop on how to set up a SW Youth Voice based on her successful models in Auckland. We would like councillors to consider this and approve in principle the idea and consider funding this project (subject to final costs).

Both these projects are long term initiatives covering more than one election cycle.

Community Grant Application to the South Wairarapa District Council

Dear Mayor Viv and Councillors,

We are in the very early stages of planning for next year's event, to be held over Easter weekend, from 9th to 13th of April 2020. The Festival started in 1999 and has proved to be an enduring and iconic part of the Wairarapa events calendar.

2020 will be the fourth year we have run the festival over Easter and it has proven to be a good move. Traditionally Easter weekend was quiet in the Wairarapa and we saw a great opportunity for attracting visitors and entertaining locals. The weather is more likely to be settled over Easter (due to the full moon) and visitors to the region can plan ahead to attend morning and day time events right through until the Easter Monday.

We are seeking community funding support from the South Wairarapa District Council along with the other Wairarapa Councils and Trust House. We have a minimum of three events planned for South Wairarapa in the 2020 programme. Martinborough is always spectacular to fly over and the launch from Greytown's Memorial Park has been drawing large numbers, particularly enthusiastic families. Partnering with Martinborough wineries is proving to be a complimentary boost to the profile of the event and the wine village.

Hot air balloons and the Wairarapa are a natural partnership – we have a wide-open valley, unrestricted air space and very hospitable landowners where balloons can land. The Wairarapa event attracts balloonists from all over New Zealand due to our reputation for being the "friendly festival". We will again be having at least one 'special shape' balloon from overseas which provides a focus for the marketing and promotion of the event, and we are actively building relationships with other international balloon festivals to help promote tourism for the Wairarapa.

The 2019 Night Glow was well attended, with nearly 12,000 people enjoying the spectacle. Unfortunately, the balloons were unable to inflate (although our special shape 'Busby the Queens Guard' made a stellar effort), due to wind gusts which made it too dangerous for our pilots and balloons. Despite the balloons not inflating our pilots put on a good burner display to the choreographed music and light show, the food vendor choices were good and the popular band The Shenanigans kept the crowds entertained.

The gate revenue this year again exceeded our expectations, but costs were also up. Good numbers came from outside of our region, strategic advertising via NZ Chinese media proved extremely worthwhile. We have used social media to identify key localities where visitors come from and target our marketing to families in those areas.

Whilst there is a good level of support amongst the Wairarapa business community for the event, as evidenced by \$18,500 raised in business sponsorship for this year, we still need the support of the Council's and Trusts to ensure this iconic event remains financially viable and accessible to the public. The risk of losing our main income source (the Night Glow) means we try to hold a buffer of funding.

We work closely with the Civil Aviation Authority to ensure the event is safe for all aspects of the flying. Health and Safety for the public is also a key component in our planning. We have seen real benefits from the employment of a dedicated event management resource and will continue with this in 2020. We also recognise the ability of social media to boost the profile of the event and the region. We will continue to work with Destination Wairarapa to assist with promotion of the 2020 event.

We have a proven track record of managing the event's budget within the funding available. We ran the 2018 event at close to breakeven, despite budgeting a deficit. We are still wrapping up the 2019 event (but the indications are that we will again manage to at least breakeven), and do not have finalized accounts at time of submitting this application. We have produced an initial draft budget for 2020 which is included with this application.

We are committed to the Balloon Festival remaining an iconic and key feature of the Wairarapa and greater Wellington region's event calendar and we ask that Council support us with a grant of \$5,000.

Our junior football club is fun focused and inclusive and we've got a growing number of players, with over 70 junior players registered for the coming season (up 27% from last season).

During the winter season we use the pitches for training and matches, in the offseason we run a free summer football programme for players aged 5-13. Over the past summer we had over 30 children registered for a series of 10 coaching sessions and participants came from across the South Wairarapa region (including players from other clubs).

Current and future players aged between 10 and 13 years will benefit from the new posts as will all visiting teams players throughout the season (roughly 200 players per season).

In addition, new posts will mean the pitch will be used for senior training also. We currently have 22 players registered for our senior ream.

The club

We believe our focus on installing equipment is of a high standard helps the club become attractive to more players and equally importantly volunteers (we're already seeing growing numbers of both from the investments we've already made).

New (modern) posts will also help minimise the injury risk to players (the current posts really are unforgiving iron bars).

Martinborough FC Meeting Minutes

February 5, 2019

I. Call to order

Paul Brandon called to order the Committee Meeting of Martinborough FC at 7PM on February 5, 2019 at Burger Craft, Martinborough.

II. Roll call

Paul Brandon conducted a roll call. The following persons were present: Paul Brandon, Ian Barrs, Paul Ivory, Tim Roach and Cam Hayton (Sport Wellington Wairarapa). Apologies received from Rachel Griffiths and Blair and Sam (Capital Football).

III. Open issues

a) There were no open issues.

IV. New business

- b) New Sponsors –Paul Brandon has been successful in negotiating with both Margrain Villas and The Claremont Motel to secure sponsorship from both parties (their logos will go on the sleeves of the Senior Team shirts). Due to teams outside the Wairarapa wishing to come and play against Martinborough FC as well as the success of the 7-a-side tournament last September, it was thought that to have 2 recommended places to stay for visiting teams and their families would be a great idea – hence the approach to these 2 venues. They will both be prmoted as the Martinborough FC places of choice to stay and will offer reduced rates to players/teams who come to stay in Martinborough.
- c) Club finances currently have \$328 with a further \$1500 to come from WBS as their sponsorship for the Senior team along with a further \$768.75 from Capital Football (line marking rebate).

Line Marker rental to Featherston FC to remain at \$150 for the season and subs for Senior team to be set at \$140 with the Juniors set at \$70 (no changes from previous years and still makes us one of the more competitively priced teams in the area).

Still required to pay Martinborough Rugby Club \$500 for the use of their facilities (showers/changing rooms/lights) from last year and Paul Brandon to negotiate rates for this year as felt that \$500 was quite high for what we were using – \$200 more of reasonable figure.

Senior team to enter the Waikanae Memorial Tournament again this year at a cost of \$50 for the team. Last year very successful in promoting Martinborough FC and teams from the Kapiti area keen to come over and play friendlies against us both pre and post season.

- d) New goals for older Junior grades after getting 4 goals replaced last year, Paul Brandon to follow up with Capital Football about getting the old remaining metal goals replaced (as believes Capital Football agreed to replace them this year). They are a health and safety issue as basically pieces of scaffolding welded together so to replace these is a priority.
- e) Friendly matches for Senior team Kapiti Coast Utd are keen to come and play on 9th March as well as interest from Tawa, Waikanae and Porirua clubs too.
- f) Junior teams As Junior season commences on 4th May, Ian Barrs suggested that we commence the Summer Training programme from mid March for about 6 weeks on a Sunday morning and then change this to a pre-season training programme on a Saturday nearer the start of the season.

Due to the success of these programmes in the previous years it was agreed that these would continue with Ian taking the older group of children and the club looking for parent(s) help with the younger kids.

Coaching Courses for the Junior coaches this year will be promoted with the Club looking to finance any courses that will charge a fee. This way it was felt that we could attract and retain parents who are keen to assist with the coaching of the kids.

Retreating Line – this will be new for 2019 for grades 9 and up. Paul Brandon to send out the instructional video/email from Capital Football to all committee members and coaches so they are aware of how the new ruling will work.

End of season trophies – cost is about \$2000 to have everything done. Mixed response as Ian Barrs felt that it was costly to give each child a memento of the season with Paul Brandon advising that he felt that for kids to actually receive a small trophy in recognition of the efforts was a small price and would last a lot longer than a paper certificate. This will be discussed again during the year to make a final decision before season finishes.

- g) Incorporated Society a couple of Trusts have requested that we become Incorporated in order that they can allocate funds to us. Paul Brandon to look further into this.
- h) General Business not covered above quick discussion about whether to prmote the qualifications Martinborough FC now had amongst its players with Tim Roach having gained significant qualifications through Capital Football up to Level 2 Senior coaching and Paul Brandon recently acquiring Level 2 Youth coaching as well as a referees introductory course pass.

Paul Brandon also asked those present if any were interested to fill the Secretary and Treasurer positions. All declined and advised Paul Brandon that he was doing a good job so could carry on doing all 3 duties.

Roger Fraser Urban ratepayer

In considering the Annual Plan consultation document I have a general concern that South Wairarapa District Council (SWDC) recommends increasing rates to cover new initiatives, but at same time does not look to make savings elsewhere to offset those initiatives. It is a reality for most individuals and households that it is simply not realistic to keep adding expenditure to their budgets without making savings to compensate. In future public consultation, it would be important to understand what SWDC could stop doing (and at what saving), in addition to being presented with requests for new spending.

I am also mindful of the significant overhead and expense increases, particularly in staffing, that continues to occur at the operational level of the SWDC. These cost increases are then passed to ratepayers, via rate increases that continue to be well ahead of the rate of inflation. One simple example: staffing in the annual report for the year ended June 2018 was 66. At the same time in 2016 it was 55 persons. A dramatic rate of increase, and a trend that no one has no confidence will come under control any time soon, particularly when the appointment of a communications officer, a proposed minutes secretary and other headcount related changes were discussed in the recent presentation to ratepayers.

Against this background, I make the following comments on the recommendations for increased rates to cover four new initiatives.

Discussion topic 1: Reduction in library charges – strongly oppose; maintain status quo There is no convincing argument that ratepayers should pay additional rates to reduce library charges. Library charges are already modest, and removing price signals to borrowers that they need to pay a small amount to borrow an expensive book, or need to pay a fee for late returns, simply erodes borrower responsibilities to honour the terms on which they were lent the book in the first place

Discussion topic 2: Extended pool opening hours - limited support

This is a worthwhile initiative to consider, but there are reservations that the extension of weekday hours is long enough to permit commuters to be back in time to participate to any great extent. Similarly extending weekend hours into what for many people is a meal time, or socialising period may have a less than desired outcome. There is therefore a reasonable doubt that the numbers will justify the additional spend.

Discussion topic 3: Change in funding of housing for seniors – strongly opposed; divest or recover from tenants

Requesting ratepayers, many of whom are on fixed incomes (which are increasing at nowhere near the level of rate increases), to subsidise social housing is inappropriate. As well as being on fixed incomes, many ratepayers worked hard all their lives to save for, and purchase, their family homes. That they are being asked to subsidise individuals who failed, or were unfortunate enough, to do that, demonstrates a lack of understanding on this matter. The solution is simple; either make tenants responsible for paying a rental that covers all costs, or SWDC should divest these rental properties. The latter point is most important – currently ratepayers contribute to social housing both via rates and income taxes. Central government is the entity responsible for provision of social housing, and if a tenant cannot afford rentals, it provides protection via the accommodation

supplement. Taking all this into account, there is no justification for SWDC to provide subsidised rental housing.

Two other important points to consider are that we are told that SWDC rents are the lowest in the country (why?) and second, that no mention has been made in the debate so far about the responsibility of families to contribute to their vulnerable relation's wellbeing. It is deeply concerning that ratepayers are being asked to plug the gaps welfare policy or families are unwilling or unable to.

Discussion topic 4: Extra footpath maintenance – strongly oppose Proposing such a large sum of money (with a huge attendant rates increase) for such modest improvements reinforces our concern that this is a council unable to prioritise spending; or, make the hard decisions. Put simply, this council cannot maintain required roading services now (witness the many speakers at the public meetings). It simply does not make sense to be proposing upgrading footpaths while our rural roads are reported to be unsafe by regular users.

Lastly, there is one residual concern that needs to be tabled. That is, that the proposals put to the public meetings were not adequately supported by robust financial justifications.

A prime example is the intended increase in dog registration fees and rubbish bags. These were presented as a fait accompli, and justified on the basis that "they had not been increased for several years". This is not acceptable - a more convincing justification would have documented actual costs, vs recovery, and given ratepayers an informed basis on which to view the increases.
