The present conditions on licence number **44/ON/222/2012** shall continue to apply.

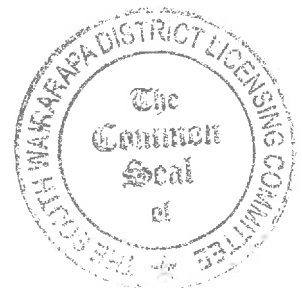
The following further condition has been imposed by the District Licensing Committee:

DECISION ON THE PAPERS

This is an application by Citterio Leases Limited for a Temporary Authority in respect of premises situated at The Square, Martinborough known as "The Martinborough Hotel", due to a change in licensee. This is the first application for a Temporary Authority.

Police and the Inspector have no opposition to this application. Accordingly we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard, as set out in s.3, s.4 and s.136 of the Act. We grant the Temporary Authority for a period of three months from the issue date.

The Licensee must comply with the conditions set out on the base licence for the premises, in addition to the following modified/ new conditions.

1. No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day to any person who is not;
 - I. Present on the premises to dine
2. Drinking water is to be freely available to customers while the premises are open for business.
3. Food must be available for consumption on the premises as follows: **At all times when the premises are authorised to be open for the sale of alcohol, a range of**

food choices must be readily available. Menus must be visible and food should be actively promoted.

4. The licensee must provide information regarding alternative forms of transport from the premises.
5. The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the responsible consumption of alcohol. The host responsibility policy must be displayed in view of the public.

CONCLUSION

Having regard to the relevant provisions of the Sale and Supply of Alcohol Act 2012, the Committee is satisfied that a Temporary Authority should be granted.
