DECISION ON THE PAPERS

This is an application by Murdoch James Estate Wines Limited for a Temporary Authority in respect of premises situated at 284 Dry River Road, Martinborough known as "Bloom Restaurant"

This is the first Temporary Authority for this applicant. The application was sent to the Police and Inspector and no reports of opposition were received. Accordingly, we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard, as set out in s.3, s.4 and s.136 of the Act. We grant the Temporary Authority for a period of three months from the issue date, and authorise the issue of an authority with the following conditions;

1. The authority is subject to the conditions of the replacement base licence; particularly noting condition **(b) On such days and during such hours as the premises are being operated as a bar but not other than on the following days and hours:
Monday to Sunday 7am to 1:00am the following day**
2. Drinking water is to be freely available to customers at all times when alcohol is available.
3. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
