




Map of listed trees- Greytown





Map of listed trees- Greytown

Subject: Carpark adjacent to Chemist and Bakery, Featherston

Hi Brenda

I am very concerned that this carpark is too small to safely accommodate all the vehicles that wish to use it for weekday shopping and Saturday market days.

I have often noticed the following situations:

- The entrance way is quite narrow, and frequently, a car wishing to enter has to wait for a car to exit. The entering car is often seen sitting with its rear extending into the road, which causes congestion and reduced field of view for the exiting car.

The carpark doubles as pedestrian access to the market venue every Saturday morning. In my opinion, the area of the carpark is too small to accommodate the mix of vehicles and pedestrians. There are numerous family groups, often with buggies and toddlers and elderly, all passing very closely to vehicles manoeuvering into and out of parking spaces.

As far as I can tell, a few business owners use the carpark for their own cars, which reduces the available spaces for the public; similarly, there are two stallholders each taking a regular place in the carpark on market days, which appears to reduce the visibility, reduce the vehicle space, and cause clusters of pedestrians to be positioned very close to moving vehicles.

I have found that it is not easy to see whether the carpark has vacant places when you are approaching it from Fitzherbert St, which can often result in cars having to back out when they don't find a spot; the whole area can often look like a busy, congested mess.

Another dangerous aspect of the carpark is when a vehicle is exiting and turning right into Fitzherbert St. The cars parked on the street are too close to the entrance, and there is no clear view of approaching north-bound traffic.

A further hazard, as I see it, is that the entrance is too close to the railway crossing on Fitzherbert St. When the north-bound traffic stops for the train, the entrance to the carpark is totally blocked, vision to Fitzherbert Street is almost nil and the whole lot takes ages to clear.

Lastly, there are no painted parking places, signs or direction arrows, and the whole thing is just a free-for-all.

The Saturday market has gained a firm foothold in the town, and has encouraged increased foot- and vehicular traffic. I believe that the safety aspect of the carpark needs to be urgently addressed.

I'd be happy to talk with you about this, or attend a meeting if necessary.

Great to see you today, and to hear that your new job is going really well.

I am writing on behalf of Featherston Camp Memorial Trust (the Trust) to thank the Featherston Community Board for its support for the proposed Featherston Camp Sculpture.

Your support, along with the support of grant funding bodies and our own fundraising efforts, has enabled us to commission the sculpture, enabling the project to come to fruition. We plan to unveil the sculpture during Armistice Day commemorations in November 2018.
