### ANNUAL PLAN 2014/2015 SUBMISSION

The Museum has now been fully functioning under its new status as a Charitable Trust for eighteen months and in that time much has been achieved. A lot of this has been able to be done by virtue of the Council's special grant of \$3000 through the Community Board for the computerised recording of the collection and also from the Council's annual grant for general purposes of \$750. Both have been well received and appreciated.

Arising from the work we have been able to do, the greater level of activity has resulted in an increase in our running costs, as distinct from special projects. While visitors' donations fluctuate and only produce about \$6/700, more visitors than in the past carry no cash and a downward trend in cash is noticeable.


A large future ongoing cost we are faced with is the major upgrade in the security system, just completed, which while in place for the protection of the collection, does have some benefit for the Council as owner of the building. This should approximate \$800. We are also working with potential insurers to cover the collection (and here we acknowledge some advice given to us by Council officers) and while not finalised, an ongoing premium cost is expected to exceed \$2000.

Further work to increase our revenue sources is a priority for the Trustees and so we are looking at this closely. We have already used some of our reserve capital for expenditure purposes but understandably are reluctant to use capital for revenue purposes. In virtually all that we are currently doing, professional advice is being sought where deemed necessary and appropriate.

In the light of the foregoing situation as set out above, we are now seeking a general grant from the Council in the 2014/2015 Annual Plan.

Another matter on which we wish to submit to the Council for the Annual Plan, is the matter of maintenance of the building and its surrounds which is the responsibility of the Council. May we suggest that it would be constructive for the Council and us to jointly carry out an inspection of the building at an early opportunity to identify any issues which we jointly may consider need attention.

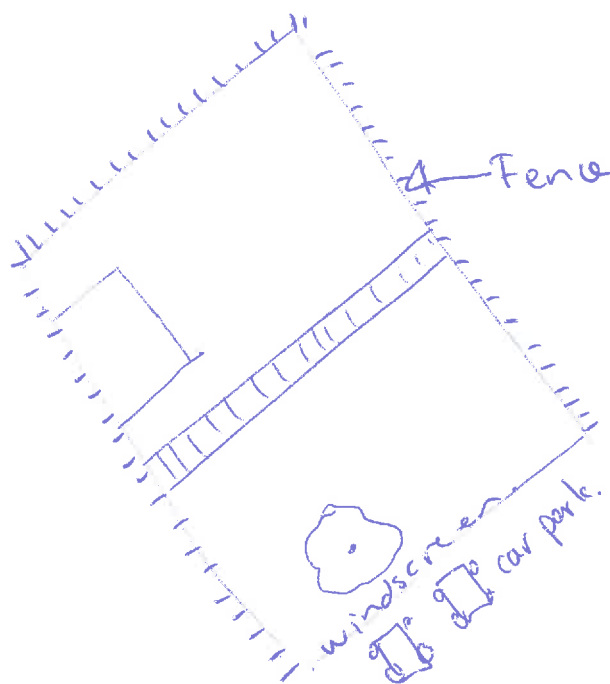

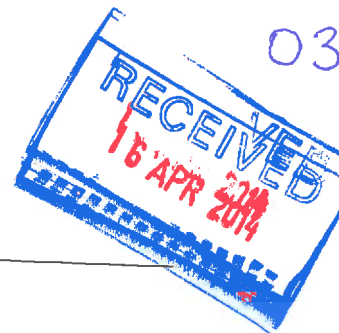

## Submission to draft annual plan 2014-2015

2014 being an election year, the Democrats for Social Credit Party wishes to remind councillors of their duty to both challenge and influence central government policy.

We respectfully ask you to support and lobby for the following proposals:

1. Local body access to nil-interest credit-lines and loans from our sovereign bank, the Reserve Bank of New Zealand. These for essential capital works, thus relieving ratepayers of unsustainable debt-servicing to the private financial sector. The RBNZ is already equipped to provide such facilities as proven by the multi-billion dollar arrangement made in recent years for the major banks.
2. Remove the GST from rates.
3. Support the "Robin Hood" Tax campaign now gathering momentum globally. The levying of a minuscule tax on money and share market transactions would allow Government to provide funding for more public amenities without further need to raise rates, taxes and charges.
4. Support the campaign demanding complete transparency as to the TPPA (Trans Pacific Partnership Agreement) negotiations.

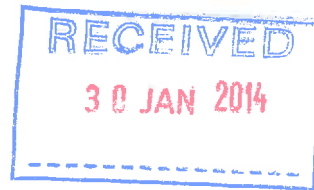

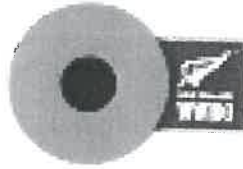

## FEATHERSTON CAMP MEMORIAL GROUP PROPOSAL

**Subject:** Seeking the South Wairarapa District Council's agreement in principle to a proposal to install a structure in central Featherston to mark the historical value of the Featherston Military Training Camp.

### Proposal

We propose that as part of the upcoming international commemorations of the First World War a significant work be commissioned by the South Wairarapa District Council (the Council) to recognise both the local and national significance to New Zealand of the Featherston Military Training Camp. We are seeking the Council's agreement in principle to construct a tribute to the camp, and the people who passed through it, in the central part of the town. We ask that the Council gives consideration to locating the dedicatory structure in the proposed town square.

We also ask that the Council hears us in person about this proposal within its Annual Plan process. Such a project can only be undertaken with collaboration between the community and the Council. If the Council agrees to our proposal we propose to work alongside it in promoting the tribute and sourcing the funding needed. We are committed to a collaborative working relationship with the Council to see this project through to the installation stage.

### *Our vision*

We believe this project would reacquaint Featherston with its First World War history and further emphasise its association with Messines in Belgium. A substantial tribute would, we believe, enhance the town's public image and be held in high esteem. This project can only be developed if the Council makes land available for this purpose.

### *Why is this tribute needed?*

To date the only physical memorial to commemorate this historically significant camp and the thousands of people who trained and worked there are two small plaques (one of which has been conspicuously amended to correct inaccurate information) in the Garden of Remembrance off State Highway 2. There is little remaining now in the area to show that this camp existed and the huge impact it had on the inhabitants of Featherston: and yet its historical importance is of national and

international significance and ought, therefore, to be memorialised in some way during these 100 year commemorations of World War 1.

### ***Who are we?***

We are a newly formed group of Featherston residents who are conscious of the important upcoming 100 year commemoration of the First World War and the special place we believe the Featherston Military Training Camp has in the history of New Zealand.

### ***Benefits to the Featherston and South Wairarapa communities***

If strategically placed the proposed structure could also boost the town's (and the region's) economy by encouraging people passing through to stop, thereby having the flow-on effect of more "tourist dollars" being spent in nearby shops and cafes. If promoted as a nationally and internationally significant historical memorial it may well attract visitors into the South Wairarapa district from all over New Zealand and from overseas.

### ***Our supporters***

We have the support of the Wairarapa WW100 Steering Group and Toi Wairarapa, along with local societies and others with an interest in the historical significance of the camp. Letters of support for the project are attached. These indicate the high level of common interest and support for the proposed project.

## **Background**

August this year will see the beginning of the centenary of the First World War, a war that lasted more than four years and claimed the lives of over 16 million people. It was a turning point in world history.


New Zealand contributed to the British and allied war effort during this conflict in many ways, with its troops serving in all major campaigns on the Gallipoli peninsular, in Palestine and at the Western Front. Featherston was the base for the largest military training camp in New Zealand, constructed from 1914–1916, from where, after completing their training, soldiers had a three day march over the Rimutaka Hill to Wellington for embarkation to these foreign parts. Over 60,000 men and some 2,000 horses trained and left for overseas from this historically significant camp from the time of its completion in January 1916 until the end of the war in November 1918. Along with satellite camps at Tauherenikau and Papawai, the camp could accommodate 9850 men in huts and tents. Its campsites and training grounds covered 1861 acres (753 ha) of land in the Featherston–Greytown area. A short railway siding was constructed through adjacent farms to allow troops, equipment and goods to be delivered to the camp.

## **Conclusion and Next Steps**

With Council's agreement in principle in place, at a later date we will present a project and funding plan. First tasks are to undertake a feasibility study to ascertain costs of the project and to identify funding sources. Stage two would involve considering ideas for a structure that would be most suited to be placed in the town. We propose that the relevant stages of the project be open for public consultation and submissions.

We believe that it is important to recognise and mark the historical significance of the Featherston Military Training Camp as it was in WW1. Installing a structure as proposed above will benefit Featherston and the wider community. It would provide a unique attraction in the centre of the town that will attract visitors, including relatives and descendants of the soldiers who trained at the camp, and contribute to improving the appearance of Featherston's town centre.



The Featherston Heritage Museum often hosts visitors from Belgium who show immense interest in where the soldiers that liberated their country from German occupation were trained.

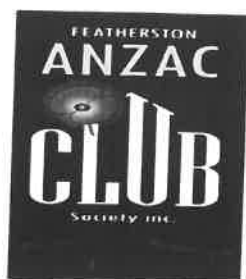
In fact, it was only last Thursday 13<sup>th</sup> February, that we hosted our most recent Belgium visitors.

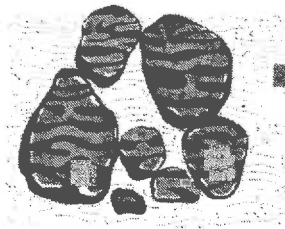
I am happy to write in support of the Featherston Camp Memorial Group's project to erect a memorial to the Featherston Military Training Camp from World War One.

Good afternoon Adrienne & Paul

David Watt and I are hoping that you may both be able to attend the film show at Longwood Homestead this coming Saturday at 2pm.  
 We are sold out but could find a seat for each of you if you can make it.

I want to update you also on a research project which we are just getting underway to improve the accuracy and completeness of the national register.  
 I am happy to follow up this e-mail with a phone call and a meeting if helpful- it is some time since we had the opportunity to discuss historic and cultural heritage together.

We are finding a lot of interest in other parts of our region in seismic upgrades of heritage buildings and insurance issues.  
 One of the most common requests is hands-on seminars for owners and architects, engineers, real estate agents on the gnarly challenges of affordable retro-fits.  
 You will also be receiving a letter shortly about our name change to Heritage New Zealand Pouhere Taonga.

### Research project

In 2004 an audit found that 22 of the places thought to have been registered in the South Wairarapa District had not been completed with a proper minute from a NZHPT Board meeting-(in the 1980s).

To remedy this NZHPT has been working geographically through clusters of these deficient registrations with an emphasis on getting South Wairarapa District Council places completed as soon as possible. Key drivers for the work in this are the increased attention to seismic upgrades and pressure for redevelopment following the recession which may include demolition and new build unless we have robust information on the worthiness of these places.

Other Councils have contributed to our research work- often through their professional fees budgets. The amounts have ranged up to \$10,000.  
 South Wairarapa's bundle of 22 places is one of the bigger in our region and our budget to complete this work is \$20,000. A contribution from Council for even \$4,000 would go a way to assist with completing this work as soon as possible.

The benefits to Council of this research include:

- there will be a succinct history and story of each place
- a summary of the place's important physical heritage attributes, noting significant changes and additions
- an assessment of heritage significance equivalent to the standard required for heritage inventory reports for most territorial authorities across NZ
- significance statements and comparative analysis which illustrates the place's heritage importance locally and nationally against NZHPT's registration criteria under the Historic Places Act (1993)- many of these places were considered for registration in the 1980s



- updated and accurate land title and location information that can be added to Council planning information including GIS overlays
- supporting visual information such as original plans and photographs where available
- a copy of the research report for Council files including the bibliography- this material could be suitable for a future short publication to add to the wealth of material about significant Napier heritage.

We are keen to work with Council on this study and on other heritage matters e.g seismicity and affordability of the retro-fit work to building stock.

I can provide any further information as needed, for example samples of the inventory styled reports from other places.

In 2012, several councils agreed to contribute to this fund and I still believe it is a useful approach. At least one new Council is considering joining the scheme.

We are all at different stages of deciding our Annual Plans. However, the fund's growth has not been as fast as originally intended. While Wellington remains supportive, further increases without all Councils also increasing, would make our percentage contribution much higher per capita as a proportion of the total fund. Given we already contribute to many regional amenities, as do some other Councils, through other budget lines, I'm proposing that our contribution to the fund remains at 2013/14 levels for this year ahead.

After this AP round, we'll get into the LTP and I'd like all 8 territorial Councils to commit to an agreed level so we can be strategic over some long-term funding for key organisations.

My understanding, from our staff and some conversations with Mayors is summarised on the attached table.

The supplement circulated to households with Midweek (22 April 2014) mentions a proposal for a cycle trail from Cross Creek to Featherston. However, I find no mention of this in the Plan itself.

I am opposed to this cycle trail, and suggest that the money (\$205,000) would be better spent on the Martinborough Town Hall, water supply and sewerage upgrades, libraries etc.

We have a perfectly good road, with little traffic, between Cross Creek and Featherston. The current fad for building cycle trails reinforces the notion that roads are for motor traffic and unsafe for cyclists. SWDC should be encouraging both local people and visitors to ride bikes on our roads instead of driving. The fewer cars we have on the roads, the safer they will become.

This is gravelled from just past the Escarpment Vineyard to White Rock Rd. Traffic has steadily increased over the last few years resulting in the constant formation of pot holes and dust. The pot holes are regularly filled in by grading however this is an on-going hazard to everyone using the road and may result in a serious accident in the future. The dust during summer is very uncomfortable for those people living close to the road and becomes a real nuisance. In particular I feel great sympathy for Katherine Jacobs and Jeremy Corban and the Campbell family. I have been the manager on the Te Muna Vineyard since 2011 and have noticed a steady increase in traffic. I would expect this will continue to increase which will place further pressure on the integrity of the road and jeopardise the safety and overall quality of life for everyone using and living near Te Muna Rd.

I urge the council to consider extending the length of tar seal as soon as possible to reduce the risks associated with using and living on or near the road and invite you to come out and see the state of the road for yourselves. (4wd recommended)

I would be happy to discuss this matter with you further.

Wairarapa SPCA Submissions re Feral and Stray Cat Control within the Wairarapa district.

The Wairarapa SPCA has been operating since 1940s based in Masterton. The organisation is financed via donations and primarily staffed with volunteers.

The primary purpose of our organisation is preventing Cruelty to Animals, we respond to many complaints pertaining to alleged cruelty, and where verified we take the appropriate steps, we respond to call outs pertaining to sick and injured animals, and we obtain the appropriate treatment for those animals. Our resources to respond to our primary purpose are limited.

And they continue to be further stretched by requests to capture or remove unwanted, stray and feral cats from members of the public's property, many of these animals are not sick or injured, merely a public nuisance, which we field multiple calls daily requesting our assistance. Our role is not pest management.

Having said that, we often respond to hopefully prevent a cruelty situation arising, (i.e. an irritated member of the public taking uneducated steps to remove the nuisance, and injuring the cat)

The costs associated with legally removing the cat (Trapping) (as per *The Animal welfare Companion Cats Code of Welfare 2007*) are very high, they involve the setting and checking and clearing the trap, require trained personnel to clear the trap, if the cat is a \*stray cat It needs to be kept for 7 Days while the requirements of sec 141 of The Animal welfare act 1999, are met. The cost to keep for 7 days, advertise, and if unclaimed euthanasia and dispose of conservatively \$100 per cat. (I say euthanasia as unfortunately our centre has a limited ability to house and re home all cats and kittens)(*In an ideal world we would find a home for all of them, but it isn't an ideal world*)

\* Feral cats trapped do not require to be held 7 days, they can be humanely euthanized, but it is not always easy to define a feral cat, so care must taken to ensure that no ones pet is labelled as feral, experienced staff and veterinarians are able to assist classifying the cat.

**There are cats and there are cats**

For the purposes of the Code, the cat population is divided into three biologically distinct categories:

- **Companion cat** - a domestic cat or kitten that lives with humans and is dependent on humans for its welfare.
- **Stray cat** - a companion cat that is lost or abandoned.
- **Feral cat** - a cat that is not a stray and is not dependent on humans for its needs.

### **Interpretation and Definitions”, of this code, The Animal Welfare (Companion Cats) Code of Welfare 2007**

**Colony** A group of stray cats living together.

**Companion cat Common domestic cat** (including a kitten unless otherwise stated) that

Lives with humans as a companion and is dependent on humans for its welfare. For the purposes of this code, kitten will be referred to as “cat”.

**Feral cat** For the purposes of this code means a cat which is not a stray cat and which has none of its needs provided by humans. Feral cats generally do not live around centres of human habitation. Feral cat population size fluctuates largely independently of humans, is self-sustaining and is not dependent on input from the companion cat population.

#### **Stray cat**

For the purposes of this code, means a companion cat which is lost or abandoned and which is living as an individual or in a group (colony).

Stray cats have many of their needs indirectly supplied by humans, and live around centres of human habitation. Stray cats are likely to inter breed with the unneutered companion cat population.

From the Stats available it is apparent that there has been a significant increase in cats being brought to the centre by members of the public, the majority are Stray and feral cats, records at National database show 539 cats went through the centre in 2009, of which 25 were returned to the owner. 2010 , 686 cats brought in 32 returned to owner, 2011, 977 cats through the centre, 20 returned to owner, 2012 , 1096 cats through the centre , 19 returned to owner. 2013 stats are not available at time of this submission. The continued demand for cat control has had significant impact upon our resources, SPCA’s core function is not pest management, but by default our services and resources are being called upon, to the detriment of our core function (Preventing Animal Cruelty)

As such we (The Wairarapa SPCA) would like to propose 3 options for serious consideration

**Option 1:** The 3 Wairarapa district Councils take sole responsibility for the control of Feral / Stray Cats, adding it to its other public good requirements pertaining to public nuisances within the district another arm to its existing Animal control Department and pound. The SPCA could then refer all Stray /Feral cat concerns onto the relevant Council.

**Option 2:** The local authority's out source cat control to a private approved organisation. Similar to the Gisborne District Council.

**Option 3:**

(a) The SPCA has a limited capacity to hold Feral/ Stray Cats but Sets up an area for 8 purpose built Cages, costs associated to the adaptations to existing pens to safely handle dangerous cats to be divided 4 ways between the SPCA and the 3 local authorities. Costs are yet to be obtained. Maintenance costs to be covered by the SPCA.

(b) SPCA Providing Traps and instructions to the public, then overseeing and receiving and accessing stray and feral cats.

Each Council to fund 2 Traps and SPCA to fund 2 Traps Costs to be obtained

(c) Notification of cats held as a result of trapping etc, via web site undertaken by the SPCA.

(d) Stray cats held by SPCA 7 days as per legal requirements, cleaning feeding etc undertaken by the SPCA, 7 days keep, euthanasia, and disposal costs charged to the authority from which the cat came from. Conservatively at a cost of \$100 per cat.

(e) Feral Cats, disposed of by SPCA as per legal requirements charged to the authority from where it came from, conservatively \$40 per cat

(f) Sick and injured cats handled and processed as per legal requirements, costs associated covered by the SPCA.

We propose that should the councils select Option 3, then it could be implemented initially for a period of 12 months, and then reviewed.

We look forward to your council considering the above proposals and advising us accordingly ASAP, so that we can take the appropriate steps in notifying the community as to what action they need to take to resolve the issues they are experiencing with Stray /feral/ cats.

I am happy to attend any meeting to clarify any questions raised.

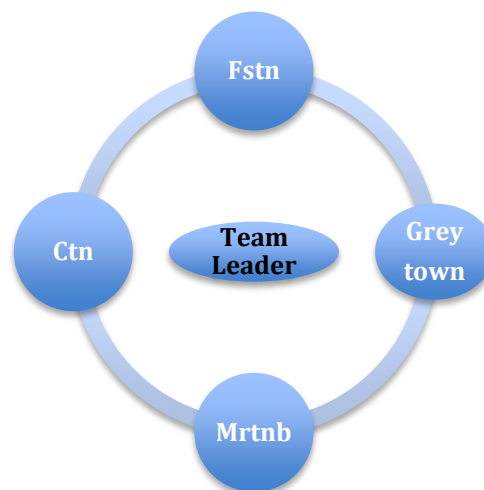



Quality urban planning and design creates places that work and places that have use and value. Urban design and urban planning have economic, environmental, cultural and social dimensions. The quality of infrastructure and quality of life are important factors in creating successful towns and cities. Quality urban planning and design can have significant positive effects on both of these by creating well connected, inclusive and accessible places. Creating quality urban outcomes requires action across a wide range of sectors and on a number of scales from regional, city, town, suburban, streets, open spaces and buildings.

### THE ANNUAL PLAN

---

I support the Martinborough Town hall and Community Centre project as I feel it incorporates quality urban planning and design to achieve the community goals outlined by the council on page 11 of the annual plan.

#### 1. Healthy and economically secure people

One of the aims is to provide a town that is more attractive – not just for our existing residents but also for new families and visitors. Support services and facilities for families are designed to attract more people to live and visit the South Wairarapa in order to support our local businesses. The health outcomes of having attractive and fun outdoor spaces are obvious. A community hub provides opportunities for positive social interaction. The centralisation of community organisations such as Plunket, the toy library and the connections with the health centre facilitate positive outcomes for a range of community members

#### 2. Educated and knowledgeable people

Libraries are changing in nature and it is important to provide a flexible environment for these changes. The renovated town hall will allow us to host more cultural events such as the kokomai festival where we largely missed out due to the unsafe and rundown nature of the hall currently. This benefits the whole South Wairarapa area.

#### 3. Vibrant and strong communities

This community centre project will provide a platform for the town to grow creatively as well as supporting economic activity such as events and our health providers. The aim is for the new design to reflect and celebrates the culture and identity of the South Wairarapa. This expression of community heritage, landscape, culture and values leads to a sense of pride and accomplishment – as well as the comfortable feeling of recognising that this is “home”. Safety and the prevention of vandalism or graffiti in the town centre is also improved by the concentration of activity in the centre. CPTED or crime prevention through environmental design techniques will be used and the opportunity for “eyes on the street” or surveillance will support the safety goals of the council.

#### 4. Sustainable South Wairarapa

Cultural, economic, social and environmental sustainability are at the heart of this project and is essentially the reason we have all committed so much to the project.

#### 5. A place that's accessible and easy to get around

The project addresses some issues that we currently have around accessibility in the town centre. There has been a lot of work done on this by the square committee and this project will take it further in ensuring that the Town Hall Precinct becomes a pedestrian and cycle friendly area while still allowing the normal traffic flow around the square. In addition car, bus and campervan parking to the rear of the precinct will improve the way we move around the town centre and provide extra parking for the medical centre.

### **THE URBAN DESIGN PROTOCOL**

---

This project also fulfils the seven essential design qualities for making more successful New Zealand towns in the Ministry for the Environment's Urban Design Protocol.

These qualities are outlined below:

Context: Seeing that buildings, places and spaces are part of the whole town or city

Character: Reflecting and enhancing the distinctive character, heritage and identity of our urban environment

Choice: Ensuring diversity and choice for people

Connections: Enhancing how different networks link together for people

Creativity: Encouraging innovative and imaginative solutions

Custodianship: Ensuring design is environmentally sustainable, safe and healthy

Collaboration: Communicating and sharing knowledge across sectors, professions and with communities.

### **THE COMMUNITY WORKING TOGETHER WITH THE SWDC**

---

There have been many plans and groups that have worked on improving the Martinborough Town centre but none that has taken such a wide view. This project pulls many plans together to provide an outcome that benefits such a large cross-section of the community. The project helps connect all the differing groups – the SWDC, the Martinborough Community Board, the Playground Committee, the Square Committee, the Ruamahunga Health Trust etc that have been previously working independantly.

This project has undertaken significant community consultation as outlined in the feasibility study that was compiled by SGL group. From the start of the process we have talked to groups and individuals and assessed their needs and ideas and incorporated these into a common vision.

We have pledged of nearly 1 million dollars from the community as I write this and fundraising is ongoing.

A large team of community volunteers have spent hours and hours working on this project. This goes way beyond the Martinborough Town Hall Working Group to others that have given their time for fundraising, publicity and writing, attending design workshops, attending interviews and forums, preparing feedback, lobbying major funders and investigating other community initiatives and designs.

In addition to this the leadership of Steve Bramley from SGL ensures that the project will be well managed. His experience in the development of significant community projects is invaluable to the success of this project.

## Footpaths

It has been suggested by council staff that our repeated requests for a footpath on Roberts street between Weld street and the school take the form of a submission to the annual plan. This is an extremely dangerous piece of road for children and other pedestrians.

The reasons that we request a footpath on this piece of road:

- It is the only access to the school from the south west corner of town as there are no other cross over streets until you get down as far as Jellicoe street.
- It is very narrow with many driveways and there are no footpaths at all and the the verge is often long and unmown.
- The intersection with Grey street is unusual and slightly off centre with an enormous drain which makes it impossible for a child to find a safe place to stand to get around the corner or cross the road.
- At the time this is used by school children there is heavy school traffic in the area
- The street is also on the public bus route and has a bus stop on it (also with no footpath or safe place to wait).
- There is a lot of heavy traffic that uses this road to access Palliser vineyard that is at the end of weld st – they drive between the 2 vineyards etc along this route

We walk/cycle our children down this road to and from kindergarten/school/sportsfields every day. It is very dangerous with blind spots at the school intersection. I have watched many scary instances with children on bikes or walking and traffic from the school on the intersection of grey street and roberts road. I am terrified someone is going to be seriously injured here. The combination of buses, school children, school car traffic and no footpaths are unacceptable to us as ratepayers and to other parents who live in this area of town.

We oppose allocating any financial or Councils management resources into the Martinborough Town hall Project. We are in very interested in heritage buildings, however we are concerned that the Council has been pressured into spending a large sum of money to earthquake strengthen a building which does not attract much use. Born and raised in the District we have in the past 25 years have only frequented the Town hall to attend funerals, Rugby Cabarets watch MADCAPS and have held the odd party in it, so on that basis it does not seem prudent to squander rate payers money on an amenity that the majority of residents have no use for.

While it may be ideal for concerts, we have several private venues within the Martinborough Boundary that the council could financially subsidise for these such random events rather than spend millions of dollars on a structure that will not increase its patronage. The other logical solution would be to drive 15mins to either Featherston or Greytown to use the ANZAC or Kuranui Colleges Hall, or even drive a mere 8 more minutes to the Carterton Events centre for this purpose

With a population of a mere 1500 do not want this council to fund putting an expensive sticking plaster on our crumbling hall and adding a space for the library The cold reality being we do not wish the SWDC to go bankrupt or

financially burden the ratepayers of the whole SWDC just to have a Town Hall that currently has a poor to even negative annual net rate of return .

The Library is though an essential Community asset, We need to either build or purchase one suitable for this need. Several years ago when the Library out grew its previous location (current museum) on the square to Jellicoe Street next door to P and K, we suggested that it would be preferable if the Council owned its own building for the Library and that the councillors consider relocating the Library to the old Featherston County Councils building across the road from the District Councils office, and incorporate the Info centre, now i Site within the lobby of the Library. The decision makers including one current Councillor boo hoo ed it citing that it would be too far out of the town centre ( The CBD) for the residents to come by and borrow a book, and that leasing a space was the only option; yet now owning our own library going as far as suggesting building a library in the Childrens playground area with no adjacent street parking, up against to a building that is going to cost an awful lot to bring up to spec is at odds with their original decision.

With international flights direct to Wellington set to increase with the runway extension and the Rimutaka Cycle Trail being recently opened as Great Ride, the Wellington/Wairarapa region is uniquely positioned to become New Zealand's premier cycling destination. An acknowledgement of this and conviction to support development of a network of trails (not necessarily through financial contributions) as part of the annual plan would be a great enhancement.

#### Quick, Cheap wins for South Wairarapa cycling

- Enhanced signage on known cycling routes, in particular Western Lake Road and Hinakura Road to Longbush and along the Bidwells Cutting Road where narrow shoulders and undulating topography combine to create poor visibility and an opportunity for poor passing decisions.
- Speed restrictions to 80km/h along western lake road adjacent to the DOC scenic reserves.
- Enhanced signage in Featherston to embrace its place on the Rimutaka Cycle Trail.

#### Other matters

Page 15 - Use of swapped land - should be made available for commercial development. The proposal for a Mens Shed has value, however to locate it here would be a terrible decision for the future vibrancy of the town. I would suggest seeking a location adjacent to the community centre or an existing park,

Page 15 - Martinborough Town Hall - I am concerned about the proposal to relocate the i-site to a "dead spot" in the town. If the i-site was to be related to the town hall it needs to have consideration given to providing an open and light inviting space with some surrounding activity to attract visitors.
