I am writing to say that I disagree with your decision to close South Wairarapa libraries some days as a cost-saving exercise.

I would like to see Greytown Library open every weekday. Being a town without a shared working space like that of Martinborough or Carterton I feel the library is an important resource for locals who need a place to work with internet out of home. Furthermore as a mother of two young children, having limited days of the week to get out new library books after school when we also have extracurricular activities on certain days after school as well is very restrictive and disappointing.

I have lived in South Wairarapa for over 5 years now and the library has played a pivotal role in my parenting experience. From preschool story time in the library on a Tuesday in Featherston to going with my girls to select new books, or escape the house on a cold, rainy day. The new hours limit these options for all parents and I think will be greatly met with sadness and disappointment. We can also no longer frequent the library as a whole family every Saturday, as during the week my husband works as a commuter and the new hours mean even if he catches the last train into town or the first one back to Greytown he will still arrive outside of library opening times on weekdays.

The library is a really valuable service for our community. It provides shelter, education, friendship and entertainment. It helps kids learn to read, teenagers find graphic novels, old people get online, and commuters find books to read on the train.

I'm really invested in keeping Greytown Library open every week day and every Saturday and I look forward to hearing the outcome.

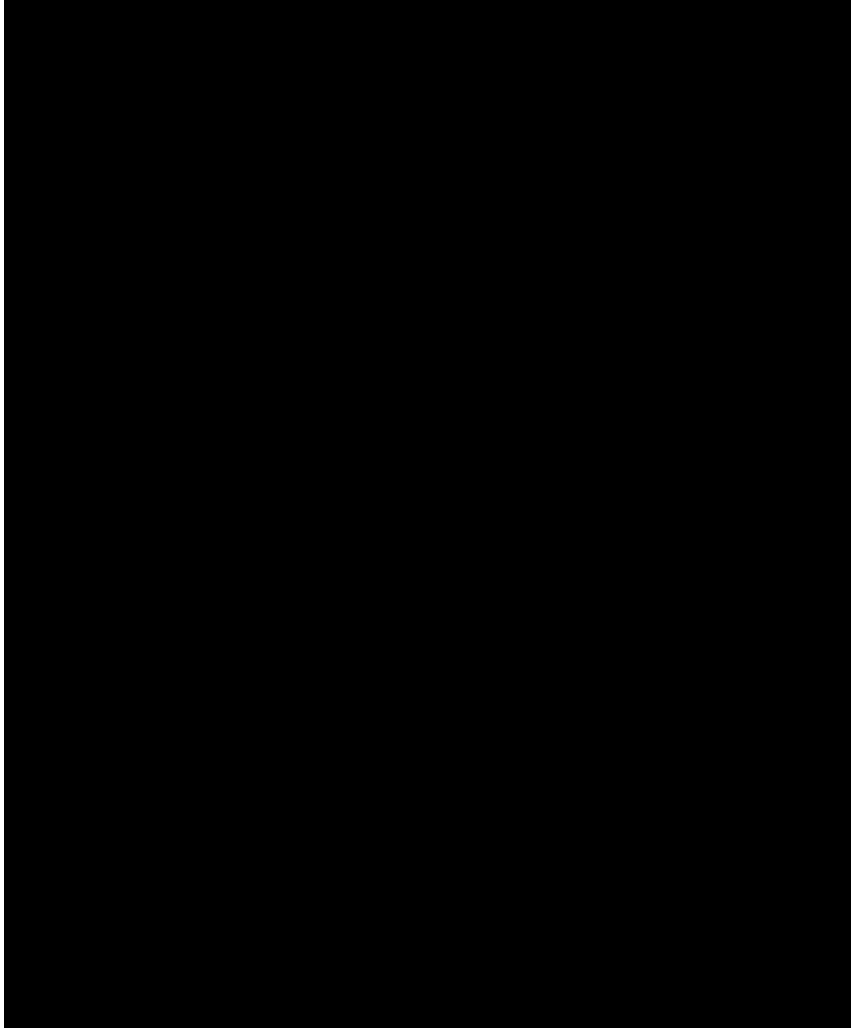
Hiya, I've read the Facebook post calling for submissions about the Libraries, and clicked through to the relevant SWDC webpage to read about how the decision came about. I submitted last time using the online form when we were asked to, and stopped in to a drop-in session too.

I have a [REDACTED]-year old boy ([REDACTED]) who attends [REDACTED] [REDACTED]. We often go to Greytown Library around 3pm on Mon/Tues/Weds, and as we live in Featherston we could theoretically pop into Featherston Library on any 'normal' day, including a weekend.

Libraries are more than just places to rent books; Featherston Library is also a print shop when Print Space is not open. Featherston Library is an Information Centre, now that the actual info centre is not used. Featherston Library is a service centre for everything Council-related in Featherston, like rubbish bags or dog tags or other bits and pieces. Featherston Library is the only safe, indoor community space for literally everyone of all ages/abilities/genders/races where there is no expectation of any financial transaction whatsoever. Featherston Library provides important internet and computer services for disadvantage households that do not otherwise have access to what is increasingly viewed as a human right. Featherston Library is where Penny, Liz, and the other hardworking librarian staff share their smiles, knowledge, expertise, and sweat as they deliver personalised quality service — and yes, they know us all by name.

I could go on and on and on about how much I use the Library in Featherston and what SWDC Libraries mean to me.

Instead, I'll simply attach a photo from 6.5 hours prior of my [REDACTED] old son discovering today that his safe warm Greytown Library space wasn't available to him any more, and that despite his efforts to open the door he could not get in.



■ be blunt, this is the education of our kids we are talking about. Library services are not ring-fenced and funding can be sourced from other line items, generated from sale of land assets, or charged out to ratepayers.

Thank you for reconsidering the hours the Council libraries will be open. This is something I am passionate about as the father of a [REDACTED] year old who loves reading and as an avid reader myself. The proposed hours just will not work for us, especially the very limited weekend hours proposed. I strongly suspect the approach will mark a death knell to our library usage. If we cannot be sure the library will be open when we leave the house on Saturday, then we are unlikely to visit. And to be honest, we will probably be less likely to leave the house at all as a result. The Saturday ritual of coffee / hot chocolate at a Greytown cafe, a visit to the library and then a treat from the French Baker or Bicycle Kitchen will be a thing of the past. A library is the heart of a community, and cutting hours so drastically is going to impact on more than just library lovers like ourselves - it is also going to impact on the businesses we frequent when we make our visits.

This move is also going to remove my refuge for when the water or power is (frequently) cut at home, and my access to resources that are useful to me in my work. It is also going to stop me from being able to access the extremely valuable information and advice that your skilled library staff are able to provide - including about how to access other Council services. And will the meeting rooms be available when the library is closed? I suspect not.

A few years ago the library staff covered and labelled books and library managers were able to source and purchase items to suit their clients. They no longer do these tasks so one would presume they would have more time for other activities. In those days casual staff were rare. Have the numbers of permanent staff been reduced? If not where is the extra money spent that they can no longer service the same hours? Is having an overall library manager the added expense?

It is interesting that Carterton does not find it necessary to reduce hours. You post that library membership and usage has increased by 29% in the last year. Is this a problem? Do you hope to decrease usage by restricting hours? Our libraries are also our community centres. In the days before staff were continually rostered to different branches they were places people could find a familiar face and someone to help with queries. You put up the rates and take away a service that most people in the community use and value.

As a Greytown resident who worked as a librarian in Wellington for over 20 years and as an unpaid volunteer at Greytown library for several years I find the council's decision to cut library hours quite shocking.

Out-of-touch Council closes Featherston library in classic 'dick move'

Featherston locals are angry, disappointed, and shocked after the South Wairarapa District Council (SWDC) announced through social media channels yesterday that the library will close on Wednesdays and Saturdays.

Featherston, which is New Zealand's only Booktown, and a community of young families and commuters will have its library closed on Wednesday and Saturdays from this Saturday, 1 July, which is also the first day of the school holidays.

The Council says the move is a cost-cutting exercise and was consulted on in the Annual Plan. However, many locals felt the Council has not been transparent and honest, and that what was consulted on was a pool of funding for sick leave cover.

Local professional and mother, Erin Banks said on the Council's Facebook page, "the fact that so many people are surprised and upset to read of these cuts today is testament to the fact the consultation didn't reach wide enough and the impact was clearly not communicated."

In an undemocratic move, on Thursday evening, the Council turned off commenting on the library closures Facebook post.

Award-winning author and local mother Noelle McCarthy said on Instagram, "this is a decision that directly impacts children in our community [and SWDC] you are not understanding what matters in a community and how working parents live." She was writing in reference to the closure of Saturday mornings.

Council scores own goal on announcement

In announcing the closure of some library days, the Council's own press release said, "the new roster will enable the libraries to remain open as much as possible, taking into account commuters who might not be able to visit the library during the week."

Across Wairarapa, at least 1350 people commute daily, with a significant number coming

from Featherston. Yet the new Featherston Library will open after the last commuter train leaves town in the morning and before the first train arrives home in the evening.

The wrong way to improve reputation

On 22 February this year, RNZ reported that only nine percent of South Wairarapa residents were happy with council decisions, a drop in satisfaction of 50 percent compared with the previous year's survey ^[1].

At the time, Mayor Martin Connelly was quoted as saying, "we have to rebuild the trust... we need to show people that we are listening, and we are taking their views seriously."

The closure of Featherston Library on Saturday demonstrates the hollowness of the mayor's intentions.

Libraries as a return on investment

The closure of Featherston Library on Saturdays is a Council bid to save money, despite overwhelming evidence that libraries economically benefit communities.

In the Council's own annual customer perception survey, the libraries are its most valued service. Since 2020 usage and membership has increased by about 30 percent.

In the UK, the economic value of health and wellbeing benefits through library engagement has been estimated to be 748.1 million pounds per year ^[2].

The value of libraries isn't news. In 2014 the Library and Information Association of New Zealand Aotearoa (LIANZA) commissioned a report that showed the economic value that libraries deliver to first-world economies like New Zealand's isn't in doubt.

"Hundreds of research projects across the OECD – some running for many years – have demonstrated that libraries produce solid returns on investment. Depending on the sector and the country, returns of 3:1 to 9:1 is typical – for every dollar invested, between \$3 and \$9 of direct benefit is achieved by society." ^[3]

What needs to happen?

Full reinstatement of the hours of the Featherston Library (Council is closing it on Wednesdays and Saturdays).

At the very least, open Saturdays. Closing on Monday mornings and 'giving' that half day to Saturday is a sensible move that would serve the community and cost no more.

As a [REDACTED] for the rollout of the Literacy and Numeracy assessments, I have seen the need for strengthening literacy among our ākongā. As someone who also delivers the Young Readers Programme for Booktown in my spare time, I have seen how empowering it is to give children the space to read and engage with literature. Removing a vital and free resource for young readers and their whānau on a Saturday morning is an absolute travesty, and completely goes against the aims of improving literacy levels in Aotearoa. It also seems completely at odds with promoting Featherston as a Book Town. It is essential that the library stay open on Saturday mornings.

As Featherston becomes more of a commuter town, this also strips access for those who may only get the chance to use the services on a Saturday. Libraries are a valuable community hub and resource, and when we strip these, we start to unravel the fabric of community. The library is one of the few resources in Featherston which is accessible to people no matter their age, gender, ethnicity, income, or ability, or interests. It feels like a real step backwards to reduce access to this resource.

I also think that more could be done to improve the community engagement with the South Wairarapa libraries. Things like drag story time for rangitahi and whānau have been incredibly popular around New Zealand, and would encourage more engagement with the libraries and reading.

I am just one of many who was dismayed, confused, and quite honestly taken aback at the news of the Featherston library now being closed on Wednesdays and Saturdays. I work as a [REDACTED] at Featherston School, and half of our classes now have to change their library days because of the Wednesday closure. Half of our school is affected with next to no notice. I don't drive, so having Saturdays cut out completely affects me greatly as well. The library is not only my second home, my primary source for reading material, my go-to for resources, but also the only place I can go to utilise services such as registering my dog. In addition to this, as a much broader point, Featherston is New Zealand's one and only Booktown! I don't know if you recall your own article on the matter, but we are even meant to be hosting the GLOBAL conference for the International Organisation of Booktowns next year!

We'll be a laughing stock to the 40 representatives of other booktowns around the world, if the changes go ahead. I am a [REDACTED] year old mother of 2, a [REDACTED] year old and a [REDACTED] month old. We currently spend every Tuesday morning at the library to join the librarians AMAZING story time. At this story time my kids have learnt to sit and listen to the librarian reading, sing along with their songs, dance to their dancing, socialise with other children near their age and much much more. We also spent at least 1-2 other morning during the week at the library, either playing and reading books or meeting other mums in the cafe or plunket area where the kids can read books and safely stay is our view. This is especially good in the colder months when it is too cold or wet to be playing outside.

Being a mum who has young children we also use the plunket area as a meeting space for new mums to meet, have a coffee, breastfeed and change our children and to just get out of the house for the benefit of our mental health. And yes I have tried breastfeeding in the cafe... it is not easy! Especially when I have had a toddler to look after too! This is the ONLY place in martinborough where I have felt 100% comfortable breastfeeding... I have been abused in local cafes, people near me have got up after staring at me and "huffing" because they don't want to be near it. This is more of a common issue than I ever realised... which is devastating... yet a different issue altogether! My point is this is a safe, warm and friendly space for all mothers to meet and feel welcome.

The library is also the only place you can go for a morning out that is FREE. And as we all know everything these days is rather expensive.... As much as I do like to treat myself to a lovely coffee at the cafe every now and then! Which brings me to my next point.... If people stop coming to the library then what happens to the cafe? It will eventually loss too much money and have to be sold or shut down. This is one of the only cafes in martinborough I can get my pram into! As well as many people who come in to the cafe who have wheelchairs or mobility scooters.... It would be heartbreaking to loose the ability to cater for EVERYONE in one place.

The librarians always put so much effort into have activities for the kids, either new book displays or computing in and the librarians all know my children by name... and my kids love them all! A library seems to me to be an essential service in a community. I use it regularly for doing computer work, photocopying and printing jobs as well as for borrowing books.

As I drove to Featherston library I thought that this would not be an option for everyone, particularly elderly people, youth, or those on tight incomes, to drive to the next town to use the library. It is also not a wise move environmentally, when we're all trying to minimise petrol use, to require people to drive to another town to use the library. A library is a good use of our planetary resources, a shared community facility; we don't all have to own and run our own computers, printers photocopiers and books.... a wasteful practise. And the libraries help those who struggle with technology.

Today the Waihenga centre was full of people wanting to use the library, particularly because it is the school holidays.

Our rates are rising dramatically but a council service we pay for through our rates and which we depend on is cut back; it makes no sense. In particular I think it's really unfair to only open every second Saturday... this will make it very hard for workers and commuters to use the library (which they pay for). I wish to register my strong objection to the reduced library opening days implemented from 1 July 2023.

I was not aware of the change until visiting the library on 3 July as, it would appear, is the case for many residents. The way, the inclusion of the budget to cover staff leave and the likely impact if not included, was described in the proposed Annual Plan was at best equivocal and at worst disingenuous.

Our Martinborough library provides an essential service to the community. It is astonishing to see that the cut to hours has been implemented during the school holidays when families are taking advantage of its services even more than usual. I note that Saturday opening is no longer available for the Featherston library. This is a harsh blow to the community especially for those that are in employment.

In addition to the reduction of library hours letting our rangatahi down, access to resources and computers is essential to support the community and literacy in particular. It must be remembered that the library is more than a place to borrow books. It provides a safe place for children, a place for elderly to read the newspaper, ongoing holiday activities, copying and printing facilities and access to computers to name a few. The Council cannot assume that all children, students and residents have access to computers at home. As you know we do not have any Government agencies, Post Office or Bank where those without computers can access some help. Once again, the most vulnerable of our community with so little voice are affected. The library is their only option and in Martinborough their access has now been reduced by more than 30%.

The Council's commitment and contact with the wider community is not discretionary. A functioning library is part of that picture. Without a cohesive community what does the town have?

One has to wonder at Council's commitment to the town, after encouraging them to raise many millions for what is now a very attractive facility it now wishes to diminish its accessibility and use with this short sighted change.

I would urge Council to reconsider its decision and reinstate the library opening hours.

As a resident of Featherston I do understand SWDC has to consider costs of operation and as a result the reduction of library hours and other services.

I do support the choice to pick fixed days to open. It makes planning easier.

I do NOT support the inequitable access to be libraries between towns that is proposed by the council. This is highly disappointing.

People working in Featherston have lost all access to the facilities and will be forced to travel under the current proposal while a fair system would prevent this.

The working class of Featherston contributes significantly to the SWDC rates and are locked out of the service while this is not needed if the council would consider a more equitable approach. Just travel as suggested by the Mayor on Facebook isn't always an option considering the costs of petrol as well as time constraints. Simply opening up a Saturday in Featherston would mitigate this.

The Saturdays are the only day some of the families can take their children to the library, taking away this option can have a significant impact on the literacy and academic performance of these children. Considering the lower socioeconomic demographic of Featherston compared with the other towns, these children already have enough barriers. Simply opening a Saturday would mitigate this.

I'm officially sending through my views on the library opening hours.

When SWDC asked for feedback on library funding in the 23/24 Annual Plan consultation document, it was made very clear in the document that the extra \$166,000 you wanted feedback on was “a pool of casual Library staff to cover leave”. That meant that what was at risk (in the eyes of those making submissions) was some occasional and irregular closures due to staff leave--NOT systemic cuts to library opening hours across the board. Had you made that clear in the consultation document, your public response would have no doubt been very different.

The fact that the SWDC took advantage of the situation to make drastic and systemic cuts that were NOT consulted on has eroded not only my trust in the Council, but (based on the social media response) the trust of many in our local community. I urge you to undo the damage you've done and return the libraries to their normal hours.

In particular, Saturday hours every weekend are critical--in Featherston, Greytown and Martinborough. Many Wairarapa residents commute to Wellington or the Hutt during the week, and we need regular and dependable Saturday hours--even if it's just the morning. This 'every second Saturday' business will be too hard for residents to track, not line up with when books are due, and eventually lead to no customers on Saturdays at all.

Where's the consultation?

Recently a stream of residents was shocked and angered when it was announced that SWDC has ruthlessly cut library hours in a significant and systemic manner across Featherston, Greytown, and Martinborough. The announcement was made on the Wairarapa Library Services Facebook page.

Why was everyone so surprised and angry? Wasn't this covered in the 23/24 Annual Plan consultation document? No, it wasn't.

Nowhere in that consultation document did it say that SWDC were planning on systematically cutting library hours. According to that document, the only thing on the table was “a pool of

casual Library staff to cover leave”. That is very different from asking the community if we would like to systematically reduce library hours. In fact, multiple days have been completely cut from the regular schedule.

This shows an egregious lack of transparency by the council. SWDC have utterly failed to meet their basic duties in consultation.

In addition, SWDC has shown itself to be extremely short sighted. It is a well-known fact that libraries make a huge contribution to fostering a literate community. Higher literacy rates are shown to be associated with less crime, higher earnings, and higher employment rates, and it improves the development of the wider community.

Reducing library hours does not increase literacy – it does quite the opposite. Reducing library hours harms communities. Failing to consult properly does the same.

I object to the Council's decision to cut the hours of opening of its libraries. The original consultation with the public on this matter indicated 50% of people making submissions wanted to keep the \$165,000 budgeted to cover staff on leave. The Council indicated that removing this amount from the budget would mean that libraries would be closed four days a month. In fact, the Martinborough library is now being closed the equivalent of ten days a month which is far more than the Council had previously suggested.

The libraries are an important community resource and a large amount was committed to the Martinborough one when the Waihinga Centre was built. It is particularly important that the library is open on Saturdays as this is when families can come together. People working full time cannot come on weekdays and children only have limited time to come after school.

I would like to see the libraries open six days a week even if this means reduced staff on some days or the use of volunteers. The library is important in many different ways. It is a social centre, particularly for children, parents, elderly and the poor. The café at the Martinborough site is linked to the library and would be affected by the closing of the library on ten days a month. This amount of reduction could even make the café's viability threatened.

Kia ora,

I just wanted to express my disappointment over the reduction in service of Featherston library, and other South Wairarapa Libraries in the new hours announced last week.

My [REDACTED]-year old son and I have Wednesdays off together and for the past two years we have biked down to Featherston Library nearly every week. On first reading these changes I was devastated that our special ritual was taken from us with no notice. When I told my son he was baffled and upset – why is it closed? But this is our library day? It is very hard to stomach a big rate rise when the community asset we make most use of will now be all but inaccessible to us. We can't simply change our day due to day-care hours and work schedules. All in all it's pretty heart-breaking. The library has helped foster a love of reading in our son and we will miss this place terribly.

The library is much more than just a place for books – and we see that whenever we visit. We change over our books, do some printing, partake in activities or story times, play with the legos and train tracks and often stay for well over an hour. In that time I have never seen the library not busy – and we always see at least one school group of around 20 children, sometimes more. In fact, as I understand it, Featherston School – which has no library of its own - has at least half the school attend Featherston Library on a Wednesday. Much of the discussion around Featherston library changes has focussed on the Saturday opening – which I agree is vital, but I would urge you to look at all the days of the week. Many folks can't just change the day they go to the library and some people do go every day.

People come in to get books, pay council fees, buy rubbish bags, and make general enquiries as the Featherston library is a one stop shop for all of these things, and our resources like this as a town are very limited. It's a hub for young and old, a warm and welcoming very special taonga that is very dear to our community. I think some of the broader use of the library has been lost in the discussions I've seen – it's a public space, in winter it's warm, for some people it's the only warm, free space they can be. I work adjacent to the Carterton library and there are everyday regulars who come here because they have nowhere else to go – I'm sure the same is true of all the libraries in the South Wairarapa Region. We are talking about people's sense of belonging, their basic needs, their access to education and literacy here – none of these are "nice-to-haves".

I know the WLS have done everything they can to maintain their service levels, and it's so sad the council chose not to keep this resource accessible to all. As it stands many of the librarians I have spoken to have said they are already pushed for time to do the library work like weeding and shuffling that is so important in their work, simply because they are so busy with the public actually using the library. Reducing hours means concentrating these people across fewer days – and even less time available for the library staff to maintain a high standard of work and keep the library functioning well and thriving rather than just surviving.

Some thoughts on potential solutions might be:

- As a first point of call I think having at least an alternate Saturday would be important for Featherston's working and commuting population.
- \$165,000 seems pretty small-fry in the context of council budgets – would it be possible to use funding from say other areas like new acquisitions or other areas of council to supplement libraries? Taking funding from other projects by extending their timeline for completion?
- Could the libraries be open every day but with reduced hours?

Lastly, thank you for responding to the public outcry by requesting further submissions on this topic and the hosting of an informal meeting with elected members of council and the Featherston Community Board. Thank you for taking the time to listen to your community – I hope we can reach a point where this decision can be 'unmade'.

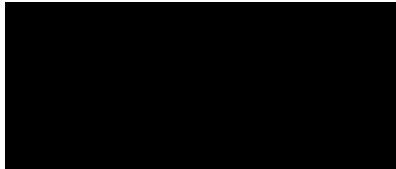

Thank you for the opportunity to provide feedback on this issue. Happy to have my feedback posted on the website.

Within my sphere of the community it would seem there is no support for the councils majority vote to remove the budget for casual librarians within the South Wairarapa. Lets be clear this is a council decision and not a public decision following a consultation process, which perhaps some media comments may suggest.

I have concerns about the consultation and deliberations process, particularly in relation to how the information was presented.

After reading the consultation document, much is made of increasing budget for water and roading, however the only options provided for budget cuts were casual librarians and community grants. The tone seemed to be increase budget for these vital options and reduce budget for less vital options. The general public could be misled to view this as a “one or the other” situation or rank in importance. When you read the public feedback from the deliberation report, a number of comments mention that water is more important than the library which supports this idea. (See deliberations report on council website)

I’m unsure whether the council was presented with the deliberations report as part of the voting process. If so the 4 options are all skewed against the casual librarian budget. Options 2, 3 and 4 in the document site **significant community support** for those options. All options had the librarian casual budget removed.

Significant community support is a stretch of epic proportions. 152 submissions were received on the casual librarian budget option. 50% voted to keep it in the 23/24 budget. 50% voted to have it removed, bearing in mind my previous comments. The SWDC notes that less than 2% of ratepayers responded to the public consultation. Perhaps the council is disconnected and needs more information to make these decisions. I would presume the community boards who represent and advocate for the community would have their fingers on the pulse of community sentiment. The decision to reduce hours in Featherston is embarrassing given that Featherston is positioning itself as “ NZs only Booktown”.

To put into perspective removing the budget item for casual librarians accounts for 0.5% of SWDC revenue. I understand the COL crisis requires that councils review every budget line, but why choose this cost centre? It is purely a budget as the SWDC state and there seemed some ideas that could lessen the need for this budget (volunteer librarians for example). Library use has increased by 30% over recent times. The library is one place we can go to where we don’t need to spend money for entertainment, providing its open. It allows social connection, which is waning as has been well documented.

From a council perspective, I could imagine the challenges of an apathetic public. Engagement of all

groups within the community is so important for decision making. As humans we make mistakes, and from this perhaps the community will learn to be more engaged on public consultation and voting. My family's request would be that the council roll-back its decision and re-instate the budget for casual librarians. Acknowledging the mis-step based on a lack of information may be an opportunity to foster improved community engagement.

I am making a very brief submission, as requested on the SWDC website, concerning the opening hours of SWDC libraries.

I live in Featherston, and was concerned to see Library hours reduced, especially with weekend opening being removed from Featherston Library completely (notably being kept at both Martinborough and Greytown- two communities obviously already wealthier and more privileged than Featherston). While other (Martinborough & Greytown) library hours were reduced more, I think the Saturday reduction in Featherston would have a proportionally more negative impact, largely due to the high number of commuters and less privileged people in Featherston. The removal of a Saturday in Featherston would obviously mean people who work normal (ie. somewhere between 7am and 6pm weekdays) working hours would not be able to access the library at all.

I urge SWDC to reconsider the move to reduce opening hours, and instead consider raising these funds from another source (increasing rates on derelict urban commercial buildings, for example).

It seems to me (from the outside looking in), that these cost-cutting measures were always on the cards, but were hidden within misleading wording - as evidenced by your Instagram post on June 16 that said:

South Wairarapa District Council (SWDC) wishes to correct recent misinformation shared in social media about the proposed 2023/24 Annual Plan funding for the Wairarapa Library Service.

I would also like to express my dismay at some of the comments made by councillors on social media in reply to residents expressing their disappointment at the changes. The Mayor's comment that Featherston residents could drive to other libraries on Saturdays is both insulting and out of touch with the realities of our community, where people still use public transport to get around and can't afford to travel to other towns for that reason.

I welcome the Mayor's statement regarding the possible reverting to previous hours

and look forward to Featherston getting their Wednesdays and Saturdays back.

I hope that the SWDC will listen to reason and reconsider these decisions and also show due consideration to the welfare of our valued librarians who do so much for the literacy of our tamariki.

As a current school principal (19 years) and 35 years in teaching I would implore you not to reduce in any way the operation of the Featherston library its opening hours and services.

People are struggling to pay for essentials in their homes in terms of mortgages, petrol and food. Access to books is a lifeline to many elderly, unemployed and parents with children.

A small picture book in NZ costs around \$30 to buy. This is out of the budget for many parents.

If we are to lift literacy achievement and therefore economical wealth for the country and region by having highly literate people, they need access to books, for free, especially on weekends. If there are to be closures then richer communities like Greytown and Martinborough would be much better placed.

I grew up in a household where we could not afford to buy books and my father was illiterate. The local library was a lifeline and got me on a path to reading and to education. Without access to a small community library my life would have been very different. Digital devices and reading online is not the same and not an appropriate substitute for selecting books in a library each week.

Please find other ways to reduce costs if this is indeed a cost cutting exercise. Many Featherston people have little petrol money to drive to another town. Featherston continues to be deprioritised in the South Wairarapa. Please consider other areas to reduce costs to the ratepayer eg. Reducing staffing salary costs, removing ineffective and superfluous meetings, poorly planned projects and general overheads at the council itself as a first option closely followed by considering what can be reduced in the wealthier communities of Greytown and Martinborough. Other councils are creating hubs for their communities. I would suggest we look at how to expand services for Featherston, not reduce them. Our elderly and people at home with little to new transport options need a library open every Saturday without fail.

The question posed during the Annual Report consultation failed to convey that reducing funding of \$160,000 would result in the partial closure of all of the South Wairapa libraries (excluding Carterton). Had this been better articulated, the response (based on the current community reaction to the closures) would undoubtedly have been quite different.

The reduced hours was also poorly conveyed to the public. Communication has to be broader than social media channels such as facebook to reach the whole community. The rapidity of the changes was also of concern for a decision that was clearly going to have an impactful (negative) reaction from residents.

As many submitters have already commented, libraries hold a pivotal place within the community. Libraries are our portal to learning and enrichment, deliver Council administrative functions which often have a regulatory role e.g. submission of dog registrations, provide essential IT services at no or minimal cost to users who otherwise have no access to these, and are an important place of connection for our communities.

The closures are particularly impactful on Featherston residents as with no Saturday service, access to library services for a large segment of those who work Monday to Friday out of town, are now non-existent.

The Featherston closures are also out of alignment and intent of Featherston's increasingly high profile as New Zealand's only Booktown, an initiative that the community are overwhelmingly proud and supportive of. A limited library service will simply signal to visitors that books and its artefacts are not valued.

Of all the positive services within our communities, libraries rank highly. We don't need our towns to be slipping further backwards and I ask that the Council reconsider and reinstate this essential service which provides so much to our community and wider society.

I was shocked and disappointed to see that Featherston library would be losing Saturday service, and feel misled by the limited public consultation on this matter.

I am not personally dependent on the library being open on Saturdays, but I feel compelled to speak on behalf of those who are - people who may be under-represented in submissions due to their limited time and resources.

It was apparent how out-of-touch our councillors are when one suggested that Featherston residents simply drive to Greytown or Martinborough to use the libraries there - given the cost of petrol, the fact many library users do not have a car, and the environmental impact, this is a disappointing take. Saturday is Featherston's busiest day, when many residents visit the fruit and vegetable market and those working Monday to Friday have the opportunity to shop.

Libraries are not just for checking out books, but are, for residents on the lowest incomes, the only place where they can copy documents, pay council bills and use the internet. These residents, who pay the same rates as everyone else, directly or indirectly, are often working Monday to Friday on the lowest wages. They cannot simply visit during the week and they are unlikely to be able to visit the region's other libraries. They are simply losing all access to a service they pay for.

I expect to see our rangatahi heavily disadvantaged by this move as well, with those without internet access at home hurt the most - Featherston does not have a highschool, so all of our young people commute from Greytown or Masterton, with limited time to use the library on weekdays, especially after accounting for after school activities.

While I appreciate that spending has to be cut somewhere; I hope this move will be reconsidered. For Featherston to be the only library deprived of weekend opening hours is manifestly unjust.

Thanks for the opportunity to comment on the recently announced reduced library hours for South Wairarapa District. My submission will be brief.

I understand that the vote not to allocate funding for a pool of casual staff to cover leave is not reversible and that sometimes as a result, the library in Featherston will be closed due to staff being on leave of various kinds.

My preference is that Featherston Library is open according to its hours before any closures came into effect, that is, open every day except Sunday. I understand that the library may need to close sometimes if staff are on leave.

If this is not possible, and some regular reduction in hours must occur, my preference is that the closed days are during the week and not on Saturdays.

My reason for this is that many people, including myself, work in town during the week, and Saturday is the day that we can visit the library. The library is more than just a place to get books out. It is a key attraction in town and a visible Council presence. It is important to maintain this in our town. I do note that weekday opening is important for our school kids and parents with young children.

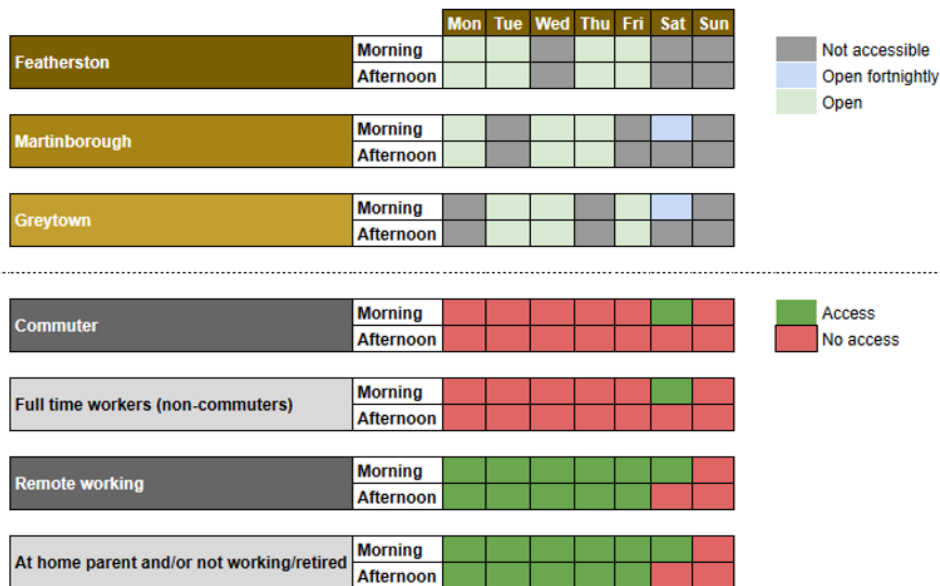

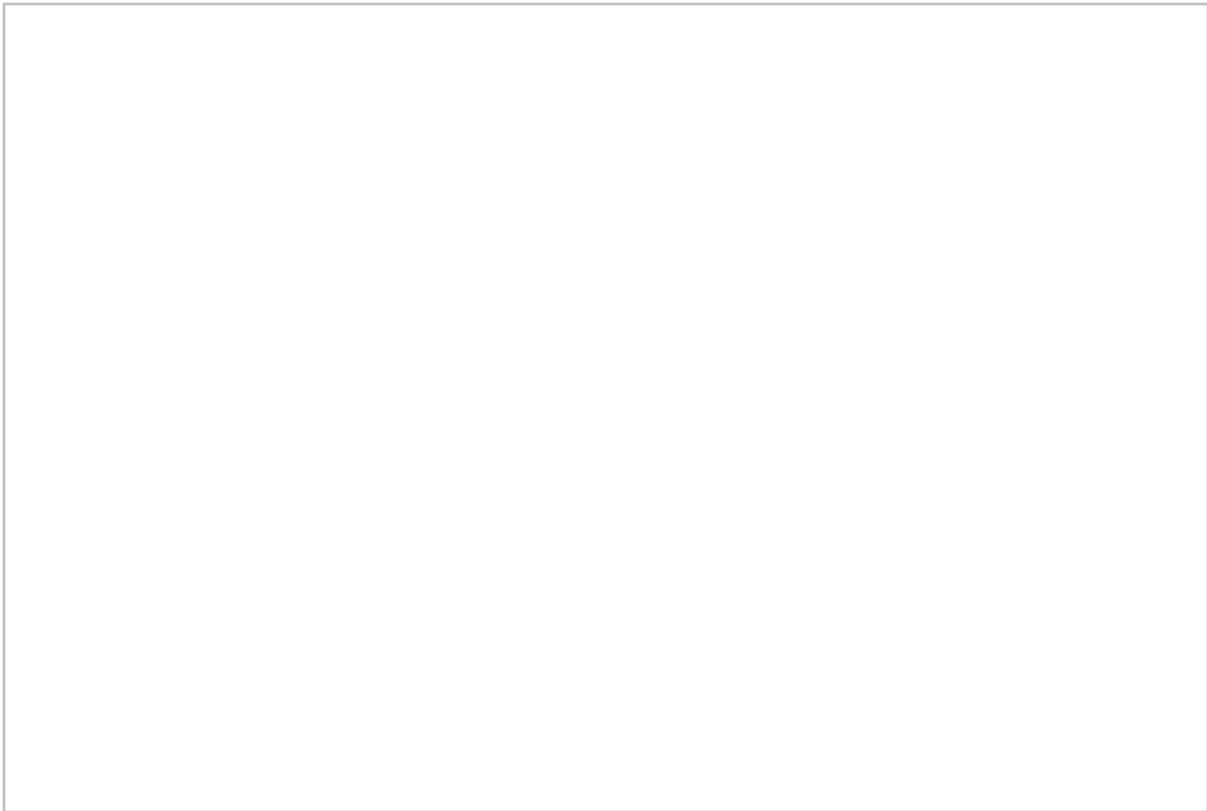
Thanks for inviting public views on library opening days. I'm happy to be available if you'd like to discuss any aspect in more detail, and you have my consent to publish this submission.

On SWDC's previous decision, offering only week-day opening hours for libraries effectively removes the ability for local working families to access SWDC library facilities. This affects all families and people in the region, and particularly those who work out of the region - particularly Featherston, where a meaningful proportion of the working population commute.

The schedule below roughly shows the effect of the previous options - full time workers having, at best, a Saturday in Martinborough or Greytown - with no local option for Featherston residents in this position. It does seem clear this option is unfavourable.





With this in mind, SWDC's first-best option is to consider:

- opening at least a full day Saturday - if not both Saturday and Sunday (with staggering across the three townships)
- to reduce or change weekday hours or weekday availability in compensate - for example, opening at 10am or in the afternoon.

To the extent it hasn't already, the SWDC could look at what hours other councils offer - there will be many smaller districts in NZ with similar challenges. From a quick review, it is clear that most councils offer a combination of later morning open hours (e.g. 10am) and evening hours (e.g. 6pm to 8pm), and opening on Saturday and/or Sunday.

SWDC may also like to use this opportunity to progress the Councillor's decision to explore opportunities of service delivery with community - for example, use of volunteers.

Please include the list of our concerns regarding the reduction in library hours throughout the South Wairarapa for consideration in the library hours review. We all live in Martinborough and share a love of books and the value that the local library and staff provide.

Key points:

1. The third place

The library acts as the third place for a community after home and work. They are places where we exchange ideas, have a good time, and build relationships.

2. Library functions

A library's basic functions include the promotion of education, the dissemination of information and the promotion of culture.

3. Opening hours

Standard opening hours are essential for ensuring accessibility to the library and enabling the community to benefit from its functions and purpose. These hours support access to all the community and not just those able to make their way on the days it is open.

4. Services to children

The services the library provides to children should be seen as a priority. Currently, schools visit the library to teach children what is available and how to research. School holiday programmes are enjoyed by many families and regular interactions with children of all ages is possible throughout every day.

The library plays a crucial role in providing services to children, modelling curiosity, fostering learning, and granting access to quality information. Limiting access impacts those who are less likely to have access elsewhere, undermining the investment made in the library service.

5. Support for the elderly

The libraries operate as a place for many elderly people to have regular contact. It provides them with access to a wide range of resources and activities, fostering intellectual stimulation, social engagement, and a sense of belonging within their community. Loneliness is a significant issue in this demographic and libraries have and continue to be a place that acts to minimise isolation.

6. Impact on adjacent businesses

The negative effects of limiting hours will affect businesses and services located near the library. An example is the Martinborough Library which shares space with the iSite and a café that will see a drop in foot traffic from library users on the days the library is closed.

7. Need to improve customer space.

There is a need to improve the customer space of libraries in South Wairarapa, as the current focus on book stacks has overshadowed the library's purpose as a place of learning, fun, and safety for the community. The restrictions experienced by both the Greytown and Martinborough libraries due to their design as storage facilities rather than a customer space should be improved rather than have reduced investment.

8. Lose partial benefit of the national system of libraries

The amount required to maintain current staffing levels and therefore opening hours is well worth the money to maintain a core service at the standard enjoyed by other library users around the country.

The library services not only work closely with each other in the South Wairarapa and have links to the Wellington libraries but they are part of a national library system which maintains catalogues, interloan, Aotearoa People's Network Kaharoa (APNK) for free wifi and other services funded by central government at no cost to councils. Reducing access reduces the full utilisation of these free services.

9. Summary

In summary, retaining the current opening hours of libraries is crucial to preserve the library's role as a community hub, provide essential services to children and the elderly, support adjacent

businesses, improve customer space, and maintain access to the national library system.

Summary of submission

- The change that has been made to library hours is not the change that was consulted on in the Annual Plan Consultation document.
- The information currently available and the current two-week feedback period does not meet the requirements of the Local Government Act.
- South Wairarapa District Council needs to run a consultation for this decision that meets the requirements of the Local Government Act and its own Significance and Engagement Policy.
- I disagree with the decision to reduce the opening hours of South Wairarapa Libraries.

The scope of consultation to date

In the annual plan submitters were asked to submit on a choice between:

- Keep a budget of \$165,000 for the cost of casual staff to keep libraries open when permanent staff are on leave.
- Remove the budget for the cost of casual library staff and risk continued library closures on some days of the week.

On 9 June the outcome of removing the budget for the pool of casual staff was reported by council to me “that some libraries may be closed on some days due to a lack of sufficient staffing numbers, estimated as 4 days per month”

All the wording implied that the impact of not having this budget available was ad hoc closures at reasonable levels.

What was not consulted on was a permanent and significant reduction in the hours of service across all libraries. Specifically, a 41% decrease in the hours of service at Martinborough and Greytown and a 27% decrease in Featherston (but made worse by no weekend hours).

Consultation requirements

The change that has been made is outside what was consulted on and given its significance that is in breach of the Local Government Act and SWDC’s Significance and Engagement Policy. The degree of significance of the decision is high because the decision involves a large reduction in a level of service, has a moderate impact on a high proportion of the population and is inconsistent with community outcomes. Accordingly, to lawfully make this decision SWDC needs to meet the requirements of consultation under the LGA as summarised by council here:

That involves an options analysis, making the information as widely available as

possible, and a month-long submission period. The information provided in the Annual Plan and the current two-week submission period via email is insufficient.

My feedback on the change

I disagree with the decision to reduce the opening hours of South Wairarapa Libraries by such a significant amount. I would like:

- To see the libraries return to full opening hours and close on an ad-hoc basis as required due to staff leave.
- To see a full review of the libraries budget to identify where cost savings can be made without reducing opening hours.
- The requirement that a library cannot open without at least two staff to be reviewed. With changes like self-check-out and current library attendance it is not clear to me that two staff is always necessary.
- Each library to be open each weekend for at least 2 hours. Every alternate weekend is confusing and no weekend hours for Featherston is not acceptable.

If for some reason none of these options are available, I would prefer to see the opening hours be reduced (for example 10am to 3pm) rather than libraries be completely closed some days.

Libraries are the communities most loved council service. They are a place of learning and a sanctuary. I strongly disagree with such a huge reduction in service without adequate consultation.

Good afternoon

I wish to point out how disappointed I am to see the reduction in library hours across the board, and particularly in Featherston where I am a resident. How can it be that these are not going to be available on any Saturday going forward? And why is it that the other towns will still have access to these services within the weekends and we will not?

It is becoming apparent to me that there are some misunderstandings within council as to what the constituents want from their significant, more than 50% in three short years, rates increases. I can assure you what we do not want to see is reduced access to fundamental community services. You are clipping costs in all the wrong places rather than doubling down and investing in the appropriate areas, such as an appropriate development contributions policy which would allow you to finally start collecting appropriate funds from all the new subdivisions and developments, rather than leaving the existing households to pay the exceptionally expensive new costs.

Furthermore I did not see any consultation available with the community to discuss library hours? Did I miss this opportunity or was it not undertaken?

I am beginning to lose confidence in the SWDC and seriously questioning whether I should consider relocating to a district better equipped to deal with its finances, collection and spending. And providing more appropriate communication along the way.

I am still reeling about the impact your new unbudgeted (in the LTP) rates increase and the effect it is going to have on already vulnerable parts of our community. More pensioner and family poverty to be seen coming up locally in the existing recession and cost of living crisis, let alone with such irresponsible policy. I say again, where is your development contributions policy and why has it not been implemented earlier, years and years earlier like other councils across the nation? Why are you allowing this oversight to continue to penalise the general population of your district and allow all profits to go directly to developers without the necessary growth portion of expenses being gathered at the time of consent.

I cannot express enough how frustrated I am with the current direction this and the previous council has/is taking and I for one would welcome another public meeting to allow us to air our concerns.

The 2023 AP consultation asked for comments to: *“Include a budget of \$165k for a pool of casual Library staff to cover leave or remove the use of a pool of casual staff that will result in libraries being **closed more often.**”*

On June 28th councillors determined to not fund a pool of casual staff. The SWDC media statement on the same day stated: *“Not fund a casual pool of library staff to provide backfill as needed so that libraries may remain open six days a week. This has saved \$165k, however, libraries **will be closed at least one day a week.**”*

Suddenly the proposal has changed from covering leave and sickness and *“being closed more often”* to *“being closed at least one day a week”*. All but three Councillors voted for this still, there was no discussion of permanent days closed.

On the 29th June, the very next day, SWDC reported that libraries will close **two days a week and some Saturdays.**

This decision was made in less than 24 hours after the casual funding was not approved. Surely to make such a decision, receive a recommendation report, review the data, analyse the options, clarify any facts, maybe bounce the idea around with others, and agreed a totally new, very reduced schedule of opening hours takes more than 24hours. Or was a fast decision, with no structured analysis, rushed through as a reaction to the decision to not fund casual staff. The AP shows a requested increase in library funding of \$535k so libraries still received \$370k more this year to provide the same service as with no special projects highlighted.

On the 2nd July, one working day after the closure announcement, it was decided to run a “consultation” on the decision to close. We are given no information other than what was provided at the AP, we have no options, no costs and no focus for the feedback to this “consultation”. Asking what do you think about the closures after they have been closed is not a “consultation”, it is a call to arms.

What if all decisions made by elected Councillors in the AP, were to be “re-consulted”? Whoever approved the cost of this immediate new “consultation” shows no awareness of tight budgets or the need to be prudent with our rates. Staff time and energy has had to be redirected from other projects.

In the AP submissions a number of people suggested interesting and innovative ways to support

library staff during sickness and vacation. These included; returning to using volunteers for adhoc sick days, reassigning council staff from desks at the Council offices or from “working at home” to the Library so that library staff are not working alone. Collaborating with I-site staff. Brainstorm, get creative. Many other ideas need to be fully considered before we are held hostage to relitigating annual plan decisions days after being made.

I do not want to reinstate any budget for casual staff to cover sick and vacation leave at Libraries. I want creative options to be considered and tested. Also, a thorough objective review of all Library costs and processes by management to find savings. Councillors need to give oversight and ensure that the service is delivered appropriately for our towns within the budget agreed.

1. This submission on behalf of the **[REDACTED]** expresses our concerns regarding the proposed reduction of library opening times at the Featherston Library. As an organisation committed to promoting literacy, community engagement, and access to books, reading and information, we firmly believe that the Featherston Library is more than just a library—it serves as a vital community hub that offers a wide range of services to residents of all ages and backgrounds – particularly the sizeable number of residents who commute to work outside the town and only have the weekend to access community facilities such as Featherston Library.

With Featherston being a commuter town, many residents rely on the library to provide a quiet and conducive environment for their academic pursuits. 4. Additionally, the Featherston Library hosts regular Age Concern, Digital Seniors, and Justice of the Peace (JPs) clinics, which are crucial services for our elderly population. These clinics provide vital support and advice, ensuring that our seniors can access the assistance they need. By reducing the library's opening times, we risk isolating and disadvantaging our elderly community members, who rely on these services for their wellbeing.
5. Furthermore, the Featherston Library serves as an Information Centre, providing residents with a central location for Council-related activities such as registering dogs and obtaining rubbish bags. By curtailing library hours, we hinder access to these essential council services, inconveniencing our community members and potentially causing administrative difficulties.
6. Featherston is home to three primary schools, namely Featherston School, St. Teresa's School, and South Featherston School. These schools heavily rely on the library during school hours to support their educational programs. Reducing the library opening times would limit access for these schools, hindering the students' ability to engage with reading materials, conduct research, and develop crucial literacy skills. Our schools are the foundation of our community's future, and we must ensure that they have the resources they need to succeed.
7. The Featherston Library is also an important space for community events, particularly for children. It holds regular children's events during the week and school holidays, fostering a love for reading and storytelling among our young population. By reducing library hours, we risk depriving our children of these enriching experiences and the opportunities for social interaction and educational development that they provide.
8. The Featherston Library holds a special place in our community as New Zealand's only Booktown. This unique designation reflects our town's commitment to literature, storytelling, and community engagement. It is disheartening to note that Featherston has been disproportionately affected by the proposed reduction in library hours, compared to the other South Wairarapa towns.

We urge the Council to recognise the significance of the Featherston Library as a cultural and educational asset and reconsider the proposed reduction in opening times.

1) Libraries provide an important resource for their communities. Not only do they support literacy and reading, but, more and more, they are the only place that locals can get help and information about government services and other concerns. With no CAB in South Wairarapa the librarians often become de facto advisers particularly when people need help with managing online interactions. Libraries should be open regular hours each week, including some regular times outside normal business hours.

2) It is particularly concerning that the hours in Featherston are being reduced given its position as New Zealand's only Booktown and an active member of the [International Organisation of Booktowns](#), one of whose aims is to strengthen rural economies. Having a part-time library isn't a good look.

3) In difficult economic times people rely on libraries to provide some connection and entertainment, which is often vital to their wellbeing. Reducing the libraries' hours risks undermining the wellbeing of those who are less well off, and their quality of life. This in turn affects the wider community.

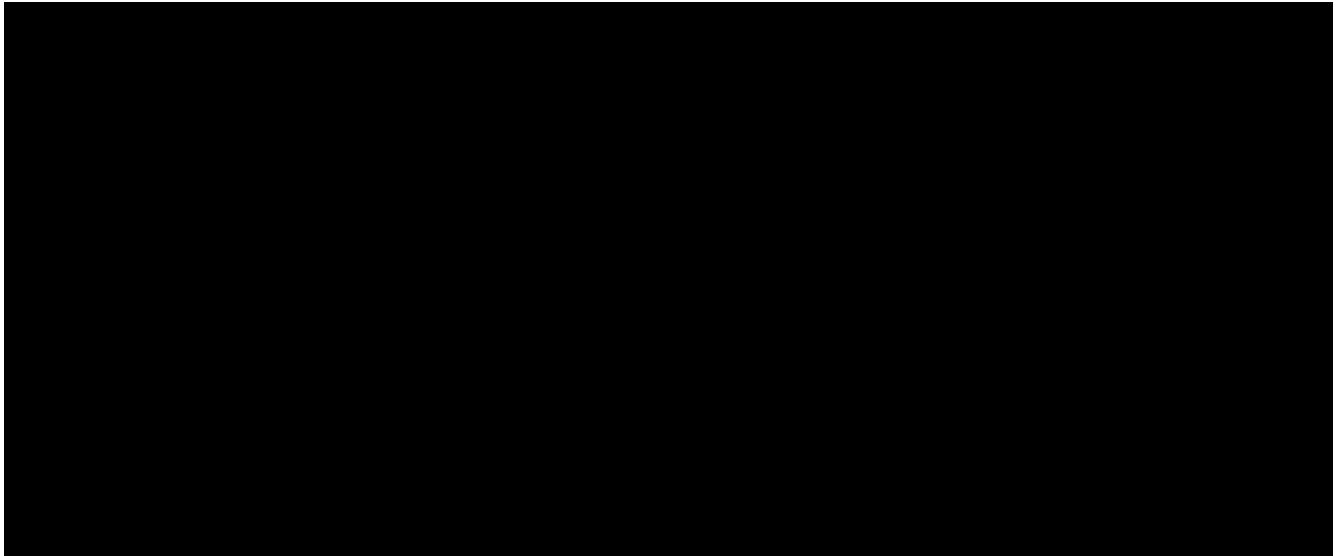
Featherston Library – the community of Featherston has many young families and people who commute to work therefore can only access the library on a Saturday.

Thank you for the opportunity to provide feedback on the changes to the opening hours of the South Wairarapa Library service. I consent to my feedback being shared anonymously.

I do not believe that the outcome of drastically cutting the opening hours of the libraries has been communicated in good faith. Your own website (<https://swdc.govt.nz/news/council-passes-four-resolutions-that-give-direction-to-the-2023-24-annual-plan/>) states

Remove the \$165,000 for a casual pool of library staff on an 'as needed' basis to cover scheduled and unscheduled leave, such as sickness. This means that some libraries may be closed on some days due to a lack of sufficient staffing numbers, estimated as 4 days per month. (9 June 2023)

The above statement is quite different to the outcome we know find ourselves with, 7 days less access per week across the three libraries. I have read the previous submissions published on your website (https://swdc.govt.nz/other/council-to-review-library-opening-hours/?fbclid=IwAR3DagFUuKiVRvsvUzUCZQugkJdSq3TZs_5hGSr_SHZs41xMG9kDNBwiuio) and it is clear to me that I am not the only one who did not understand the severity of the decision not to fund the additional casual library staff. I believe this highlights a failure of council to communicate the true impact of this funding decision. I would ask that you do what you are able to to increase the opening hours to be more in line with what was consulted on.

Libraries play a vital role in our society. You boast on your own website (<https://swdc.govt.nz/news/correcting-comments-on-the-library-service/>) that the library is the councils most valued service -

The libraries are the Councils' most valued service in its annual customer perception survey. Since 2020 usage and membership has increased by approximately 30%. (16 June 2023)

Why would you cut your most valued service so dramatically? A cut in hours will result in a cut in usage, will this then be used to further cut services?

A library is one of the few places anyone can go and enjoy with no financial transaction being required, a vital service as we find ourselves in this cost of living crisis.

As the mother of two young children, libraries have saved me on more occasions than I can count, a warm dry non judgemental space filled with amazing resources for old and young alike, a welcome break from the busy and sometimes incredibly lonely world of being a stay at home parent. My children love books and I love being able to give them an opportunity to explore the world through books at no significant cost to my family, this is a something that all tamariki and their whānau should be able to enjoy.

Literacy empowers and liberates people. It is well known that improved literacy leads to improved social outcomes. Libraries play a crucial role in enhancing literacy within our

communities. As a council, you should be doing everything you can to empower the people you serve.

With one of my children at school and a husband who commutes we will now have very limited chances to enjoy the experience of the library as a family. Our family will not be alone in this situation.

I urge you to reconsider the decision you have made. The decision to drastically reduce the libraries opening hours will impact our most vulnerable citizens, many of whom are, unfortunately, not yet old enough to vote.

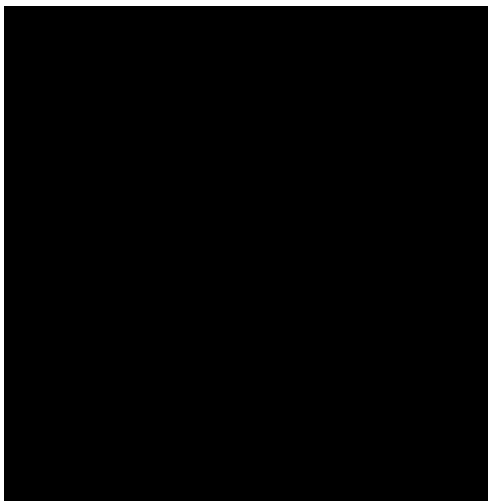

This is worth so much more than the amount of money you are saving by partially closing the South Wairarapa Libraries!

A public meeting was held on 6 July 2023 at the Featherston Community Centre attended by members of the public and elected members of the community board. The following points came out of the discussion.

- The library is a public resource used by the local schools, which have limited library facilities. The closure of the library during the week for a greater number of days will have a significant impact on the educational outcomes of the local school children.
- Featherston is now partly a commuter town. Therefore, a large proportion of the community is able to access the library only on a Saturday.
- Featherston is also recognised national and internationally (and fully supported by the Council through grants) as a Booktown.

Following this meeting and after receiving a lot of community feedback, the Featherston Community Board resolved to take all feasible action to work with the South Wairarapa District Council and the Wairarapa Library Service to restore the Saturday opening hours at Featherston Library while maintaining the current four-weekday opening hours.
