PURPOSE

To inform members of the Community Wellbeing Fund grant submissions for September 2024.

EXECUTIVE SUMMARY

- The Community Wellbeing Fund opened in June 2024, with three deadlines and meeting dates for community to apply to and present at in July, September and November.
- Due to an overwhelming response in the second-round (deadline 16 August 2024, meeting date 4 September 2024) the CWBF Subcommittee agreed to postpone the original meeting from Wednesday 4 September and rebook it for Saturday 19 October
- This was to ensure that everyone who has applied has an equal opportunity to speak to their
 project and for all projects to be heard and assessed in full. Following this, the CWBF
 Subcommittee publicly announced a submission extension to the 18 September to allow those
 who were going to apply by 31 October to be included in final allocations.
- The Community Wellbeing Fund has received a total of 78 applications, with a total funding request of approximately \$1.4 million.
- The Community Wellbeing Fund has been well received by the South Wairarapa Community and extends to Carterton and Masterton communities.
- Through the live phase of the fund Member's and Council officers have had rich engagements with Community Groups, charities and local 'heroes' to support in grant applications and advise on best practice funding.
- Grant Guru launched during the same time has been great addition to our offering. In addition
 to prospective funding in this round groups can future proof their funding capabilities with
 this platform.

RECOMMENDATIONS

That the Community Wellbeing Fund Subcommittee

- 1. Receive the Community Wellbeing Fund Grant allocations report.
- 2. Allocate \$360,000 of grant funding to individuals, groups, marae and charities that meet the CWBF Criteria and Wellbeing outcomes.

BACKGROUND

Funding has come from Department of Internal Affairs through the Better Off Funding package,

Strategy Working Committee approved (SWC2024/41):

- A total grant pool of \$500,000 to be used for the Community Wellbeing Fund.
- Expenditure for marketing and promotions will come from this total.

Grant distributions and Subcommittee expenditure must be made by resolution at a formal meeting.

On May 29th the Community Well Being Fund Subcommittee agreed to a meeting schedule where applications are submitted for review and consideration. The first, 24 July, then 4 September and the final meeting for the year 27, November.

Due to an overwhelming response for the second grant round 4 September, the Subcommittee agreed to cancel the September meeting, extend the application deadline to 18 September, midnight. With the final meeting for the Community Wellbeing fund grant allocations set for October 19 2024.

A total of \$360,000 remains for grant funding allocation.

DISCUSSION

Eligibility and Criteria

As per the CWBF Criteria Report: The Community Wellbeing Fund will benefit a range of community-based projects, this is a fund that individuals can apply to as well as:

- ·Community groups
- ·Marae and Hapori
- ·Primary/Intermediate schools/kura
- ·Secondary schools/Wharekura
- ·Tertiary education providers/Whare Wānanga
- ·Charitable trusts
- ·Incorporated societies

The focus of the fund will be on the South Wairarapa District, however, initiatives that were outside of this locale that have measurable benefit to our communities may be considered at the CWBF Subcommittee's discretion.

To be eligible projects, initiatives or activities must meet one of the following criteria:

- a) Supporting communities to transition to a sustainable & low emissions economy.
- b) Delivery of initiatives that support improvements in community wellbeing.

Applicants must include one or more of the following wellbeing outcomes: Social, economic, cultural and/or environmental.

- Projects that support Māori aspirations with a focus on kaupapa Māori values
- Projects that provide quotes that support local businesses and suppliers
- Projects that benefit more than one audience demographic

Applications received

There is currently \$360,000 in the fund and \$1,180,049 worth of grant applications to be considered at this meeting.

We received a total of 64 applications for project in Featherston, Greytown, Martinborough, Rural South Wairarapa, Coastal South Wairarapa, Carterton and Masterton.

The applications have been collated for the subcommittee to consider in thematic charts; High Priority, Capital Projects, Environmental Projects and Events.

Summary of Applications

The complete applications were circulated in stages to the committee for review. A shortlist created, whereby successful applicants to were able to proceed to the speaking / presentation stage, a summary of the project request with officer's initial recommendations is provided in Appendix B.

High priority applications

We have included a chart that shows applications that meet multiple criteria and have high impact potential on the outcomes they have noted they will deliver on.

Many of these applications also strongly align with Council and Regional Strategies of note including but not limited to:

- Ruamāhanga (Climate Change) Strategy
- Five Towns Trails Master Plan
- Waste Management and Minimisation Plan (WMMP)
- Positively Ageing Strategy
- Rangatahi Youth Strategy & Plan
- Wairarapa Economic Development Strategy
- Regional Food System Strategy

Top Capital Projects

We have included a chart which has collated the capital applications presented to the Community Wellbeing Fund committee.

New Zealand is facing an infrastructure challenge across the nation this extends to community facilities and buildings — as a Council this is all to familiar to us having essentially three assets to service across three town e.g. swimming pools.

In reviewing these applications, the CWBF subcommittee should consider funding for success e.g. no less than 70% or a confidence that other funders will meet any shortfall so that the project can go ahead.

Other considerations for capital projects to discuss include:

The immediate need – is this prevalent; can the community operate in its current state, is their liability in not meeting current building or earthquake standards

Community user - consider how many people use the facility, will an investment support at asset in becoming a multi-purpose facility which in turn enhances operational capability and reduces maintenance for multiple buildings or rooms.

Project management – consider confidence in governance (the decision makers), planning (budgets, fundraising, timelines and communications) and people (has the community endorsed this, are the suppliers and tradesman local and able to deliver the project on time to cost).

Top Environmental Projects

Applications that met strongly focused on criteria a: supporting communities to transition to a sustainable and low emissions economy and had clearly articulated environmental wellbeing outcomes have been included in this chart.

It is important to note only one 'Criteria A' application was funded in the last round however we have received X application to consider.

Key sustainability themes include;

- Water conservation and protection
- Solar projects
- Food security
- Emergency management
- Waste minimisation
- And environmental education projects

Globally environmental projects accrue significant funding, in New Zealand we are far behind on environmental investment. This is likely as outcomes are more difficult to measure as they take time and the level of investment accessible to local authorities, charities, community groups and businesses is extremely limited.

An investment today may not provide immediate outcomes but is worth an investment and consideration for both communities now, and communities in the future.

Top Event Proposals

Included for assessment are a range of community events, some that are new, some that are well established.

The Community Wellbeing Fund subcommittee may wish to conder how these events deliver sustainable 'social, cultural or economic' outcomes. And can these be measures effectively.

In terms of delivery on initiatives that enhance community wellbeing the Subcommittee may wish to consider these bullets in their assessment as the funding requested is significant and almost equal to that of the capital requests.

- Does the event enhance the overall health, happiness, and prosperity of a group of people living in a particular area?
- Does it deliver deep balanced or broad impact to an individual, families or whole communities?
- Does participating in the event as a stakeholder provide rich opportunities that will create a ripple effect to the whole community?
- Does the event celebrate more than one community, have the organisers considered Kaupapa Māori values?
- Will a grant from the CWBF support the event in being sustainable in the future or is it so significant that it creates jobs and enhances SWDC as a destination?

Council offers have included recommendation to consider Council partnership funding for events that provide mutual benefit to multiple stakeholders, this may me considers a component of Regional Economic Development Funding.

DIA responsibilities

There is no longer a requirement for 6 monthly reporting requirements to the DIA. Reporting will now be part of the drawdown process. This report will includes claims and invoices, milestones, projects status, health and safety, risks, forecast and wellbeing outcomes.

Council has spent the 10% pre allocated in the Community Wellbeing Fund and a final drawdown will be made of the remaining \$360,000.

Future Allocations

There will be no future allocations of the fund.

COMPLIANCE SCHEDULE

Full consideration has been given to the provisions of the Local Government Act 2002 S77 in relation to decision making, in particular:

- 1. A Local authority must, in the course of the decision-making process,
- a) Seek to identify all reasonably practicable options for the achievement of the objective of a decision; and
