### **Purpose of Report**

# Appendix 1 – Library Management System – Summary Report

### Background

The current Library Management System (LMS) supplied by NCS (Napier Computer Systems) is reaching the end of its useful life. There are a number of initiatives in the public library environment relating to LMS' which streamline processes, enable more cooperative initiatives between I ibraries and improve the management of library collections. Two of these have been identified by the Wairarapa Library Service as strong contenders for the replacement of the current system. These are the SMART Region system and the National Library's Kotui system.

A report has been prepared for the Wairarapa Library Service (WLS) Committee and this document summarises the key points of that report with the recommendation for Council to consider.

### **Report Summary**

The following summarises the LMS providing a quick overview of the main points. Each system was scored on a 1-5 scale (1=poor; 5=excellent) according to the information available and reflecting the findings of the report.

#### Conclusion

The analysis of both systems uncovered some concerns about the hidden costs in the SMART Region system in relation to the management structure and decision-making processes which potentially could inhibit getting the best value from the system or commit Council to additional costs in human resources and training.

Technical support for the Kotui system is based on the APNK (Aotearoa Peoples Network Kaharoa) which has been operational in the WLS libraries since 2008. There is a very high level of confidence in the service that has been provided by the APNK team. This support has reduced the WLS' dependence on Council IT resources which is likely to be similar with Kotui.

The Kotui system is the result of a major national project co-sponsored by Local Government New Zealand, the National Library of New Zealand, Association of Public Library Managers. Both Carterton and South Wairarapa District Council's contributed to the original project.

#### Recommendation

That the Council's agree to install the National Library based Kotui system, subject to the approval of funds in the Council's LTP, as early as this can be scheduled with the Kotui team. That the RFID implementation be postponed until the new system is in place and more competitive information on costs can be obtained.
