## 1. Background

### 1.1 Water Race Subcommittee

The report relating to recommendation A&S2020/40, is included in the agenda for the Assets and Services (A&S) Committee meeting held 12 August 2020.

Officers undertook to investigate the nature of Moroa Water Race events resulting in an operational callout (e.g. urban vs rural vs stormwater), cost and location and put together some analysis for the Committee. This will provide a basis for a decision to be made on how the current Greytown urban stormwater system should be funded.

A Council decision transfers responsibility for stormwater back to the A&S Committee and will require an amendment to the Water Race Subcommittee terms of reference.

A Council affirmative decision would require Council to attribute urban ratepayers any future budgeted costs for Greytown stormwater investigations and improvements.

#### **1.1.1. Financial Implications**

There are no budgetary implications for this financial year as no additional work is being approved, however in future years urban ratepayers will see an increase in rates relating to stormwater provisions.

#### **1.2 Solid Waste Management and Minimisation Bylaw**

The A&S Committee considered a report on progress towards investigating, developing, implementing and then monitoring and enforcing a consistent bylaw for the eight Wellington region councils.

The Committee noted that officers would seek Council approval to undertake public consultation on the proposed bylaw from Council.

The Wairarapa councils will be undertaking further work on the Wairarapa controls that support the proposed bylaw with the aim of reporting to the October council meetings. The expected consultation timeline is November-December 2020.
