#### A6. Extraordinary business

Cr Plimmer was given leave to supply a verbal report from the Regional Land Transport Committee deliberations and highlighted the following points:

- The Regional Land Transport plan is a 6 yearly plan with a three yearly review and SWDC, CDC and MDC all submitted to the Committee together, however, the issues submitted by the three Councils did not make the top 30.
- Key issue raised: Remutaka hill, and economic impact on agricultural drivers, (i.e. if
  the hill closes there is no way for our produce to get to port).
   This is supported by Porirua, Upper Hutt and Lower Hutt District Councils. Road user
  groups acknowledge the improvements on south side but corners on north side are
  dangerous as trucks cannot pass. This issue is not on the list for the next three years.

Members queried whether SWDC had submitted on the Waihinga Bridge (this was done), whether there are minutes of the forum available to view, links between the Waihinga Bridge and the Remutaka Hill, and prioritisation of issues, roads of significance and Waka Kotahi planning.
