H2. Update on Manganese Removal Plant

Mr Wilson advised that after the Tenders Working Party had reviewed tenders, the project cost could be confirmed at \$200,000 above the estimate and that this figure included a contingency of 5%.

The resolution to proceed with the project detailed how the project would be funded, not the amount.

The Martinborough Infrastructure Reserve Fund was sufficient to cover the increased cost.

Mr Wilson discussed the manganese plant location selection and options considered, plans to investigate alternative water sources, and future operating costs with members.

Council considered the ability to increase the contingency to allow for unforeseen cost overruns, but for good accounting practice agreed to leave the contingency at 5% as per the agreed contract.
