H1. Purchase of Land

Mr Crimp had prepared the report at the request of elected members to enable sufficient information on whether a tender for purchase should be submitted for the Featherston Golf Club land.

Points discussed included:

- That an option to lease the Golf Club land was not presented as it had already been discounted in discussion with the Featherston Golf Club as not feasible due to the increased costs of maintaining a highly fertilised grass course once irrigation of treated wastewater started.
- That due to time constraints only a desktop study of suitability for wastewater irrigation could be completed and that although consultants could start an onsite geotechnical study immediately, they could not provide full analysis of suitability prior to the tender process closing.
- That findings from the desktop study showed that the Golf Club land was suitable, however it was not of the same quality as the north eastern block of the 'Hodder' land. Mr Crimp verbally updated the Council that for every 1ha of land currently designated for Featherston wastewater irrigation, 2.5ha of land would be required at the Featherston Golf Club site. If the land was purchased, some of the existing block would still need to be retained.
- That a separate resource consent would be required to irrigate to the Featherston Golf Club land.
- Removing trees on the Featherston Golf Club land so it was suitable for irrigation and mitigating groundwater bore potable water contamination had not been costed.

Not withstanding the points above, members considered that purchasing the Featherston Golf Club land kept all options open and provided future proofing possibilities with excess land able to be sold at a later date.

Cr Craig left the meeting at 4:01pm.

Cr Craig returned to the meeting at 4:03pm.
