Appointment review

1. Purpose

The purpose of this report is to discuss the current appointments to Regional Committees, forums and working groups that are currently automatically allocated to the mayor.

2. Recommendations

 - c. Wairarapa Safer Communities

3. **Options and discussion**

Council is now halfway through the triennium, and it is an appropriate time to review the automatic

assignment of the mayor to a range of Committees, forums and groups.

It is recommended that these appointments be spread more widely across the elected members for

the remainder of the triennium.

4. **Financial implications**

The remuneration of elected members is set by the Remuneration Authority by legislative

determination. Council is not able to vary these values or add any additional funds to this

remuneration pot without permission from the Remuneration Authority.

5. Implications for Māori

Going forward it is recommended that Cr Maynard is the only elected official sitting on the Māori

Standing Committee.
