#### 7 DECISION REPORTS FROM CHIEF EXECUTIVE AND STAFF

#### 7.1 ADOPTION OF THE WATER SERVICES DELIVERY PLAN

Ms Meerman spoke to the report and provided background, noting that all four Councils are considering plans for adoption also today.

Cr Ellims arrived at 11:22am.

Members acknowledged the work that has been completed over the term to make the best decisions within the framework provided by the Department of Internal Affairs (DIA), noting that many options have been considered throughout the process and work between the four Councils to arrive at the proposed plan as presented today. Member also noted that costs and affordability have been at the core of Council's concerns as plans have been worked through.

Members also highlighted there have been some previous oversights regarding how land for discharging wastewater has been utilised and that requirements for consents have been granted with greater constraints, but there would be a greater focus on this in future.

Members commented on the lack of consideration of affordability from central government and more assistance being needed in this area, the inevitability of water reform, setting up the new Council for success and getting it right for the community.

Members noted the proposed plan is the follow-on work from the Local Water Done Well consultation, alongside the Long Term Plan, completed earlier this year. This proposed plan is the operational arm of those previous decisions made on 25 June (Wai+T model) and the next step toward transition and setting up the new water entity.

Members acknowledged the work of Councillors and Officers involved in the process up to this point.

Members acknowledged the Deputy Mayor's efforts to communicate concerns regarding affordability to central government.

Members highlighted the timeframes and constraints of the work laid out for councils in relation to water reform.

Members queries included: possible changes to the capital works programme; financing; what the decisions from today's meeting will mean for the transition (adopting the plan as it stands provides the best view of how to deliver water services, this commits Council to pick up implementation as it's set out in the report and some assumptions may be reviewed by the new water entity – recognising that a transition is coming); and the capital works programme for wastewater.

Members discussed the financial costs per user – refer to page 30 of the agenda for details.

Members noted that other options were more expensive than what has been proposed in the report.

Members noted there will be oversight of efficiencies and costs that will be conducted by an economic regulator.

Ms Meerman responded to questions regarding the average cost per residential household – noting the information in the report does not necessarily translate into the actual bill that will be received per household – further work will occur on how the new entity will structure charging over the next few years.
