4 Deliberations

Members noted that those organisations that hadn't completed an accountability form for previous funding received would be required to do so as a condition of the grant being paid.

The Featherston Returned Services Association were unable to raise additional funds so had returned the funding allocated to them in a previous funding round.

Members assessed the Youth Grant Applications noting the following:

- Masterton District Council did not fund educational projects.
- The Swim with Sophie funding allocation would be for assistance with a new venture as a one-off contribution.
- The Devine River NZ Trust application was granted partial funds subject to workshops being held in the South Wairarapa.
- Members believed the project had not been correctly scoped or budgeted, with minimal self-funding evident. Greytown Scouts were partially funded with the remaining funds to be obtained through fundraising or other means.
- The Wairarapa Whanau Trust would be required to develop more online/social media media visability, to ensure a youth coordinator was employed, and to ensure a set of financial statements was submitted to SWDC.
- The Wairarapa Youth Orchestra Application was tentatively declined due to projects with greater need.
- Dragonfly would be partially funded on the caveat that they play at a South Wairarapa event.
