Firstly we wish to acknowledge the time and effort that has gone into the draft LTP and also the public presentations. It is not an easy time for both Councillors and Council Staff in juggling the Council purse and ensuring our rating dollars are used to best advantage in the three towns. Congratulations.

We as a Community Board would like to see that works already started are able to be finished in the coming year and also provision made for additional works/amenities that will be of benefit to the Martinborough community as a whole.

- Martinborough Square kerb extensions and pedestrian crossings. To complete the
 work already started in upgrading the kerb extensions at Oxford St and Cambridge
 Rd. Widening the pathway between the flower gardens will give easier access to the
 pedestrian crossings and make it easier for mobility scooter users.
 We would also support the Town Centre (Square Committee) in their submission.
- 2. Oxford Street. The drains and lack of footpaths have been of concern for a number of years. The Community Board would requests further investigation as to what can be done to improve the drainage and provide a footpath from Regent Street through to Todd's Road.
- 3. Priority be given to providing foothpaths along Esther Street and Roberts Street to ensure all streets have one footpath.
- 4. Replacement of the current swings in the Playground funding for this could be provided from the Pain Estate
- 5. Court House. Complete a feasibility study to move this building to the Square alongside the museum, as per the designs in the Square Development Plan. There are a number of uses for this building, once it has been relocated, it would be in keeping with other buildings around the Square.
- 6. Jellicoe Street. As in previous years, we would support the upgrade of the lighting in Jellicoe Street and to put the power lines underground this would bring it in line with Kitchener Street. We realize this is not something that can be done this year but would like to see provision made in the 10 year plan.

- 7. Swimming Baths. Complete a feasibility study regarding costs to upgrade the existing main pool and provision of facilities to heat the pool. The Community Board are currently looking at the level of support/use the pool would receive if it was upgraded this also includes extending opening hours, training lifeguards, having dedicated lap lanes, etc.
- 8. Wairarapa Combined District plan and Building consents. We would like to see all new housing and subdivisions making provision for water tanks to be installed. We know that in the long term water is going to be a precious commodity and if each household had their own water tank, this would at least help to alleviate the pressure on the current supply during the summer months.

Thank you for considering our submission and we would like to discuss this with Council.

The Greytown Community Board recommends that:

- SUBMISSION TO THE ANNUAL PLAN -

To whom it may concern,

During a phone call to Ian Richards on April 14 on another matter, a brief discussion was had about the shelter belt of conifers on the Card Reserve boundary running from the Harrison St corner to the entrance to the Sports stadium in Featherston.

The concern was when the next trimming/topping of the hedgerow might occur.

Subsequent discussion alluded to the possibility of total removal of the row (as it may have outlived its usefulness – a section did snap off in a storm and damage the top railing of the perimeter fence to the turf).

Closely related is the now near non-existent storm water ditch which runs parallel to Underhill Rd from the Sports stadium entrance down to the Harrison St corner.

As the group most affected by these issues we are asking the *Council to make allowance* in the <u>upcoming Annual plan</u> for some expenditure in this area.

Suggested works would include:

- Total removal of the current conifer hedgerow.
- Full piping of the ditch, from the carpark entrance to Harrison St corner.
- Some replacement planting to beautify the area. (perhaps more user-friendly, more appealing, more manageable)
- Re-sealing of the Stadium carpark is also well overdue.

We have raised the issue of the ditch several times in the past. The maintenance of the hedge has occurred semi-regularly, as other Card Reserve perimeter hedgings were tended. The carpark has been swept on one occasion.

Our group feels that the above-listed works would be of great benefit to this area of Card Reserve and we would request that such a course of action be funded in the Annual Plan for the fiscal year July 2012 — June 2013.

Submission on South Wairarapa District Council LTP 2012

Dear Jack

We would like to make the following submissions of the Councils Long Term Plan:

- We support amalgamation with Carterton and Masterton Districts, as long as the Martinborough council offices remain open for public access to regulatory officers (building, plumbing), resource management, land information and bill payments. Moving these services away would make local government inaccessible to businesses, local and rural people.
- We support the Council in providing funding for the Martinborough Town Hall in the LTP this is a very important community asset.
- We support the ongoing funding of Destination Wairarapa.
- Please continue to involve the Business Association in consultation on the
 preparation of Reserves Management & Development Plans (such as the Square
 Management Plan and Town Hall). Well developed and managed community
 facilities are essential to support a vibrant business sector which relies on a healthy
 and happy community and visitors to the area.
- We would support any moves by Council to investigate leasing facilities to
 commercial operators and expanding current shared services with Wairarapa
 Councils to reduce costs. We would also encourage Council to seek opportunities to
 sustainably defer Capital Expenditure until the economic situation improves. We do
 not support deferring capital expenditure where such delays will result in major
 economic impact in the future or will significantly impact on the environment.
- The next District Plan review should be informed by a strategic study into setting aside an industrial/business area either at the end of Nelsons Road or on the Pain Estate (or such other area that might be identified). This would make it easier for new businesses to start up in Martinborough. We strongly support a plan change being initiated prior to the next District Plan review to make provision for an industrial/business area.
- We appreciate the support Council provides for events. We would like to see the Square become the central hub for events so that visitors are kept in town longer. We have submitted on the Square Management Plan to this effect.

- In relation of the Wastewater Disposal Policy clause 3.1.9 as notified with the South Wairarapa District Council's Draft Long Term Plan 2012/2022, we request the Council provide greater clarity in the policy so that there is greater certainty as to costs and liability for landowners. There are some signficant equity and financial implications of transferring ownership of sewer laterals to private landowers. Firstly, without knowing the state of the pipes being transferred, householders do not know if they are taking ownership of a major existing problem. If those existing problems have been caused by others, landowners should not be responsible for rectifying those historic problems. Secondly, landowners should not be responsible for rectifying future damage to laterals caused by third parties (including the Council). If the laterals are to be owned by individual landowners, we request that the Council provide a clear statement in the proposed policy setting out the circumstances in which the Council or another third party will be responsible for all costs associated with repairing or replaceing pipes that have been damaged by parties other than the lateral owner. At present, the proposed policy does not set this out. We recommend that the Council takes legal advice as to whether Section 461 of the Local Government Act 1974 applies should the Council or one of its agents cause damage to laterals within the road reserve. If s461 does apply to the Council then it may not be necessary to include an equivilent clause in the Policy.
- We consider that the current policy related to the Sewage Disposal Rate for Serviced Connections needs to be reviewed particularly in relation to properties with multiple toilet pans because this flat charge system does not reflect actual use of wastewater services. Larger properties and in particular, accommodation providers are cross subsidising other users of the system by paying excessive charges.

Thanks for the opportunity to submit. We do wish to be heard, but I cannot make the 18-20 June. We will provide someone to speak to our submission.

Rates

We would support any moves by Council to investigate leasing facilities to commercial operators and expanding current shared services with Wairarapa Councils to reduce costs. We would also encourage Council to seek opportunities to defer Capital Expenditure until the economic situation improves.

Shared Services

We support the continued development of shared services, where cost savings can be achieved without prejudice to South Wairarapa residents. We support a review of the possibility of amalgamation with neighbouring local authorities but believe that any such decision should be subject to a referendum.

Rest Area on SH53

This Rest Area on SH53 on the way into Martinborough should be closed. If people need to stop for a rest, we would prefer that they did it in town where there are plenty of cafes and shops. The rest area is an eyesore and a repository for rubbish dumping for people staying down the coast; it is also used for inappropriate freedom camping from time to time.

Notable Trees on Considine Park (Holiday Park and pool area)

swimming pool complex. The storm water needs to be drained into the drain on Dublin Street West. At the

moment the storm water is draining onto our property and despite having raised this, it still hasn't been fixed.

We have considerable problems with surface drainage, exasperated by the additional water from the pool

complex. We have asked the council officer to do this and it has been approved, but it has not been done. We

would prefer the storm water runoff from the pool was drained into the open drain on Dublin St West – this

had been approved in a previous Annual Plan process.

We would like to continue to be consulted on changes to the freedom camping rules and facilities wherever

possible.

SUBMISSION TO SOUTH WAIRARAPA DISTRICT COUNCIL ON THE LONG-TERM PLAN 2012-22

Introduction

Federated Farmers of New Zealand is a member-based organisation which represents farming, farming communities and other rural businesses. We welcome the opportunity to comment on South Wairarapa District Council's Proposed Long-term Plan, particularly as it relates to rural ratepayers.

We acknowledge any submissions made by individual members.

General

Federated Farmers thanks Council for the opportunity to meet informally earlier in the year. Our discussions then highlighted water and roads as key issues for the farming community and we highlight these again below.

Revenue and Financing Policy

Federated Farmers note that Council indicates (pg 3) that it has undertaken a review of its Funding Policy, and proposes to remain with the current land-based system rather than move to a capital based system. The principal reason presented (pg 127) is that the ratio of land to capital value was inconsistent across the district, and this would lead to more ratepayers having increases, than decreases, in rates payable.

In the coming year Council intend to complete the review of the Revenue and Financing Policy (pg 42). Federated Farmers strongly recommend that full details of the assessment of benefits and costs for rural and urban ratepayers, and the mix of rating instruments (land or capital value, and use of the UAGC) be tabled to enable proper discussion prior to this review being completed.

Rates Limit

In the coming ten years, Council proposes (pg 37) to cap overall rates increases at the BERL cost index (forecasting increases of 3%+ each year) plus 2%. Federated Farmers support Council's "no frills" focus, and urge Council to constrain spending within the BERL index if possible, for example, through pursuing options for shared service delivery.

Rating Impact

Federated Farmers commend Council on the presentation (pg 34) of a table illustrating what you get for your rates – urban, commercial and rural. Even more useful is the table (pg 35) which illustrates the levy per week for each service of council. This table is presented only for urban ratepayers: Federated Farmers recommend a similar table be presented for rural ratepayers.

Governance

We note that Council are currently participating in investigations into shared services and future governance structures. Federated Farmers, Wairarapa Province, endorse these investigations and

emphasise the importance of delivering efficiencies for ratepayers across core services and infrastructure.

Water and Wastewater

All facets of water feature highly across the LTP – urban supply, Longwood and Moroa water races, urban stormwater (and the link to the Moroa water race), urban waste water, and reference (pg 12) to a review by GWRC of the Lower Valley Development Scheme. The opportunity for strategic alignment with other councils and the water storage project is clear; and Federated Farmers recommend that planning for water and waste water services be undertaken in conjunction with similar reviews underway by Masterton and South Wairarapa District Councils, and in consultation with the Wairarapa Storage project.

Roading

Federated Farmers acknowledge the scale of the road network (pg 30) and difficulties arising from removal of the NZTA seal extension subsidy (pg 31).

Having said that, the importance of regular maintenance of gravel roads was highlighted at our meeting earlier this year (with a suggestion that a bit extra could perhaps go a long way), and we emphasise this point again. In the coming year Council propose (pg 65) to review and complete the Roads Asset Management Plan: Federated Farmers recommend that specific consideration be given to the ongoing maintenance requirements of gravel roads in the district.

Regional Amenities Fund

Federated Farmers does not support the proposal for Council to contribute to a Regional Amenities Fund.

Resource Management

Federated Farmers note (pg 54) that Council propose a project in the coming year to protect and enhance significant indigenous flora and fauna with stakeholders; and record our interest in further details at an appropriate time.

Conclusion

Federated Farmers, Wairarapa Province, request that full details of the proposed rating policy including assessments of differential benefits and impacts across rural and urban ratepayers be provided prior to final decisions on the Revenue and Financing Policy.

We emphasise the importance of ongoing maintenance of the Districts gravel road network.

We support the investigations into shared services and assessment of governance structures; and recommend specific collaboration around water and waste water projects.

We wish to be heard in support of this submission.

Submission to SWDC Re: Martinborough Public Swimming Pool June 2012

We believe that it is worth spending money to upgrade and beautify the Town Pools to increase patronage.

Martinborough's geographic location - so far from any good beaches - means public swimming pool facilities should be a Council priority and be well used. Although there is a river nearby, flow and water quality is variable and it is not safe for small children.

With the vastly increased visitor numbers to the town over the years–especially over the holiday period and on weekends, it is logical to have good pool facilities. Unfortunately the Martinborough Pool does not meet the need at present, the pools are unattractive and uninviting.

However, it would be relatively quick and inexpensive to make the pool much more attractive by incorporating the grassy, treed area between the pool and Princess St into the pool surrounds with extensions to this area added in time. Better shade trees could be planted and this would encourage local and visiting families to come and picnic there as they do in many other pool complexes in New Zealand and around the world. (Waikanae is a good example). A small slide would be popular.

If funds allow in the future, it would be good to cover the pool to increase usage on cooler, windy days with the ability to open up the sides or at least one end on hot days.

Community fundraising could be stimulated if suitable, appealing plans were proposed.

Many children are not getting enough exercise today and with obesity as an increasing health problem in adults, encouraging swimming from a young age can only be beneficial.

In the past we have circulated photos of successful existing pools with lawn and shade trees in the hope of encouraging the Community Board and Council to make the pool environment more appealing.

Martinborough is fortunate to have adjacent land to achieve this easily.

The 2012 Festival



The Festival continues to attract audiences in the 15-24 age group through targeted programming, marketing and pricing. The audiences in the regions also reflect this trend.

Income

With the support of sponsors, regional partners and a dedicated audience, the Festival continues to be a financially sustainable organisation in a challenging economic environment. The overall cost of staging the Festival is \$12.7 million.

The festival's income is generated from:

- 37% box office
- 38% sponsorship, grants, patrons
- 9% Wellington City Council
- 12% government agencies
- 4% other earned income

The box office and sponsorship are our main sources of income – but it would be impossible to stage the Festival relying on only box office and sponsorship. We need to ensure that the level of funding and commitment continues.

Building on the success of the 2012 Festival, the 2014 New Zealand International Arts Festival aims to be surprising, entertaining and thought-provoking.

Introduction

This submission provides information on the public health implications of council long term planning decisions. Council makes many decisions that influence health and wellbeing. For some issues, the link is direct and immediate: decisions around water quality influence enteric disease levels, decisions around community services influence people's immediate access to social structures needed for healthy living. For other issues, links are less direct and immediate but the long term impacts are cumulative and intergenerational (e.g. urban form can influence physical inactivity and poor diet and associated diseases, road traffic injuries, respiratory disease and cardiac conditions and social isolation¹). The figure below illustrates the determinants of wellbeing in our neighbourhoods and shows that council decision-making influences most aspects.

Better Local Government

In March 2012 central government signalled the intention to revise the Local Government Act 2002. In particular the intention to replace the 'four wellbeings' with what the government considers to be a more pragmatic view of the purpose of local government: to provide local infrastructure, to deliver local public services and to provide local regulatory functions.

The presence of the four wellbeings in the current legislation helps to cement the notion that public health is one of the key functions of local government at both regional and territorial levels. The replacement of the four wellbeings does not mean that local government's public health role disappears or becomes less obvious. RPH is developing a diagram (see draft diagram in Appendix three) to illustrate that the very important public health role of local government remains and may even be better clarified in the new pragmatic view of the purpose of local government.

We acknowledge that financial pressures and local government reform create significant challenges for local authorities. Targeted investment to address inequities and support more vulnerable populations will achieve improved outcomes for communities.

Healthy and socially connected neighbourhoods are more resilient to external events and pressures. Christchurch has demonstrated the importance of communities working together in response to major events. Community resilience incorporates both built infrastructure and the connectedness of our neighbourhoods.

Large differences in social needs and wellbeing have a negative flow on effect to the economic success of the whole community. Places with greater social and economic equity have far fewer social problems than those that are inequitable. These include better mental health, less drug use, better physical health and greater life expectancy, less obesity, better educational outcomes, fewer unplanned teenage pregnancies, less violence, less imprisonment, much stronger communities and positive social relationships. ³

Communities continue to feel the effects of the economic recession as well as the impact of widening inequities. A recent study⁴ found that ethnic and income inequalities in infectious diseases such as rheumatic fever, skin infections, respiratory and gastrointestinal infections are large and increasing, especially for Maori and Pacific populations who are over represented in the poorest areas. Council, working with vulnerable communities and other agencies, can increase community resiliency, build local identity, and help communities find innovative solutions to local issues.

Major gains to health and wellbeing can be made in South Wairarapa by:

- Placing children and youth in the centre of all policies and their implementation
- Prioritising actions to reduce health inequities between Maori and Pacifica, and other New Zealanders
- Working in partnership with central government and community agencies to improve local infrastructure and public services
- Acknowledging alcohol and tobacco as two major contributors to avoidable premature deaths, ill health and injury, and targeting actions to minimise exposure to these contributors.

Improving community wellbeing for least possible cost

We **recommend** that changes to levels of services, fees or charges are examined for their potential impacts on vulnerable populations such as children and young people, Māori and Pacific, and people on low incomes. There are simple tools that can support Council decision making around this.⁵

We **recommend** that Council lead efforts to integrate local, central government and community activity. This will help Council in providing efficient local government, quality public services and local infrastructure, and will contribute to community outcomes.

Economic growth is necessary to support the work of Local Government. This growth is dependent on building strong and resilient communities.

South Wairarapa District Council is a substantial owner of core local infrastructure such as water (drinking water, waste water and storm water) and solid waste services, local roads, parks and play spaces, as well as libraries, and other community social and recreational facilities. These require ongoing investment and commitment for future generations.

Pressure to cut costs and reduce debt can risk the quality of our social and built environment. It is important that the impact is not greater for our vulnerable communities and that there is no increase in health and social inequalities. For instance, reducing swimming pool opening hours and/or increasing charges will have a greater impact on people with low incomes, who often have higher 'access' needs and fewer alternative choices.

Council also has the ability to set fees and charges across a range of services. Fee changes should be considered for their potential impact on health and wellbeing, inequalities, and the environment. Council can also influence the location of gambling, alcohol and fast food outlets. These decisions provide an opportunity for community input into the shape of their neighbourhoods.

The current economic environment and the combination of central and local funding and activity in South Wairarapa is significant. This underscores the importance of ongoing commitment to collaborative work, for example, South Wairarapa Safer Community Council and Road Safety Council initiatives.

Alcohol and Tobacco

RPH **recommends** that alcohol and tobacco issues are clearly addressed within Council Long Term Plans, as part of delivering improvements to quality of life. Actions that Council can take are not necessarily high cost.

A recent study on the health and economic benefits of addressing potentially modifiable disease risk factors suggested that alcohol and tobacco use impose the greatest cost on the economy, when compared to other preventable risk factors such as physical activity, intimate partner violence etc. The study also highlighted the substantial costs that alcohol and tobacco impose on the health sector and on families and individuals.⁶

The Alcohol Reform Bill⁷ that is currently in front of Parliament will give communities more say in how alcohol is made available in their local area. The key mechanism for this will be the development of Local Alcohol Policies by Territorial Authorities. Although Local Alcohol Policies are not mandatory we are encouraging all Territorial

Authorities to develop their own policy. The Bill sets out the process to be used to develop the policy including using the special consultative procedure. The process will enable communities to participate in a dialogue about change in family and community values and attitudes around alcohol and its use. This is an important step toward changing society norms and tolerance. As such adequate time and resources will need to be committed to ensure the success of the process and to build upon the existing Liquor Licensing Policies, Bylaws, and draft Wairarapa Alcohol Harm Reduction Strategy.

Young people and children

RPH **recommends** that children's' rights and wellbeing are placed at the centre of decision making for South Wairarapa District Council.

The government goal⁸ that every child thrives, belongs and achieves requires a fundamental shift in the way children are considered in New Zealand society. The environment has an enduring impact on children and on the success of current and future communities in South Wairarapa. Investing in our children has significant long term payback. Council activity strongly influences the wellbeing of children including:

- · density of fast food outlets/access to healthy food
- density and location of alcohol outlets and gambling venues
- quality and location of parks, playgrounds and recreational facilities
- libraries and other community facilities
- speed limits and the pedestrian/cycle environment
- urban layout and types of uses allowed

Councils can demonstrate the importance of children by ensuring all council activity and decision making has as its primary rationale the rights and needs of children. Child rights in New Zealand are recognised in the United Nations Convention on the Rights of the Child (UNCROC) adopted by the United Nations General Assembly in 1989⁹ and ratified by New Zealand in 1993.¹⁰ The declaration, applicable to everyone under 18 years of age, states that the best interests of the child should be a primary consideration.

A child focused approach, combined with increased integration of activities in Council and across sectors e.g. housing quality and supply, education, public transport, health services, police, non-government and community, can improve child health outcomes, combat child poverty, reduce inequalities as well as help South Wairarapa to respond to global and local issues such as climate change and economic recession.

Community Outcomes

Healthy & Economically secure people - Pg 16

Smokefree

New Zealand has made good progress in tobacco control in recent years with smoking prevalence and youth initiation falling, but continued effort is required to reduce the extremely high level of harm and health system costs caused by smoking¹¹.

Each day our children visit recreation areas to use the play equipment, participate in team sports or just be outside with their family and friends. When children see adults smoking in a family-friendly place, it 'normalises' smoking and creates negative role models. Councils can play a key role in the health of the community.

In 2011 the Government announced that they accepted the aspirational goal of being a Smokefree Nation by 2025. It is possible that South Wairarapa could be a leading role model exemplar in New Zealand with 'Smokefree-Auahi Kore Townships'. This stance will provide a positive shift in the community as a future without tobacco becomes reality. As a local Council you are in a unique position to provide leadership and innovation for your community and play a vital role in providing supportive environments for people to quit smoking.

Smokefree signage

Good signage is the key to a successfully functioning smokefree playgrounds and sports grounds policy. Clear, visible and attractive signage helps remind people as to the smokefree policy that exists. Signage also provides a tool for members of the community to point to when asking smokers to stop smoking in a non judgmental and non threatening way.

Smokefree outdoor public places are about protecting children and providing them with smokefree role-modelling and empowering communities, not about punishing smokers or telling people what to do. It is not about whether or not people smoke, but about where they smoke. The signs we have encouraged other Councils to use are not negative about smokers, but rather promote positive smokefree messages by polite request.

We acknowledge that there is smokefree signage displayed in certain areas within South Wairarapa, but not all Council owned areas have signage displayed. Currently, signage at parks, playgrounds and sports grounds is in some cases not highly visible, or there are no signs at all. For example rugby grounds have little or no signage; there is no signage at the skate park in Featherston; and no signage at Kuratawhiti Park in Greytown (see appendix one for photographic examples). There is also no consistency with the signage used.

The Smokefree Network has signage that we would like to have displayed by all Councils within Wairarapa. A sample of what these signs look like is found in appendix two.

Like all other signs, general maintenance is required to replace signs as they become old and worn. We would like Council to commit to erecting and maintaining the smokefree signs as a part of the general maintenance services.

Children in vehicles

RPH **recommends** that Council encourage adults to drive smokefree vehicles when children are being transported within the South Wairarapa District. This measure is directly related to reducing the harm caused by second-hand smoke exposure.

Smokefree-Auahi Kore spaces

We acknowledge that South Wairarapa District Council has a smokefree environment policy that covers Council playgrounds and swimming pools. We ask that Council consider extending the current settings of Smokefree-Auahi Kore spaces as follows:

- Parks/Reserves: A policy that designates <u>all</u> parks and reserves as Smokefree-Auahi Kore.
- **Rivers:** Include rivers as a new setting to extend smokefree spaces. Reducing the level of disposed cigarette butts will particularly improve watercourses and downstream coastlines (beaches).
- Alfresco dining spaces: Consider outdoor dining spaces becoming smokefree. Increasingly non-smokers who seek outside places to dine are now questioning why they must dine with second-hand smoke impacting on both their dining experience and health.
- Events: Designate all Council sponsored events/activities as Smokefree-Auahi Kore.

Smokefree-Auahi Kore South Wairarapa District Council

RPH is able to:

- support South Wairarapa District Council to achieve being a Smokefree-Auahi Kore District by 2025
- assist Council employees to quit smoking
- provide advice and policy support
- provide Smokefree-Auahi Kore signage

RPH recommends that the Council:

- expand the smokefree areas to all recreational zones including parks, swimming pools and sports fields.
- erect the recommended smokefree signage around recreational zones including playgrounds, and sports fields to indicate that these are designated smokefree areas.
- commit to the maintenance of signs as a part of the Council's general maintenance services.

Key Project – Water Supply – Pg 21

RPH **supports** the proposed water infrastructure developments to upgrade Featherston water supply and Greytown Bore supply to achieve compliance with the New Zealand Drinking Water Standards 2008.

RPH **recommends** that the LTP considers greater reference to the complementary measures of water use conservation and efficiency, in addition to water meters as described on page 31.

Public Protection - Pg 45

Retailer Licensing

RPH **recommends** that the Council investigate instituting, through a by-law, the power to control the number and location of tobacco retailers, as a means to reduce the exposure of children and young people to tobacco products. This is particularly relevant in areas of high-deprivation and close to schools. South Wairarapa could use a similar structure to the current well established liquor retail licensing system.

Water Supply - Pg 69 - 72

Oral Health and Fluoridation

Teeth and gum disease are common health problems and most are preventable. While everyone is potentially susceptible to dental decay, children are particularly at risk. For children oral health has implications beyond additional fillings. Poor dental health causes pain and discomfort and can impact on children's dietary intake and therefore their physical and cognitive development. Evidence shows that water fluoridation is effective throughout a person's life time, preventing root caries in adults and older people, so that fluoride can be seen to be of benefit to anyone with their natural teeth, not just children 12,13,14,15,16,17.

Like several other public health strategies, such as immunisation, a vocal minority of people question the benefit of, and raise concerns about, the risk of water fluoridation. RPH recognises that the addition of fluoride to water supplies is an issue for debate and decision by the relevant territorial authorities in conjunction with their communities, which includes the Wairarapa DHB.

It is important to note that the practice of fluoridating community water supplies is strongly supported by the Ministry of Health, Wairarapa DHB and RPH.

A National Perspective on Fluoridation

A New Zealand survey¹⁸ showed that fluoridation protected 5 year olds in lower socio-economic groups from more decay than it did for those in high socio-economic groups.

At a population level, it is estimated that water fluoridation prevents between 58,000 and 267, 000 decayed, missing or filled teeth in New Zealand per year¹⁹. Based on current levels of 50 percent of the population receiving fluoridated water, it is estimated that the annual cost savings are up to \$14.3 million²⁰.

New Zealand research has demonstrated a net economic benefit for fluoridating community water supplies with populations of 1000 people or more²¹.

An International Perspective on Fluoridation

According to the Centre for Disease Control, Atlanta, USA (CDC)²², community water fluoridation is one of the ten GREAT public health achievements of the 20th century:

"Water fluoridation remains the most equitable and cost effective method of delivering fluoride to all members of most communities, regardless of age, educational attainment, or income level".

RPH **recommends** that Council explore the feasibility of fluoridating the South Wairarapa community water supplies as per the New Zealand research demonstrating a net economic benefit with populations over 1000 people.




