Callouts and Customer Service

As part of a drive to provide a better customer service to those with solid waste issues, Council diverts all incoming daytime queries direct to our contractor Earthcare. Having subsequently reviewed the customer service reports from Earthcare all the indicators show that the new system is providing faster and more accurate service to our customers.

Council has also moved to using City Care Ltd as our afterhours call centre. The centre is based in Christchurch and manages all calls to council that are made outside normal working hours. The transition to this system has been successful and there were no apparent concerns arising from the call centre's management of our recent flooding and road closure events.

Cape Palliser Road/Kupe Sail

The storm over 27-28 July resulted in emergency works requiring immediate repairs to the boulder beaches at Te Kopi on the Cape Palliser Rd. The repair work at Kupe's Sail which commenced in the week beginning 12 August 2013 was classified as a permanent repair rather than the temporary repair solution that was initially proposed. Kupe Sail officially reopened to normal traffic on Friday 20 September 2013.

Refuse & Recycling in Featherston

It seems that refuse and recycling days are an invitation for it to get windy. We ask that residents make a judgement call that if it is too windy to avoid putting out recycling or ensure it is secure to avoid littering or losing bins. To assist with this Earthcare has arranged for the recycling truck to follow closely behind the refuse truck in an effort to remove the opportunity for the recycling to take flight.



About the new

The supply and sale of alcohol has been the subject of community concerns from time to time. In 2012 significant changes to the previous regime for deciding who could sell liquor and from where were made by the Government.

To assist our community to understand these changes and how they affect both what Council does and how citizens can engage in licencing processes, a brochure has been prepared. This brochure is available from Council.

Often asked questions – what types of Licences can be applied for?

- On Licence allows sale for consumption on site
- Off Licence allows sale for consumption off site
- Club Licence allows sale for consumption by members, guests on site at a club
- Special Licencee allows sale for consumption at special events.

On the Dog Front

Well done to the 97% of dog owners who have registered their dogs for the 2013/14 year. Microchipping of dogs is also an important part of dog ownership. All dogs registered in NZ for the first time from 1 July 2006, except working dogs, need to be microchipped. Microchipping is a simple, lifelong way of identifying dogs and linking them to their owner. If your dog gets lost this is a simple and effective way for you and your dog to be reunited.

NEW Off leash Dog exercise area for Greytown

Greytown should be getting their long awaited off leash dog park soon. Planning is well under way for the new off leash dog exercise area to be located at the end of Cotter Street Greytown. Council is working jointly with the Greytown Lions Club on this project to provide a fully fenced exercise area. Watch this space.

Dog Control Policy and Bylaw 2013.

The recently adopted Bylaw and Policy are now operative. Some of the key changes are that they

- Amend the dog control fees by removing the approved and general owner categories.
- Provide clear policy about dog exercise areas.
- Amend the classification of menacing dogs by dog breeds or type of dog to align with the Dog Control Act.
- Change to the wording to neutering and disability assist dogs to align with the Dog Control Act.
- Update Schedule A (Areas where Dogs are prohibited) and Schedule B (Dog Exercise areas).
- Provide the ability for Council to make changes by resolution to the schedules.

Allow for dogs taking part in an organized event (which has council approval) such as a dog show to be an area where dogs are prohibited or where dogs must be on a leash.

Bag a Bargain: And last but not least, an opportunity to bag a bargain. You can now buy specially designed poo bag dispensers that attach to your dog's leash. The dispenser includes 13 biodegradable "ezebags" so you can clean up after your dog when you are out and about. The dispenser is only \$4 and is available at the Council office and service centres.

Sale and Supply of Alcohol Act

Do I have a say?

Members of the public can make objections to applications for new and renewal of licences. If you object you need to show that you have a greater interest than an ordinary member of the public. This could mean you live nearby a proposed outlet. You cannot object simply because you oppose the idea of the sale of liquor generally.

How and when can I object?

An objection has to be written and submitted to the local district Licencing Agency where the application was lodged within 15 working days after the first public notice is placed in the newspaper.

It must identify the particular application (the proposed premises), give your reasons for objecting, be signed and provide your name, address and contact details.

An objector can attend and speak in support of their objection at the hearing of the application.

What can I object to?

There are specific criteria listed in the Act and anyone intending to lodge a submission should obtain more details. However in general terms an objection can cover the suitability of the applicant, hours of operation, design and layout of premises, other goods for sale onsite, other services onsite, amenity and good order in the neighbourhood and the systems, staff and training required. If the application is for a renewal a further matter is included which covers the manner in which alcohol has been sold, displayed, advertised or promoted by the licencee previously.

Rebates 2013/14

The Rates Rebate Scheme provides a rebate of up to \$595 for low income earners who were paying rates for the home in which they were living on 1 July 2013.

- Your rebate will be calculated based on your Income, from 1 April 2012 to 31 March 2013, rates and the number of dependants. The income eligibility for a rebate is \$23,870
- However if your income exceeds this amount you could still be entitled to a rebate depending on the total cost of your rates and number of dependants. You must provide proof of income from your income provider for ALL forms of income, including interest & dividends.
- Application forms are available from the Featherston and Greytown Libraries as well as the Council office.

Would you prefer to receive your rate demand by email?

We now have the facility to send rate demands by email. If you wish to receive your rate demand by email please email rates@swdc.govt.nz, and we will add your details to our database.

We encourage you to take up this option, some local authorities have up to 20% of rate demands delivered by email and at 70c per envelope the savings are considerable and of benefit to all.

Direct Debit is the cheapest way to pay your rates as we withdraw the funds directly from your bank account at the very last minute. That way you get the benefit of your funds for the longest possible time.

If you have not had the opportunity to do so but would like to pay by Direct Debit please complete and return that form to us. If you have not kept the form we sent, just contact us by phone or email/post or drop in to one of our service centres to arrange to complete the required form.

We are very pleased with the response to our last notice about paying by Direct Debit with 200 additional ratepayers signed up. Our thanks to all those who pay by this method as administratively it is easier for us and means you not having to stress about paying on time.
