



**Subject: Request for Waiver of Requirement to Apply for New Manager's Certificate**

Dear Chairperson/Committee,

I am writing to request that the District Licensing Committee exercise its discretion under Section 208 of the Sale and Supply of Alcohol Act 2012 to waive the requirement for me to apply for a new Manager's Certificate.

I acknowledge that I did not submit my application for renewal on the due date.

My understanding at the time was that the due date was the final day for submitting my application, and as such, I believed I was within the prescribed timeframe. This was an error on my part, and I did not willfully fail to comply with the requirements of the Act.

Section 208 provides that where a person has neglected or omitted to do any act or thing within the precise time prescribed, the licensing authority or committee may waive the omission if satisfied that it was not wilful. I respectfully submit that my omission was the result of a genuine misunderstanding, and therefore request that the Committee grant a waiver on this basis.
