OFF-LICENCE

Sections 17 to 20 and Section 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 Canoe Wines Limited Partnership is authorised to sell or deliver alcohol on or from the premises situated at 66 Kitchener Street, Martinborough, and known as "Nga Waka", to any person for consumption off the premises and to supply complimentary samples of alcohol on the premises.

- No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine, or fruit, or vegetable wine made: C.
 - on the premises; or
 - from grapes or fruit harvested from land on which the premises are situated.
- Drinking water is to be freely available to customers while alcohol is being supplied free as a sample, from the location at which the sampling d. occurs.
- A properly appointed certified manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must f display:
 - At each principal entrance to the premises, the ordinary operating hours during which the sale of alcohol is permitted.
 - A copy of the licence and all conditions subject to which it is issued, to the inside of the premises so to be easily read by all people entering at each principal entrance.
 - At every point of sale for alcohol, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.

Remote Sales

- The licensee must take reasonable steps to verify that the buyer and the receiver of an alcohol delivery is not under 18 years of age, and that the n. receiver (where present), is not intoxicated. Alcohol purchases must be signed for by someone who is aged 18 years or older. In order to take the delivery, valid and current identification must be shown to the person/s delivering the goods.

 - Full name

 - Photo, and
 - Signature
- The licensee must display on its website and/or catalogues and on every receipt issued for alcohol sold remotely:
 - The licence holder's name and licence number
 - The date on which the licence expires

DECISION

This is an application Canoe Wines Limited Partnership for a renewal off-licence in respect of premises situated at 66 Kitchener Street, Martinborough, known as "Nga Waka".

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act and we grant the applicant a renewal off-licence authorising the sale and supply of liquor for consumption off the premises with the following conditions 1 - 15.

1. Alcohol may be sold on, or delivered from the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday to Sunday 9:00am to 6:00pm

- No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1:00 pm on ANZAC Day.
- 3. No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine, or fruit, or vegetable wine made:
 - a. on the premises; or
 - b. from grapes or fruit harvested from land on which the premises are situated.
- 4. Drinking water is to be freely available to customers while alcohol is being supplied free as a sample, from the location at which the sampling occurs.
- 5. A properly appointed certified manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
