**DECISION**

This is an application by **Wild Honey Art Limited** for an off-licence in respect of premises situated at 124B Woodside Road, Greytown, known as "**Wild Honey Art**".

The application is in respect of premises in which the principal business is remote sales of wine and beer as part of a gift basket.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, I deal with the matter on the papers.

I am satisfied as to the matters to which I must have regard as set out in s.105 of the Act and I grant the applicant an off-licence pursuant to s.17. The remote sales endorsement is pursuant to s.40 of the Act and applies to this licence; and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

**CONDITIONS OF LICENCE**

1. A remote sale of alcohol may be made at any time on any day.
2. The holder of this licence must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11.00 pm on any day or before 6.00 am on the next day.
3. No alcohol is to be delivered from the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day.
4. The holder of this licence must take reasonable steps to verify that the buyer of any alcohol that the holder sells by remote sale (and, if a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age.

**THE LICENSED PREMISES**

The premises, situated at 124B Woodside Road, Greytown are more precisely identified in a plan date stamped as received by the South Wairarapa District Licensing Committee on 6<sup>th</sup> June 2015.

**OFF-LICENCE**

Sections 17 to 20 and Section 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 **Wild Honey Art Limited** is authorised to sell or deliver alcohol on or from the premises situated at **124B Woodside Road, Greytown**, and known as "**Wild Honey Art**", to any person for consumption off the premises and to supply complimentary samples of alcohol on the premises. The remote sales endorsement is pursuant to s.40 of the Act and applies to this licence; and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

**Principal Business:**

The general nature of the premises is remote sales of wine and beer as part of a gift basket..

**RECOMMENDED CONDITIONS OF LICENCE**

1. A remote sale of alcohol may be made at any time on any day.
2. The holder of this licence must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11.00 pm on any day or before 6.00 am on the next day.
3. No alcohol is to be delivered from the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day.

**DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S**


A copy of this licence must be displayed at the principal entrance to the premises. The entrance from **124B Woodside Road, Greytown**, is designated as the principal entrance.

- (c) If the licence is renewed, until the close of the period for which it is renewed.
