DECISION

This is an application Hygge Limited for a renewal off-licence in respect of premises situated at 139 Todds Road, Martinborough, known as "Stonecutter Vineyard".

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly I deal with the matter on the papers.

I am satisfied as to the matters to which I must have regard as set out in s.131 of the Act and I grant the applicant a renewal off-licence authorising the sale and supply of liquor for consumption off the premises.

RECOMMENDED CONDITIONS OF LICENCE

The licence is subject to the following conditions

1. Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 10:00 am to 5:00 pm

2. No alcohol is to be sold or delivered on Good Friday, Christmas Day, or before 1 pm on Anzac Day.
3. No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made—
 - (i) on the premises; or
 - (ii) from grapes or fruit harvested from land on which the premises are situated.
4. Drinking water is to be freely available to customers while alcohol is being supplied free as a sample.
5. The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.

Remote sales

6. A remote sale of alcohol may be made at any time on any day.
7. No alcohol is to be delivered from the premises on Good Friday, or Christmas Day, or before 1.00 pm on Anzac Day.
8. No alcohol is to be delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made—


9. (i) on the premises; or
10. (ii) from grapes or fruit harvested from land on which the premises are situated.
11. The licensee must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11.00 pm on any day or before 6.00 am on the next day.
12. Condition 9 applies whether the alcohol is delivered by the seller or by some other person.
13. The licensee must take reasonable steps to verify that the buyer of any alcohol that the holder sells by remote sale (and, if a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age.
14. The licensee complies with condition 11 if they comply with a procedure declared by regulation made under the Sale and Supply of Alcohol Act 2012 to be a reasonable procedure for that purpose.
15. The licensee when selling alcohol by remote sale via the Internet must comply with any regulations made under the Sale and Supply of Alcohol Act 2012 requiring information to be visible on the holder's website when people browse, enter, or otherwise access it.
16. The licensee when selling alcohol by remote sale by mail order must comply with any regulations made under the Sale and Supply of Alcohol Act 2012 requiring information to be published in the holder's catalogues.
17. The licensee when selling alcohol by remote sale by telephone must comply with any regulations made under the Sale and Supply of Alcohol Act 2012 requiring information to be given to callers.

The conditions sought are consistent with the style of off-licence with remote sales, endorsed under s 40.

OFF-LICENCE

Sections 17 to 20 and Section 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 **Hygge Limited** is authorised to sell or deliver alcohol on or from the premises situated at **139 Todd's Road, Martinborough**, and known as "**Stonecutter Vineyard**", to any person for consumption off the premises and to supply complimentary samples of alcohol on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS OF LICENCE

The licence is subject to the following conditions

1. Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 10:00 am to 5:00 pm

2. No alcohol is to be sold or delivered on Good Friday, Christmas Day, or before 1 pm on Anzac Day.
3. No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made—
 - (i) on the premises; or
 - (ii) from grapes or fruit harvested from land on which the premises are situated.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S


A copy of this licence must be displayed at the principal entrance to the premises. The entrance from **139 Todds Road, Martinborough**, is designated as the principal entrance.
