DECISION

This is an application **Grava Wines Limited** for a renewal off-licence in respect of premises situated at **815 Lake Ferry Road, Martinborough**, known as **Grava Wines Limited**.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act and we grant the applicant a renewal off-licence authorising the sale and supply of liquor for consumption off the premises.

CONDITIONS

ENDORSEMENT: Section 40 of the Sale and Supply of Alcohol Act 2012 applies to this licence. The licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

- (a) Alcohol may be sold from the premises at any time on any day and be delivered somewhere else for consumption off the premises.
- (b) No alcohol is to be delivered from the premises on Good Friday, Easter Sunday or Christmas Day or before 1:00 pm on ANZAC Day.
- (c) No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine, or fruit, or vegetable wine made:
 - on the premises; or
 - from grapes or fruit harvested from land on which the premises are situated.
- (d) No alcohol is to be delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11 pm on any day and before 6 am on the next day.
- (e) The licensee must follow the procedures set out in Regulation 14 of the Sale and Supply of Alcohol Regulation 2013 to ensure that neither the purchaser nor the person to whom alcohol is delivered to is a minor.
- (f) A properly appointed certified manager must be appointed to the business, however, that manager does not need to be on duty when alcohol is sold remotely.
- (g) The licensee must display on its website a legible image of the licence or a clearly identified link to such an image.
- (h) The licensee must display on its website and/or catalogues and on every receipt issued for alcohol sold remotely;
 - i. The licence holder's name and licence number;
 - ii. The date on which the licence expires;

REASON FOR DECISION:

I have considered this application on the basis of the reports received from the Licensing Inspector, the Police and the Ministry of Health, who do not oppose the issue of the licence. In addition no objections have been raised.

The District Licensing Committee Chair, acting pursuant to s.127 of the Act, therefore accordingly grants an application by Oaxaca Limited for renewal of the On Licence subject to the above conditions (a) – (h).

OFF-LICENCE

Sections 17 to 20 and Section 64, Sale and Supply of Alcohol Act 2012

- No alcohol is to be delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11 pm on any day and before 6 am on the next day.
- (e) The licensee must follow the procedures set out in Regulation 14 of the Sale and Supply of Alcohol Regulation 2013 to ensure that neither the purchaser nor the person to whom alcohol is delivered to is a minor.
- A properly appointed certified manager must be appointed to the business, however, that manager does not need to be on duty when alcohol is sold remotely.
- The licensee must display on its website a legible image of the licence or a clearly identified link to such an image.
- (h) The licensee must display on its website and/or catalogues and on every receipt issued for alcohol sold remotely;
 - The licence holder's name and licence number;
 - ii. The date on which the licence expires;

THE LICENSED PREMISES

The premises, situated at 815 Lake Ferry Road, Martinborough are more precisely identified as outlined in a plan date received by the South Wairarapa District Licensing Committee.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from 815 Lake Ferry Road, Martinborough is designated as the principal entrance.

DURATION

- If an application for the renewal of the licence is duly made, until the application is determined; or (b)
