#### **OFF-LICENCE**

Sections 17 to 20 and Section 64, Sale and Supply of Alcohol Act 2012

  - Alcohol may be sold on, or delivered from the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours

# Monday to Wednesday 11:00am to 6:00pm

### Thursday to Sunday 11:00am to 9:00pm

- b. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1:00 pm on ANZAC Day.
- No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine, or fruit, or vegetable wine made: C.

  - from grapes or fruit harvested from land on which the premises are situated.
- The types of alcohol to be sold under the winery cellar door style off licence are restricted to grape wine or fruit or vegetable wine d. made:
  - on the premises: or
  - from grapes or fruit harvested from land on which the premises are situated.
- Drinking water is to be freely available to customers while alcohol is being supplied free as a sample, from the location at which e. the sampling occurs.
- A properly appointed certified manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display:
  - At each principal entrance to the premises, the ordinary operating hours during which the sale of alcohol is permitted.
  - A copy of the licence and all conditions subject to which it is issued, to the inside of the premises so to be easily read by all people entering at each principal entrance.
  - At every point of sale for alcohol, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.

### Remote Sales

- A remote sale of alcohol may be made at any time on any day g.
- No alcohol is to be delivered from the premises on Good Friday, or Christmas Day or before 1:00 pm on ANZAC Day. h.
- No alcohol is to be delivered on Easter Sunday unless the alcohol is grape wine or fruit, or vegetable wine made: i.
  - on the premises; or
  - from grapes or fruit harvested from land on which the premises are situated.
- The licensee must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11:00 pm on any day or before 6:00 am on the next day. Whether the alcohol is delivered by the seller or by some other person.
- The licensee must follow the procedures set out in Regulations 14 of the Sale and Supply of Alcohol Regulation 2013 to ensure that neither the purchaser nor the person to whom alcohol is deliver is a minor.
  - The licensee must display on its website and/or catalogues and on every receipt issued for alcohol sold remotely;
    - The licence holder's name and licence number;
    - The date on which the licence expires;
    - iii. A legible image of the licence or a clearly identified link to such an image.

# **DECISION**

This is an application Colombo Martinborough Limited for a renewal off-licence in respect of premises situated at 107 Todds Road, Martinborough, known as Colombo Martinborough.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers.

### **DECISION**

I have considered this application on the basis of the reports received from the Alcohol Licensing Inspector, the Police and the Medical Officer of Health, who do not oppose the issue of the licence. In addition the District Licensing Committee has received no objections from the community.

I, as the District Licensing Committee Chair:

- (a) Am satisfied as to the matters to which the Committee must have regard as set out in s131 of the Act, and
- (b) Acting pursuant to s17 of the Act grant Colombo Martinborough Ltd the off-licence authorising the sale and supply of alcohol for consumption off the premises, subject to the conditions of licence (a) – (I).

## CONDITIONS

a. Alcohol may be sold on, or delivered from the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday to Wednesday 11:00am to 6:00pm Thursday to Sunday 11:00am to 9:00pm

b. The types of alcohol to be sold under the winery cellar door style off licence are restricted to grape wine or fruit or vegetable wine made:

- on the premises; or
- from produce harvested from land on which the premises are situated.
- c. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1:00 pm on ANZAC Day.
- d. No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine, or fruit, or vegetable wine made:
  - on the premises; or
  - from grapes or fruit harvested from land on which the premises are situated.
- e. Drinking water is to be freely available to customers while alcohol is being supplied free as a sample, from the location at which the sampling occurs.
- f. A properly appointed certified manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- g. The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display:
  - At each principal entrance to the premises, the ordinary operating hours during which the sale of alcohol is permitted.
  - A copy of the licence and all conditions subject to which it is issued, to the inside of the premises so to be easily read by all people entering at each principal entrance.
  - At every point of sale for alcohol, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.

# Remote Sales

- h. A remote sale of alcohol may be made at any time on any day
- i. The types of alcohol to be sold under the winery cellar door style off licence (remote sales) are restricted to grape wine or fruit or vegetable wine made:
  - on the premises; or
  - from produce harvested from land on which the premises are situated
- No alcohol is to be delivered from the premises on Good Friday, or Christmas Day or before 1:00 pm on ANZAC Day.
- k. No alcohol is to be delivered on Easter Sunday unless the alcohol is grape wine or fruit, or vegetable wine made:
  - on the premises; or
  - from grapes or fruit harvested from land on which the premises are situated.

- 1. The licensee must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11:00 pm on any day or before 6:00 am on the next day. Whether the alcohol is delivered by the seller or by some other person.
- m. The licensee must follow the procedures set out in Regulations 14 of the Sale and Supply of Alcohol Regulation 2013 to ensure that neither the purchaser nor the person to whom alcohol is deliver is a minor.
- n. The licensee must display on its website and/or catalogues and on every receipt issued for alcohol sold remotely:
  - The licence holder's name and licence number;
  - The date on which the licence expires;
  - A legible image of the licence or a clearly identified link to such an image.
