# OFF-LICENCE

Sections 17 to 20 and Section 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 Escarpment Winery Limited is authorised to sell or deliver alcohol on or from the premises situated at 275 Te Muna Road, Martinborough, and known as Escarpment Winery, to any person for consumption off the premises and to supply complimentary samples of alcohol on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

## CONDITIONS OF LICENCE

The following conditions are consistent with the style of off-licence sought

- It is recommended that the licence be issued subject to following conditions:
  - Only alcohol product made by or for the licensee company may be sold on the premises for consumption off-site and is restricted to:

grape wine or fruit or vegetable wine product."

Alcohol may be sold on, or delivered from the premises for consumption off the premises, or supplied free as a sample for consumption (b) on the premises, only on the following days and hours:

Monday to Sunday 8:00am to 6:00pm

- No alcohol is to be sold on, or delivered from, the premises on Good Friday, Christmas Day or before 1:00 pm on ANZAC Day. (c)
- No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine, or fruit, or vegetable wine made: (d)

on the premises; or

from grapes or fruit harvested from land on which the premises are situated.

All alcohol products for consumption off the premises must be sold in a sealed container.

- Drinking water is to be freely available to customers while alcohol is being supplied free as a sample, from the location at which the sampling occurs.
- A properly appointed certified manager must be on duty at all times, within the licensed area, when the premises are open for the sale (g) and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and (h) must display:

At each principal entrance to the premises, the ordinary operating hours during which the sale of alcohol is permitted.

- A copy of the licence and all conditions subject to which it is issued, to the inside of the premises so to be easily read by all people entering at each principal entrance.
- At every point of sale for alcohol, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.

# Remote Sales

A remote sale of alcohol may be made at any time on any day.

- No alcohol is to be delivered from the premises on Good Friday, Christmas Day or before 1:00 pm on ANZAC Day.
- No alcohol is to be delivered on Easter Sunday unless the alcohol is grape wine or fruit, or vegetable wine made: (k)

on the premises; or

from grapes or fruit harvested from land on which the premises are situated.

- The licensee must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11:00 pm on any day or before 6:00 am on the next day. Whether the alcohol is delivered by the seller or by some other person.
- (m) The licensee must follow the procedures set out in Regulations 14 of the Sale and Supply of Alcohol Regulation 2013 to ensure that neither the purchaser nor the person to whom alcohol is deliver is a minor.
- The licensee must display on its website and/or catalogues and on every receipt issued for alcohol sold remotely;

The licence holder's name and licence number; i.

- The date on which the licence expires; ii
- iii. A legible image of the licence or a clearly identified link to such an image.

THE LICENSED PREMISES
The premises, situated at 275 Te Muna Road, Martinborough are more precisely identified as outlined in a plan date received by the South Wairarapa District Licensing Committee on the 10/07/23.

## **DECISION**

This is an application **Escarpment Winery Limited** for a renewal off-licence in respect of premises situated at **275 Te Muna Road, Martinborough**, known as **Escarpment Winery**.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s131 of the Act and we grant the applicant a renewal off-licence authorising the sale and supply of liquor for consumption off the premises with the following conditions (a)-(n).
