### **ON-LICENCE**

- sell and supply, for consumption on the premises by any person who is there to dine, any food or hot drink containing not more than 14.33% alcohol by volume; and
- let people consume alcohol on the premises

#### Conditions

- No alcohol is to be sold, supplied or consumed on Good Friday, Easter Sunday, Christmas Day or before 1:00 pm on Anzac Day to any (a) person unless:
  - they are people who are present on the premises to dine
- Alcohol may only be consumed on the premises on the following days and during the following hours: (b)

Tuesday to Sunday between 11:30 am to 10:00 pm

- Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises at all times that alcohol (c) is available for sale, supply and consumption.
- Food must be available for consumption on the premises at all times the premises are open for the sale, supply and consumption of alcohol, in accordance with the menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible and food should be actively promoted.
- The following steps must be taken to promote the responsible consumption of alcohol: (e)
  - Implement and maintain the Host Responsibility Policy submitted with the application for the licence.
  - At all times when the premises are open for the sale, supply or consumption of alcohol, a reasonable range of non-alcoholic refreshments and low-alcohol options are available.
  - The Licensee must ensure that signs are prominently displayed within the licensed premises detailing the availability of assistance and information regarding alternative forms of transport from the premises.
  - The licensee must implement and maintain steps proposed in the application for the licence aimed at promoting the responsible consumption of alcohol.
  - the following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
    - A restriction of sale or supply of alcohol to persons under the age of 18 years of age.
    - Display of appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
  - the whole of the premises is designated as an 'undesignated' area.
  - The licensee must ensure that at all times a copy of the licence, together with a statement of all conditions subject to which it is issued, is displayed at the principal entrance so as to be easily read by people using the premises.
  - A telephone must be freely available for customers to call for transport & staff must assist if required. Telephone numbers for alternative forms of transport from the premises must be displayed.
  - A manager is to be on duty at all times where the application of this licence is operating

## THE LICENSED PREMISES

The premises, situated at 74-76 Main Street, Greytown, are more precisely identified as outlined in a plan received by the South Wairarapa District Licensing Committee on 23rd June 2022.

## DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from 74-76 Main Street, Greytown is designated as the principal entrance.

# DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provision of the Act relating to the suspension and cancellation of licences, this licence continues in force -

(a) Either -

Until the close of the period for which it was last renewed; or

If it has never been renewed, until the close of the period of 12 months after the day it was issued; but ii.

(b) If an application for the renewal of the licence is duly made before the licence would otherwise expire, either -

Until the close of the period of 3 years after the period for which it was last renewed; or
