DECISION

This is an application by **The Experience Collective Limited** for a renewal on-licence in respect of premises situated **109 Main Street**, **Greytown** known as **"The White Swan Hotel"**. The general nature of the business conducted under the licence is a **hotel**.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly we deal with the matter on the papers. We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act and we grant the applicant a renewal on-licence authorising the sale and supply of alcohol for consumption on the premises, to any person who is present on the premises.
