### **ON-LICENCE**

(for premises)

Sections 14 to 16 and 64, Sale and Supply of Alcohol Act 2012

- Alcohol may only be available for sale, supply or consumption on the following days and during the following hours: (b)

Monday to Sunday between 8:00am to 1:00am the following day

- Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises at all times that alcohol (c) is available for sale, supply and consumption.
- Food must be available for consumption on the premises at all times the premises are open for the sale, supply and consumption of alcohol, in accordance with the menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted.
- The following steps must be taken to promote the responsible consumption of alcohol: (e)
  - Implement and maintain the Host Responsibility Policy submitted with the application for the licence.
  - At all times when the premises are open for the sale, supply or consumption of alcohol, a reasonable range of non-alcoholic refreshments and low-alcohol options are available.
  - The Licensee must ensure that signs are prominently displayed within the licensed premises detailing the availability of assistance and information regarding alternative forms of transport from the premises.
  - The licensee must implement and maintain steps proposed in the application for the licence aimed at promoting the responsible consumption of alcohol.
  - the following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
    - A restriction of sale or supply of alcohol to persons under the age of 18 years of age.
    - Display of appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
  - the designation of the premises is subject to the following conditions -

      - 1. Supervised 8:00am to 1:00am
    - Function room
      - Undesignated until 8:00am 9:00pm 1.
      - Supervised 9:00pm to 1:00am 2
    - Garden bar
      - 1. Supervised 8:00am to 1:00am
    - · Restaurant/board room space
      - 1. Undesignated until 8:00am 9:00pm
    - Supervised 9:00pm to 1:00am
  - (h) The licensee must ensure that at all times a copy of the licence, together with a statement of all conditions subject to which it is issued, is displayed at the principal entrance so as to be easily read by people using the premises.
  - The holder of a manager's certificate or a properly notified manager shall be on duty and on the premises at all times alcohol is available for sale, supply and consumption.
  - A telephone must be freely available for customers to call for transport & staff must assist if required. Telephone numbers for alternative forms of transport from the premises must be displayed.

## THE LICENSED PREMISES

The premises, situated at 57 Fox Street, Featherston, are more precisely identified as outlined in a plan received by the South Wairarapa District Licensing Committee on 26th October 2022.
