#### PROPOSED ALCOHOL CONTROL BYLAW REPORT

#### **Purpose of Report**

To advise the Committee of the submissions received on the Statement of Proposal for the Proposed Alcohol Control Bylaw and subsequent advice and recommendations from officers for the proposed bylaw.

#### Recommendations

Officers recommend that the Committee:

- 1. Receives the Proposed Alcohol Control Bylaw Report.
- 2. Considers submissions on the Statement of Proposal for the Proposed Alcohol Control Bylaw.
- 3. Recommends to Council that the proposed Alcohol Control Bylaw be adopted subject to any amendments recommended by the Committee.
- 4. Agrees that the purpose of the proposed bylaw be amended as stated in paragraph 3.1 of this report.
- 5. Agrees that the proposed bylaw make provision for an alcohol ban to accompany the Toast Martinborough event.
- 6. Considers and decides whether to retain the alcohol ban to accompany Toast Martinborough within Schedule 1 of the proposed bylaw (option 1) or to resolve a temporary alcohol ban for each event in accordance with clause 5 of the proposed bylaw (option 2).
- 7. Agrees that no permanent alcohol bans for specific areas and facilities be included in the bylaw, as proposed.
- 8. Agrees that the proposed mechanisms be included in the bylaw to enable Council to make alcohol bans by resolution where criteria is met, including temporary bans associated with events or permanent bans associated with specific areas or facilities.
- 9. Agrees that the consultation requirements for making alcohol bans under clauses 5 and 6 of the proposed bylaw be adopted.
- 10. Considers officers' recommendations of measures to address issues of cyclists' safety and care for tourists.

11. Considers and decides if the bylaw should include a provision to enable Council to give permission to consume, bring into or possess alcohol in an alcohol ban area as stated in paragraph 3.5 of this report.

#### 1. Background

Council adopted the proposed Alcohol Control Bylaw 2021 Statement of Proposal (SOP) for public consultation on 28 July 2021 in accordance with the Special Consultative Procedure, as provided in sections 83, 86 and 156 of the Local Government Act 2002 (LGA).

The SOP was released for consultation on 2 September 2021. A community meeting was held on 16 September to provide an opportunity for the public to find out more about the proposal before making a submission.

The submission deadline was extended from 2 September to 5 September 2021. This was to provide additional time to respond given that COVID-19 restrictions had limited the ways Council could advertise the consultation and how people were able to make a submission.

Feedback was sought on the following specific areas:

- the problem as it was defined in the SOP
- the proposed bylaw controls including a proposed alcohol ban for Toast
   Martinborough and the ability for Council to make alcohol bans by resolution
- the exclusion of any permanent alcohol ban areas, including the Featherston CBD, and
- other actions that Council could take to address public safety and reduce alcohol-related crime and disorder in the community.

#### 2. Submissions and Deliberations Process

#### 2.1 Submissions received

A total of 23 submissions were received as attached in Appendix 1. Two submissions were received by email and the remaining 21 were made using an online form.

Five submissions received were on behalf of organisations, including Featherston Rugby Club, Poppies Martinborough, Martinborough Grocery Ltd, Moy Hall Wines Ltd and Regional Public Health.

#### 2.2 Hearings and deliberations

Submitters to the proposed Alcohol Control Bylaw are provided the opportunity to present their views in person to the Committee at the oral hearings on 22 September. The Committee will then consider all submissions received together with advice and recommendations provided by officers and make recommendations on the proposed bylaw to Council. Council will decide whether to accept the Committee's

recommendations and adopt the proposed bylaw on 3 November 2021, and if adopted, the bylaw would come into effect on 4 November 2021.

#### 3. Submissions Analysis and Recommendations

#### 3.1 Problem Definition


The SOP considered whether the bylaw was the most appropriate way to address the perceived problem which is defined as "crime or disorder caused or made worse by the consumption of alcohol in public places."

The SOP set out that given the low level of crime and disorder in the district, we had considered whether we need a bylaw at all. However, while there are other options to address the problem, we considered they are unlikely to address the problem on their own. Without an Alcohol Control Bylaw there would be no ability to provide for temporary alcohol bans for events, or to deal with problem areas in the future.

Bylaws are a well-recognised mechanism and provide a preventative tool to stop problems happening which is consistent with the 'prevention first' strategy of the Police. This is preferable to waiting for problems to occur, particularly at and after events where large groups may gather

Submitters were asked if they agreed with the problem as we have stated it. Of those that responded, 27% (6 submitters) agreed with the problem as stated and 73% (16 submitters) did not.

Agreement with the problem as stated in Paragraph 3 of the Statement of Proposal which is defined as "crime or disorder caused or made worse by the consumption of alcohol in public places"





Submitters were asked to provide feedback on whether there is more or less we should consider.

#### 3.2 Further analysis and recommendation

Officers recommend that the proposed Alcohol Control Bylaw be adopted subject to any amendments decided by the Committee to reflect the further analysis and recommendations in this report.

#### 3.2.1. Purpose of the bylaw

Officers consider merit in expanding the purpose of the bylaw to better explain the problem definition, and to clarify that the bylaw and alcohol bans are the minimum necessary control to achieve the purpose, as required by the LGA. The recommended Purpose, below, also clarifies that the bylaw controls the bringing of alcohol into public places which was omitted in error from the Purpose of the draft proposed bylaw in the SOP.

#### 2. Purpose

2.1 The purpose of this Bylaw is to control the consumption, bringing into, or possession of alcohol in public places to reduce and mitigate crime and disorder that is caused or made worse by the presence or consumption of alcohol in those places. The controls in this Bylaw apply: a) to any public place subject to an alcohol ban, as listed in

Schedule 1 to this Bylaw; or b) where a temporary ban for specified events or specified periods is made by Council resolution in accordance with clause 5. Alcohol bans, when applied in accordance with the relevant legislation and supported by the available evidence, mitigate the potential for noise, litter, vandalism, violence, and other forms of crime or disorder which would otherwise occur in the absence of a permanent or temporary ban.

2.2 This Bylaw limits individual rights and the freedom to consume, bring into, or possess alcohol in public places only to the extent that can be reasonably justified. Any such limits imposed under this Bylaw are designed to be appropriate and proportionate to the level of crime and disorder which would otherwise occur in those places, as determined by evidence and proper assessment. Other strategies are also utilised to address alcohol-related crime and disorder, and include existing Police powers to protect public safety, Council powers to regulate licensed premises, and public education.

#### 3.2.2. Recommendations

- That the proposed Alcohol Control Bylaw be adopted subject to any amendments recommended by the Committee.
- That the Purpose of the proposed bylaw be amended as stated in paragraph 3.1 of this report.

#### 3.3 Proposed Bylaw Controls

Feedback was sought on the proposed bylaw controls including an alcohol ban to accompany Toast Martinborough, inclusion of permanent alcohol ban areas, and provisions to enable Council to make alcohol bans by resolution.

#### 3.3.1. Alcohol ban to accompany Toast Martinborough

The SOP proposed an alcohol ban to accompany Toast Martinborough be included in the bylaw itself given it is a well-established and recurring major event. This would provide more certainty to the community and stakeholders and is more efficient because it does not rely on a temporary ban being sought each year. It was proposed the ban would apply for the same time and location as previous bans.

Eight of the 23 submitters agreed with the proposed control to include an alcohol ban for Toast Martinborough in the bylaw. Fifteen submitters did not agree with this proposal.

Summary of comments	Officer Advice
Of those that disagreed five provided comments that no bylaw or ban was necessary as there was no problem to address.	Bans have been in place for all of the Toast Martinborough events and this has likely reduced the level of crime and disorder.

#### Further analysis and recommendation

Officers recommend that the bylaw make provision for an alcohol ban to accompany the Toast Martinborough event.

Council has the flexibility of considering two options for adopting an alcohol ban for Toast Martinborough. The first is by including the ban within Schedule 1 of the bylaw, as proposed in the SOP, and the second is by resolving a temporary alcohol ban for each event in accordance with clause 5 of the proposed bylaw.

#### Option 1

The SOP notes that including the ban for the Toast Martinborough event within the bylaw provides more certainty to the community and stakeholders and is more efficient because it does not rely on a temporary ban being sought each year. In addition, there is no requirement to provide evidence of a high level of crime and disorder and to ensure proportionality and appropriateness for bans for large-scale events (section 147A(1)(b)). This exception effectively operates as a presumption of risk that crime or disorder may be caused or made worse in those environments. There may be some difficulty in obtaining evidence of a high level of crime or disorder if the event continually operates with an alcohol ban in place to reduce such problems, as with Toast Martinborough. However, despite this exception, officers consider there is sufficient experience with the nature and operation of Toast Martinborough to justify a permanent ban within the bylaw itself.

The disadvantage of including the ban within the bylaw itself is that a change to the parameters of the ban may require an amendment to the bylaw following

consultation. The parameters of the ban are defined in Schedule 1 of the bylaw with respect to the time and geographical extent of the ban. The day is defined as the day of the event. This can change from one year to the next but is sufficiently certain in light of the prior marketing of the day of the event and the requirement in clause 5.2 of the proposed bylaw to give public notification of the event.

If Council, in conjunction with the event organisers, want to make a significant change to the fixed parameters over the life of the bylaw (five years) this would require an amendment to the ban. This could be effected by resolution in accordance with clause 6 of the proposed bylaw. Depending on the significance of the change, this may require either consultation following the special consultative procedure as set out in section 83 of the LGA or other consultation that gives effect to Council's Significance and Engagement Policy, in accordance with section 156 of the LGA. A significant change may require a number of months' notice before it could be put into effect.

#### Option 2

The exception in the LGA does not apply to bans made by resolution made under section 147B (clause 5 in proposed bylaw). Council would therefore need to carry out each year an assessment of the evidence of a high level of crime and disorder and the appropriateness, proportionality and limitation on people's rights and freedoms of the ban. This provision guards against the risk of resolving a ban that is not the minimum necessary to give effect to the purpose of the bylaw but, as indicated above, there may be some difficulty in obtaining evidence of a problem. The benefits identified in the SOP of including the ban in the bylaw will also not be realised.

The benefit of resolving the ban each year the event takes place is that the parameters of the ban can be amended if necessary to reflect the need for the event that year. The assessment would consider the impact of any changes.

Council has the flexibility to consider either of these options as both options place equal but minimal restrictions on individual rights and freedoms. The matter is largely one of practicality. Officers have contacted the Toast Martinborough event organisers who do not foresee any changes to the event, and therefore the parameters of the ban, over the life of the bylaw.

#### Recommendations


- That the proposed bylaw make provision for an alcohol ban to accompany the Toast Martinborough event.
- The Committee consider and decide whether to retain the alcohol ban to accompany Toast Martinborough within Schedule 1 of the proposed bylaw (option 1) or to resolve a temporary alcohol ban for each event in accordance with clause 5 of the proposed bylaw (option 2).

#### 3.3.2. Does not include alcohol bans for specific areas and facilities

The SOP did not propose including permanent alcohol bans in the bylaw for specific areas and facilities, including the Featherston CBD, as we do not think there is sufficient evidence of a high level of crime or disorder caused or made worse by alcohol consumption in the district.

Submitters were asked if they agreed not to include permanent alcohol ban areas in the bylaw. Of those that responded, 81% (17 submitters) agreed and four disagreed.

There is not sufficient evidence of a high level of crime or disorder caused or made worse by alcohol consumption to support permanent alcohol ban areas, including the Featherston CBD alcohol ban in the previous bylaw



Summary of comments	Officer Advice
One submitter supported a permanent night time ban in the Martinborough Square and park and a permanent ban in children's parks	There is insufficient evidence to support bans in these areas. Council will continue to monitor these areas for the future.
One submitter supported an alcohol ban in Featherston CBD as there were concerns that young people may consume alcohol at the skate park.	There is insufficient evidence to support a ban in the Featherston CBD (see further assessment below). Council will continue to monitor these areas for the future.
One submitter did not agree with any of the Council's proposals.	Noted.

#### Further analysis and recommendation

#### Featherston CBD

Total Respondents: 21

The SOP did not propose to include an alcohol ban in Featherston CBD because there was insufficient evidence of a high level of crime or disorder caused or made worse by alcohol consumption in the area in accordance with section 147A(1)(b)(i) of the LGA.

This is the assessment to be adopted for new bylaws as the proposed bylaw is a new bylaw.

However, as there was an alcohol ban in the Featherston CBD in Council's previous bylaw *South Wairarapa Liquor Control Bylaw 2011* a case could be made that the assessment for replacement bylaws provided in section 147A(3) should be adopted. This requires the Council, before making a ban, to be satisfied that a high level of crime or disorder is likely to arise in the area to which the bylaw is intended to apply if the bylaw is not made. This effectively takes into account the impact an alcohol ban may have had on the level of crime and disorder in the area and requires Council to consider whether the risk that prompted the ban is likely to arise again in its absence.

Officers identified during pre-consultation engagement that the Featherston CBD liquor ban area was a response to an historic problem associated with particular community members at that time. Stakeholders agreed that these problems have not been evident for some time. This is most likely due to changes in the general community although there may be some potential benefit due to the preventative effect of the previous alcohol ban.

Officers do not therefore consider under either assessment that there is sufficient evidence or risk of crime or disorder to include a ban for the Featherston CBD in the proposed bylaw.

#### Recommendation

 That no permanent alcohol bans for specific areas and facilities be included in the bylaw, as proposed.

#### 3.4 Enables Council to make alcohol bans by resolution

The SOP proposed including a mechanism in the bylaw to enable Council to make alcohol bans by resolution where criteria is met. This could include temporary bans associated with other events or permanent bans associated with specific areas or facilities.

Eight of the 23 submitters agreed with the proposed control to enable Council to make alcohol bans by resolution. Fifteen submitters did not agree with the proposal.

Officers will report to the Planning and Regulatory Committee and Council on any proposed ban but these must necessarily be made by Council itself. One submitter who agreed with the proposal wanted more information on the resolution process and the associated threshold of a "high level" of crime and disorder.	Noted.  There is no statutory definition of what constitutes a "high level" of crime or disorder. Council would need to have evidence of a significant and ongoing alcohol-related problem in a particular area, not just a small number or intermittent incidents.

#### Further analysis and recommendations

Officers recommend that mechanisms be included in the bylaw to enable Council to make alcohol bans by resolution where criteria is met, including temporary bans associated with other events or permanent bans associated with specific areas or facilities.

#### Consultation requirements for alcohol bans

Clause 5 of the proposed bylaw requires Council to carry out an assessment based on prescribed criteria in the LGA before making a temporary alcohol ban by resolution. Council must also comply with the general decision-making requirements in sections 77—82 of the LGA, including applying principles of consultation in accordance with Council's Significance and Engagement Policy. These are the same requirements that applied to temporary bans made by resolution under Council's previous bylaw.

Clause 6 of the proposed bylaw also requires Council to carry out the above assessment and comply with the general decision-making requirements in sections 77—82 of the LGA prior to adding, amending or revoking an alcohol ban in Schedule 1 by resolution. In addition, clause 6 requires that Council use the special consultative procedure set out in sections 83 and 156 of the LGA prior to making a resolution. This is because an amendment to Schedule 1 is effectively an amendment to the bylaw and the provisions of section 83 and 156 apply to amendments to bylaws. As indicated in paragraph 3.2.1 above, this may require either consultation following the special consultative procedure as set out in section 83 or other consultation that gives effect to Council's Significance and Engagement Policy, in accordance with section 156 of the LGA, depending on the significance of the change.

Note also that both clauses require bans to be publicly notified at least 14 days in advance of the specified event or period or before coming into effect.

Officers consider that these requirements ensure appropriate levels of consultation with the community proportionate to the application of the bans.

#### *Recommendations*

- That the proposed mechanisms be included in the bylaw to enable Council to make alcohol bans by resolution where criteria is met, including temporary bans associated with other events or permanent bans associated with specific areas or facilities.
- That the consultation requirements for making alcohol bans under clauses 5 and 6 of the proposed bylaw be adopted.

# 3.5 Other actions to address public safety and reduce alcohol-related crime and disorder in the community

There are other strategies that could be employed to address public safety and reduce alcohol-related crime and disorder in the community including current Police powers to protect public safety and Council powers to regulate licenced premises under the Sale and Supply of Alcohol Act 2012. Council could also develop controls in our policies, plans and hire agreements, use CCTV or advocate for more local Police.

Community feedback was sought on the other actions Council could take.

#### Further analysis and recommendations

Regarding working with stakeholders to address issues of cyclists' safety and care for tourists, officers recommended the following in the report to Council of 28 July 2021:

Council and the Martinborough Community Board should work with the Martinborough community, business and Destination Wairarapa to better understand the nature and size of any alcohol related problems and to promote responsible wine and cycling tourism. This work would build on the ongoing support to hospitality businesses from Council's Alcohol Licensing Inspectors and specific discussions held in January 2021.

Council should also consider measures that can be taken to improve road safety along the vineyard route, noting that a district-wide speed review is due to be carried out later in 2021. Broader issues associated with the cost burden of tourism will also be considered as part of the rating review due to be carried out in the 2021/22 financial year. Increased enforcement action and additional regulation can be employed if these measures are not successful. This is consistent with the regulatory enforcement pyramid and responsive regulation approach.<sup>1</sup>

#### Recommendation

• That the Committee consider officer's recommendation of measures to address issues of cyclists' safety and care for tourists.

#### 3.6 Other feedback

The community were given the opportunity to provide other feedback on the proposed alcohol bylaw.

Summary of comments	Officer Advice
One submitter asked whether Council would be able to put in place a ban that has no end date and whether there would be an appeal process to a proposed ban.	Bans last for the lifetime of the bylaw (5 years until the first review and then 10 years for subsequent reviews) or until earlier amended or revoked under clause 6 of the proposed bylaw.
	There is no appeals process within the bylaw but bans are subject to decision-making requirements and consultation as discussed under paragraph 3.2.1. above.
One submitter commented on the impact of Martinborough's growth on its hospitality and tourism industry and alcohol-related issues. The submitter noted that wine and tourism creates part of Martinborough's culture and noted that the bylaw had the potential to affect the way things operate as they do now. They agreed that social public drinking that did not result in harm should not be restricted.	Noted.  Officers are considering the impact of growth as part of work on the Council's spatial plan.  The bylaw controls can only limit individual rights and the freedom to consume, bring into, or possess alcohol in public places to the extent that can be reasonably justified. Any such limits imposed under the bylaw are designed to be appropriate and proportionate to the level of crime and disorder which would otherwise occur in those places, as determined by evidence and proper assessment.

#### 3.7 Council permission

The SOP did not propose to include a provision to enable Council to give permission to allow people to consume, bring into or possess alcohol in an alcohol ban area. This is because the provision may be applied arbitrarily, which risks inequitable treatment, and special licences can provide for the ability to sell or supply in an alcohol ban area. An exemption potentially undermines the policy intent of the alcohol ban in the first place, particularly considering the evidence of a high level of crime or disorder needed for the ban to be put in place.

However, there may be some occasions where Council would consider giving such permission, for example where an event was held in an alcohol ban area and "BYO" alcohol was permitted. A Special Licence would not apply in these circumstances but Council could limit the risk of alcohol-related harm through strict conditions with the event organiser.

A similar exemption was included in clause 4.1 of Council's previous bylaw.

If the Committee agreed that such a provision should be included in the bylaw, the following is recommended:

#### **Council permission**

Any person may apply to the Council for prior written permission for any activity that would be in breach of any prohibition under this Bylaw. A special licence may be issued under the Sale and Supply of Alcohol Act 2012 in respect of any

location or event and may include waivers and dispensations (subject to and in accordance with the terms of that special licence).

#### Recommendation

• That the Committee consider and decide if the bylaw should include a provision to enable Council to give permission to consume, bring into or possess alcohol in an alcohol ban area as stated in paragraph 3.5 of this report.

#### 4. Consultation and Legislative Requirements

The consultation and legislative requirements that apply to the adoption of the proposed Alcohol Control Bylaw are included in this report.

#### 5. Financial Implications

The financial implications of adopting the bylaw include advertising for notification of the bylaw and alcohol bans and signage.



(pg 4 "Fortunately, our district does not experience significant incidents of alcohol-related crime and disorder and there are no particular problem areas that we are aware of"). So if there's no problem, why has there been a solution created? You need to more clearly define your scope for change and leave out the irrelevant pieces in your public policy proposals. From page 3: "A number of concerns about crime and disorder in the district have been raised. Not all of these are alcohol-related and so are outside of the scope of the Alcohol Control Bylaw. Some stakeholders have wanted to address social concerns such as problem drinking or the normalisation of drinking around young people through alcohol bans at, for example, playgrounds and sports grounds but this is also out of scope." There are problem areas, such as Toast and other wine festivals that have unfortunately deteriorated into binge-drinking affairs, but on the whole. South Wai does not seem to have a significant issue. I've read the proposed changes between the previous bylaw and this one, and it seems you acknowledge this too. You need to re-define the problem, so we the public, understand the issues that you are trying to resolve. At this stage, it seems very unclear and underresearched.





I strongly oppose the proposed bylaw.

We live in a highly regulated society which results in costs and complexity that are an increasing burden to its citizens. Any new regulation, bylaw, or other legislative measure should therefore only be introduced where there is a clear requirement for doing so. So, does this proposed new bylaw meet the required test? I submit it does not, for the following reasons:

- The bylaw proposal states the problem we are addressing with this bylaw can be defined as "crime or disorder caused or made worse by the consumption of alcohol in public places". Yet, there is no evidence this problem exists. Neither the police nor council staff report an existing issue, so the proposed bylaw fails this essential measure.
- Every new bylaw, task or other responsibility assumed by Council, no matter how small, adds to the workload and administrative costs of the organisation. Council is already struggling with delivering basic services at a cost ratepayers can afford. It does not need yet another bylaw that will need to be managed by someone at a cost to ratepayers. Particularly when no documented problem exists.
- The Q&A document on the proposed bylaw states "without a bylaw we can't mandate alcohol bans for events as they occur during the year. Also, we wouldn't be able to introduce an alcohol ban area". This is another worrisome aspect. If the bylaw is enacted as proposed it essentially gives council staff authority to implement bans with minimal consultation. Powers currently exist to implement bans in one-off cases (like the Toast Martinborough example given in the consultation papers). The existing process in any specific case requires all factors to be considered, consultation carried out, and a mutually acceptable decision made. It is not appropriate blanket powers on these matters should in the hands of a few council officers.
- The briefing papers talk about needing the bylaw for Council to deal with the potential development of "a high level of crime or disorder". It is not the role of Council to be dealing with aspects of high levels of crime and disorder; that is the job of the police. And, to repeat, there is no evidence of an existing issue requiring attention.
- A read of the Q&A indicates a flawed thought process. Quote "We would need to take into account that it is difficult to obtain
  quantitative evidence because people often do not make official complaints and the Police may deal with problems informally rather
  than issuing infringement notices". Two issues arise from this
- First, clearly the numbers of assumed offenders small or negligible. Yet, the discussion paper seems to imply that the problem is much greater than it really is, using this as a justification for another bylaw
- Second, it seems to assume the police are acting inappropriately by not charging individuals. Police have the expertise to know that in cases of minor breaches a low-key approach may be the best outcome. This bylaw seems to question that judgement
- The bar for restricting people's freedom via the use of alcohol bans has been raised in changes to legislation. Why is Council
  then proposing a bylaw giving an ability to implement them, when its own discussion papers state "there is no evidence of alcoholrelated crime or disorder in Featherston or anywhere else in our district"

While I have detailed my main objections to the proposed bylaw above, I would close by saying this proposed change is another example of regulating the majority due to the behaviour of a very small minority. It should not be implemented.

Regional Public Health serves the greater Wellington Region, through its three district health boards (DHBs): Capital & Coast, Hutt Valley and Wairarapa and as a service is part of the Hutt Valley District Health Board.

We work with our community to make it a healthier safer place to live. We promote good health, prevent disease, and improve the quality of life for our population, with a particular focus on children, Māori and working with primary care organisations. Our staff includes a range of occupations such as: medical officers of health, public health advisors, health protection officers, public health nurses, covid-19 teams and public health analysts.

Our service delivery includes work to reduce alcohol related harm in the Wairarapa and we are one of the three reporting agencies in the Sale and Supply of Alcohol Act 2012 reporting on liquor licence applications.

## Summary

Regional Public Health (RPH) appreciates the opportunity to submit on the proposed Alcohol Control Bylaw.

RPH supports the Council's position to proceed with Option 1 outlined in your Statement of Proposal which recommends the following:

- Provides Council and the Police with a regulatory tool to control the possession and consumption of alcohol in public places leading to a reduction in crime or disorder caused or made worse by alcohol
- Promotes and maintains public health and safety
- Is an appropriate balance between regulatory and non-regulatory strategies to reduce alcohol-related crime and disorder
- Enables new controls to be in place prior to Toast Martinborough in November

#### RPH recommends

Alcohol bans are generally well supported by residents and businesses. However the details are often not well known especially by visitors. The council should ensure the bylaw is successfully communicated to the public so the details are well understood.

RPH recommends highly visible and simple signage be used to inform the public of the locations and times covered by an alcohol ban. This should be part of a wider communication and enforcement plan that supports an alcohol ban.

#### Support for Alcohol Control Bylaws

Public place drinking is one of a number of negative influences contributing to alcohol related harm. Public place settings are a common location for low level alcohol related offending, increase the opportunity for more serious alcohol-related violence1 and increase the opportunities for drunk driving and underage drinking2.

Alcohol Control Bylaws are a widely used and well-established tool internationally and in New Zealand. They are known to improve perceptions of public safety and can contribute to the reduction of harm by providing police with a tool for dealing with antisocial behaviour caused by drinking in public3. They can also contribute to change in people's perception of social norms through alcohol being less visible in public and can help limit consumption to more controlled or supervised environments.

The literature reports some limitations. Displacement can be a problem4 5 and disadvantaged and marginalised groups are more likely to consume alcohol in public, either by choice or because of limited alternatives.6 7

Alcohol bylaws are most successful when part of a wider strategy.8 9 These should include other regulations for supply control for example elements in a Local Alcohol Policy, as well as community based harm reduction initiatives, social and cultural programmes and access to health services.

Alcohol bylaws are most successful when the underlying causes are understood, that context addressed and the community are engaged in the solutions.

Support for an Alcohol Control Bylaw in South Wairarapa

Alcohol harm in South Wairarapa from consumption in a public place is a particular subset of harm that is influenced by the easy availability of low cost alcohol from off licences and the high density of premises in the district. Harms from public place drinking are often associated with heavy or binge drinking. This consumption is influenced by certain social or cultural cues and its interaction with the local physical or built environment.

The value of public consultation

We commend the Council for setting up a public meeting to consult with your community and provide additional information on your website for those who weren't able to attend this meeting. This ensures that your communities are able to be involved in the consultative process and have an opportunity to address any questions or concerns they may have.

Community knowledge of alcohol free zones

Having variable restrictions can cause confusion. Such concerns were raised in the Law Commission report Alcohol in Public Places.10 It is important there is on-going clear communication about the specific locations and the times the ban operates throughout the life of the bylaw.

Ensuring effectiveness and meeting legislative requirements

Evaluating an implemented policy is important to assess the impact both positive and negative. Prior to the next review it may be beneficial for the Council to again collaborate with other agencies involved in alcohol harm reduction and complete an evaluative impact assessment. This would provide policy makers with a high level of evidence supporting the requirements under the Local Government Act, support a sustainable approach to the wellbeing of communities and a participatory and consultative approach to policy-making.
