I want to Thank Bryce & His Team for the wonderful Work on the 'Waihinga' Cemetery "Lychgate", and Cemetery in general. I am much appreciative.

Back in early April, this year, I asked a Councillor, re. The 2. plans, LTP. & revamp of The Square. They told Me The Town/planner will get in touch with Me & explain such. Soldier's Memorial Park, Martin Square, & THE Square.

My understanding, When on 'The Square Development Group'. The Square was from Burm, Ohio St. to Burm Cork Street. Burm Naples St. to Burm Strassburg St. Also, Please Define, The other's?
