



IN THE MATTER of the Sale and Supply of Alcohol Act 2012

AND

IN THE MATTER of an application by **Featherston Bowling Club Incorporated** for a Special Licence pursuant to s.22 of the Act in respect of premises situated at **76 Fox Street, Featherston** and known as **Featherston Bowling Club**

BEFORE THE SOUTH WAIRARAPA DISTRICT LICENSING COMMITTEE

DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for **Annual Awards Night** to be held at **76 Fox Street, Featherston** and known as **Featherston Bowling Club**, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.


Accordingly, we set the following conditions under s147 on the licence:

Conditions

This licence is subject to the following conditions:

1. Alcohol may be sold under the licence only on the following days and during the following hours:
Saturday 16 August 2014 – 10.00 pm to 1.00 am the following day
2. Alcohol may be sold or supplied to the following types of people: **Members and bona-fide Guests**
3. The licensee must take the following steps to ensure that the provisions of this Act relating to the sale or supply of alcohol to prohibited persons are observed: **display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons**
4. The licensee must take the following steps to ensure that the provisions of this Act relating to the management of premises are observed: **One certified manager will be on duty at all times**
5. Drinking water must be freely available at the following places while the premises are open for business: **Potable water is to be available at each part of the premise where alcohol is being provided**
6. Substantive food must be available for consumption on the premises
7. Non-alcohol beverages orange juice, soft drinks must be available for sale and supply on the premises.
8. The licensee must take steps to provide assistance with or information about alternative forms of transport from the premises.
9. Alcohol may be sold in the following types of container only: **cans and glasses.**
10. A copy of this licence must be displayed at each point of sale so as to be easily read by persons present on the premises.

Special Licence

Sections 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **FEATHERSTON BOWLING CLUB INCORPORATED** is authorised to sell and supply alcohol, on the premises situated at **76 Fox Street, Featherston** and known as **Featherston Bowling Club** to any person attending the following occasion or event (or series of occasions or events):

Annual Awards Night

(Except where the District Licensing Committee grants an exemption under section 213(2) of the Act) The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

This licence is subject to the following conditions:

1. Alcohol may be sold under the licence only on the following days and during the following hours:
Saturday 16 August 2014 – 10.00 pm to 1.00 am the following day
2. Alcohol may be sold or supplied to the following types of people: **Members and bona-fide Guests**
3.
