DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for **Annual Jazz Festival Events** to be held at **Martinborough Town Hall, Texas Street Martinborough** and known as **Martinborough Town Hall**, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Accordingly, we set the following conditions under s147 on the licence:

Conditions

1. Alcohol may be sold under the licence only on the following days and during the following hours:
Friday 5 September 2014 6.00 pm to 12.00 midnight
Saturday 6 September 2014 6.00 pm to 12.00 midnight
Sunday 7 September 2014 12.00 midday to 5.00 pm
2. Alcohol may be sold or supplied to the following types of people: **Ticket Holders**
3. The licensee must take the following steps to ensure that the provisions of this Act relating to the sale or supply of alcohol to prohibited persons are observed: **display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons**
4. The licensee must take the following steps to ensure that the provisions of this Act relating to the management of premises are observed: **One certified manager will be on duty at all times**
5. Drinking water must be freely available at the following places while the premises are open for business: **Potable water is to be available at each part of the premise where alcohol is being provided**
6. Substantive food must be available for consumption on the premises
7. Non-alcohol beverages orange juice, soft drinks must be available for sale and supply on the premises.
8. The licensee must take steps to provide assistance with or information about alternative forms of transport from the premises.
9. Alcohol may be sold in the following types of container only: **cans, plastic glasses, and glasses.**
10. A copy of this licence must be displayed at each point of sale so as to be easily read by persons present on the premises.

Special Licence

Sections 22 and 64, Sale and Supply of Alcohol Act 2012

Inspectors Report

I have assessed the application and the requirements of the Act appear to have been met.

Provisions have been made for low and non-alcoholic beverages, food, and free water. Free transport from the Town Hall has been arranged by the festival organisers. Philippa Maynard, Garry Jackson, and David Kershaw all hold managers certificates, and have been identified as managers. This is an annual event that has been operating for 3 years. Previous occasions have not been the subject of complaint.

There is no reason to believe that the amenity and good order of the locality would be reduced by more than a minor extent, by the effects of the issue of this licence.


I have no objection to the license being issued, and recommend that the Committee set the following conditions under s147 on the licence:
