DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for **Country Music Festival 2019** to be held at **1498 State Highway 2**, **Featherston** and known as **Tauherenikau Race Course**, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Reason for decision:

The DLC Chairperson has read the Inspector's report and recommendation and accordingly issues a Special Licence under section 22 of the Sale & Supply of Alcohol Act 2012 for the Country Music Festival 2019.

Accordingly, we set the following conditions under \$147 on the licence:

Conditions

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:

Friday 11th January 2018, 10:00 am to 10:00 pm Saturday 12th January 2018, 10:00 am to 10:00 pm Sunday 13th January 2018, 10:00 am to 4:00 pm

- 2. The bar service area is designated 'supervised'. This area to be monitored.
- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 4. A certificated manager must be on duty at all times when the premises are open for the sale, supply and consumption of alcohol.
- Food must be available for consumption on the premises at all times the premises are
 open for the sale, supply and consumption of alcohol, in accordance with the sample menu
 supplied with the application for this licence, or menu variations of a similar range and
 standard.
- 6. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale, supply and consumption of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 7. The Licensee must display signage as follows:
 - a. At every point of sale/supply a sign detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and

- b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
- c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- d. Signage relating to minimising alcohol related harm to be provided by the reporting agencies.
- 8. Alcohol may be sold or supplied only to the following types of people: ticket holders
- 9. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - (i) Intoxicated persons and minors are not to be served or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.
- The licensee must notify the District Licensing Committee Chairperson of the number of tickets sold in relation to the 2019 Wairarapa Country Music Festival by Monday, 4 February 2019.
- 11. The licensee must comply with the minimum standards set out in the Alcohol Management Plan (AMP) that was presented in the application documentation. Refer: Guidelines for Managing Alcohol at Large Events (HPA).
- 12. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons at the Venue.

- 11. The licensee must comply with the minimum standards set out in the Alcohol Management Plan (AMP) that was presented in the application documentation.
