- The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - Intoxicated persons and minors are not to be served or supplied alcohol
 - If a person's age is in doubt one of the approved forms of "evidence of age" documents must be (ii) requested.

DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for Greytown Country Market to be held at 113 Main Street, Greytown, and known as Stella Bull Park Greytown, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4, s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Reason for decision:

I have considered this application on the basis of the reports received from the Licensing Inspector and the Police, who do not oppose the application. The Medical Officer of Health chose not to report on this application. The South Wairarapa District Licensing Committee Chair, acting pursuant to s.22 of the Act, therefore accordingly grants this Special Licence subject to the following conditions of the licence, set under s147.

Conditions

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption off the premises only on the following days and hours:

Sunday 17 October 2021 - 10:00am to 2:00pm.

Sunday 21 November 2021 – 10:00am to 2:00pm.

Sunday 19 December 2021 – 10:00am to 2:00pm.

Sunday 16 January 2021 - 10:00am to 2:00pm.

Sunday 20 February 2022 – 10:00am to 2:00pm.

Sunday 20 March 2022 – 10:00am to 2:00pm.

- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 3. A certificated manager must be on duty at all times when the premises are open for the sale, supply and consumption of alcohol.
- 4. The Licensee must display signage as follows:
