Special Licence

Sections 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **TIRAU LIMITED** is authorised to sell and supply alcohol, on the premises situated at **89 Main Street, Greytown** and known as **Greytown Town Centre** to any person attending the following occasion or event (or series of occasions or events):

Greytown Festival of Christmas

(Except where the District Licensing Committee grants an exemption under section 213(2) of the Act) The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption off the premises only on the following days and hours:
Friday 1 July 2022 – 3:00pm to 8:00pm
Saturday 2 July 2022 – 3:00pm to 8:00pm
Friday 8 July 2022 – 3:00pm to 8:00pm
Saturday 9 July 2022 – 3:00pm to 8:00pm
Friday 29 July 2022 – 3:00pm to 8:00pm
Saturday 30 July 2022 – 3:00pm to 8:00pm
2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
3. A certificated manager must be on duty at all times when the premises are open for the sale, supply and consumption of alcohol.
4. The Licensee must display signage as follows:
 - a. At every point of sale/supply a sign detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
5. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - (i) Intoxicated persons and minors are not to be served or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.

The recommended conditions are consistent with those associated with an off-site special licence.

Duration This licence is in force from 3pm to 8pm on 1st and 2nd July 2022, from 3pm to 8pm on 8th and 9th July 2022 and from 3pm to 8pm on 29th and 30th July 2022

DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for **Tirau Limited's** participation in the **Greytown Festival of Christmas** to be held at **89 Main Street, Greytown**, known as **Greytown Town Centre**. Alcohol will be sold for consumption off the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publically notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4, s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147.

Reason for decision:

I have considered this application on the basis of the reports received from the Licensing Inspector and the Police, who do not oppose the application. The Medical Officer of Health chose not to report on this application. The South Wairarapa District Licensing Committee Chair, acting pursuant to s.22 of the Act, therefore accordingly grants this Special Licence subject to the following conditions of the licence, set under s147.

Conditions:

1. Alcohol may be supplied or sold for consumption off the premises only on the following days and hours:

Friday 1 July 2022 – 3:00pm to 8:00pm.

Saturday 2 July 2022 – 3:00pm to 8:00pm.

Friday 8 July 2022 – 3:00pm to 8:00pm.

Saturday 9 July 2022 – 3:00pm to 8:00pm.

Friday 29 July 2022 – 3:00pm to 8:00pm.

Saturday 30 July 2022 – 3:00pm to 8:00pm.

2. The licensed area is **undesignated**.
3. A certificated manager must be on duty at all times when the premises are open for the supply or sale of alcohol.
4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
5. The Licensee must display signage as follows:
 - a. At every point of sale/supply a sign detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
6. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - (i) Intoxicated persons and minors are not to be served or supplied alcohol.
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.
