# Special Licence

- 4. Food must be available for consumption on the premises at all times the premises are open for the sale, supply and consumption of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 5. The licensee must have available for consumption on the premises, at all times when the premises is open for the sale, supply and consumption of alcohol, a reasonable range of non-alcoholic beverages.
- 6. The Licensee must display signage as follows:
  - a. At every point of supply detailing restriction on the sale and supply of alcohol to minors and intoxicated persons; and
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 7. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
  - (a) Intoxicated persons and minors are not to be served or supplied alcohol
  - (b) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.

### **DECISION DETERMINED ON THE PAPERS**

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for Martinborough School 150th School Celebration to be held at 14 Dublin Street, Martinborough and known as Martinborough School, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141. The application was not required to be publicly notified.

#### Reason for decision:

I have considered this application on the basis of the reports received from the Licensing Inspector and the Police, who do not oppose the application. The Medical Officer of Health chose not to report on this application.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4, s.142 and s.143 of the Act.

The South Wairarapa District Licensing Committee Chair, acting pursuant to s.22 of the Act, therefore accordingly grants this Special Licence subject to the following conditions of the licence, set under s147.

### **Conditions**

- 1. Alcohol may be sold, supplied and consumed on the premises only on the following day and hours: Friday 16 September 2022 - 4:00pm to 7:00pm.
- 2. The licensed area is defined as per the site plan presented in the application documentation and is designated: supervised.
- 3. A certified manager must be on duty at all times, at each bar, when the premises are open for the sale, supply and consumption of alcohol.
- 4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.

- 5. Food must be available for consumption on the premises at all times the premises are open for the sale, supply and consumption of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 6. The licensee must have available for consumption on the premises, at all times when the premises is open for the sale, supply and consumption of alcohol, a reasonable range of non-alcoholic beverages.
- 7. The Licensee must display signage as follows:
