DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for Jane Ussher's Book launch to be held at 78 Longwood East Road, Featherston, and known as Longwood Country Estate, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publicly notified.

REASON FOR DECISION:

I have considered this application on the basis of the reports received from the Licensing Inspector and the Police, who do not oppose the application. The Medical Officer of Health chose not to report on this application.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4, s.142 and s.143 of the Act.

- 5. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- Food must be available for consumption on the premises at all times the premises are open for the sale, supply and consumption of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 7. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale, supply and consumption of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
