Special Licence

Sections 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **JONATHAN REES MARKS** is authorised to sell and supply alcohol, on the premises situated at **Todds Road Martinborough**, and known as **Martinborough Golf Club** to any person attending the following occasion or event (or series of occasions or events):

GWRC Staff Christmas Golf Tournament

(Except where the District Licensing Committee grants an exemption under section 213(2) of the Act) The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

1. Alcohol may be supplied for consumption on the premises for the hours:

Friday 25 November 2022 – 11:00am to 5:00pm

2. Drinking water must be freely available at the point of alcohol service.
3. The person nominated by the licensee to be responsible for the sale and supply of alcohol must be on duty at all times the premises is open for the supply and consumption of alcohol.
4. Food must be available for consumption on the premises at all times for the supply and consumption of alcohol is available, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
5. The licensee must have available for consumption on the premises, at all times when on the premises for the supply and consumption of alcohol, a range of non-alcohol and low alcohol options such as those stipulated in the application.
6. A copy of the licence attached to the inside of the bus so as to be easily read by persons attending the premises.
7. Members of the public must be excluded from the event.
8. Alcohol may be sold and supplied only to the following types of people: registered persons only
9. The licensee must ensure compliance with the provisions of the Act regarding sale and supply to prohibited persons.
 - (i) Intoxicated persons and minors are not to be sold or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.

DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for the Greater Wellington Regional Council **Staff Christmas Golf Tournament** to be held at **Todds Road Martinborough**, and known as **Martinborough Golf Club**, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s.141 and no reports of opposition were received. The application was not required to be publicly notified.

Reason for decision:

I have considered this application on the basis of the reports received from the Licensing Inspector and the Police, who do not oppose the application. The Medical Officer of Health chose not to report on this application.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4, s.142 and s.143 of the Act.

The South Wairarapa District Licensing Committee Chair, acting pursuant to s.22 of the Act, therefore accordingly grants this Special Licence subject to the following conditions of the licence, set under s147.

Conditions

1. Alcohol may be supplied for consumption on the premises for the hours: **Friday 25 November 2022 – 11:00am to 5:00pm.**
2. The licenced premises is designated: **supervised.**
3. Alcohol may be sold and supplied only to the following types of people: **registered persons only.**
4. Members of the public must be excluded from the event.

5. The requirement for a certified duty manager is exempted and replaced by the requirement for a nominated person to be on duty at all times when the premises are open for the supply and consumption of alcohol.
6. A copy of the licence attached to the inside of the bus so as to be easily read by persons attending the premises.
7. Drinking water must be freely available at the point of alcohol service.
8. Food must be available for consumption on the premises at all times for the supply and consumption of alcohol is available, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
9. The licensee must have available for consumption on the premises, at all times when on the premises for the supply and consumption of alcohol, a range of non-alcohol and low alcohol options such as those stipulated in the application.
10. The licensee must ensure compliance with the provisions of the Act regarding sale and supply to prohibited persons.
 - a. Intoxicated persons and minors are not to be sold or supplied alcohol
 - b. If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.
