Special Licence

Sections 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **STAD_KO LIMITED** is authorised to sell and supply alcohol, on the premises situated at **23 Kitchener Street, Martinborough** and known as **Stad_ko Wines Ltd** to any person attending the following occasion or event (or series of occasions or events):

Brand awareness days Martinborough Fair

(Except where the District Licensing Committee grants an exemption under section 213(2) of the Act) The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption off the premises only on the following days and hours:
Saturday 26 November 2022 – 8:00am to 5:00pm
Saturday 4 February 2023 – 8:00am to 5:00pm
2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
3. A certificated manager must be on duty at all times when the premises are open for the sale, supply and consumption of alcohol.
4. The Licensee must display signage as follows:
 - a. At every point of sale/supply a sign detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
5. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - (i) Intoxicated persons and minors are not to be served or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.

Duration This licence is in force on **26 November 2022 from 8am to 5pm and 4 February 2023 from 8am to 5pm**

DECISION DETERMINED ON THE PAPERS

This is an application for an off-site Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for the days of the **Martinborough Fair** and relates to tastings and the sale of alcohol from **23 Kitchener Street, Martinborough**, known as **Stad_ko Wines Ltd**. Alcohol purchased will be consumed off the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s.141 and no reports of opposition were received. The application was not required to be publicly notified.

Reason for decision:

I have considered this application on the basis of the reports received from the Licensing Inspector and the Police, who do not oppose the application. The Medical Officer of Health chose not to report on this application.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4, s.142 and s.143 of the Act.

The South Wairarapa District Licensing Committee Chair, acting pursuant to s.22 of the Act, therefore accordingly grants this Special Licence subject to the following conditions of the licence, set under s147.

Conditions:

1. Alcohol may be sold or supplied for consumption off the premises only on the following days and hours:
 - **Saturday 26 November 2022 – 8:00am to 5:00pm.**
 - **Saturday 4 February 2023 – 8:00am to 5:00pm.**
2. The licenced premises are to be undesignated.
3. A certificated manager must be on duty at all times when the premises are open for the sale, supply and consumption of alcohol.

4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
5. The Licensee must display signage as follows:
 - a. At every point of sale/supply, a sign detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
6. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - a. Intoxicated persons and minors are not to be served or supplied alcohol
 - b. If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.
