 - (i) Intoxicated persons and minors are not to be served or supplied alcohol

DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for Carols at Cobblestones to be held at 169 Main Street Greytown, and known as Cobblestones Museum, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s.141 and no reports of opposition were received. The application was not required to be publicly notified.

Reason for decision:

I have considered this application on the basis of the reports received from the Licensing Inspector and the Police, who do not oppose the application. The Medical Officer of Health chose not to report on this application.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4, s.142 and s.143 of the Act.

The South Wairarapa District Licensing Committee Chair, acting pursuant to s.22 of the Act, therefore accordingly grants this Special Licence subject to the following conditions of the licence, set under s147.
