- 4. Food must be available for consumption on the premises at all times the premises are open for the supply and consumption of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 5. The licensee must have available for consumption on the premises, at all times when the premises is open for the supply and consumption of alcohol, a range of non-alcoholic beverages such as those stipulated in the application.
- 6. The Licensee must display signage as follows:
 - a. At every point of supply detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 7. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - (i) Intoxicated persons and minors are not to be served or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.

DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for Quiz Night to be held at 2773 Lake Ferry Road Martinborough, and known as Pirinoa Hall, where alcohol will be consumed on the premises.

Reason for decision:

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publicly notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147 and with the following conditions:

1. Alcohol may be supplied for consumption on the premises only on the following days and hours:

Friday 28th April 2023, 6:30 pm to 11:00pm

- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 3. A certificate holding duty manager must be on duty at all times the premises are open for the supply and consumption of alcohol.
- 4. Food must be available for consumption on the premises at all times the premises are open for the supply and consumption of alcohol, in accordance with the sample meny supplied with the application for this licence, or meny variations of a similar range and standard.

- 5. The licensee must have available for consumption on the premises, at all times when the premises is open for the supply and consumption of alcohol, a range of non-alcoholic beverages such as those stipulated in the application.
- 6. The Licensee must display signage as follows:
 - a. At every point of supply detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 7. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - a. Intoxicated persons and minors are not to be served or supplied alcohol, and

If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.
