DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for Martinborough Music Festival to be held at Texas Street Martinborough, and known as Waihinga Centre, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publicly notified.

We are satisfied as to the matters to which we must have regard as set out in s3, s4, s142 and s143 of the Act. We grant the applicant a special licence in terms of s22 subject to the restrictions imposed by s147 with the following conditions 1-8.
