  - a. At every point-of-sale detailing restriction on the sale and supply of alcohol to minors and intoxicated persons; and
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 5. The events are to be designated: undesignated
- 6. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
  - (i) Intoxicated persons and minors are not to be served or supplied alcohol
  - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.
- 7. Each alcohol tasting is to be no more than 30mL of product per serve.

# **DECISION DETERMINED ON THE PAPERS**

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for Greytown Country Markets, to be held at 113 Main Street Greytown, and known as Stella Bull Park, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publicly notified.

We are satisfied as to the matters to which we must have regard as set out in s3, s4 and s142 and s143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147 with the following conditions 1-7.

Alcohol may be sold or supplied for consumption off the premises only on the following 1. days and hours:

Sunday 15 October 2023 10:00am to 2:00pm, Sunday 19 November 2023 10:00am to 2:00pm, Sunday 17 December 2023 10:00am to 2:00pm, Sunday 21 January 2024 10:00am to 2:00pm, Sunday 18 February 2024 10:00am to 2:00pm, and Sunday 17 March 2024 10:00am to 2:00pm

- Drinking water is to be provided to patrons free of charge from a water supply prominently 2. situated on the premises.
- A certificated manager must be on duty at all times when the premises are open for 3, the sale, supply and consumption of alcohol.

- 4. The Licensee must display signage as follows:
  - a. At every point-of-sale detailing restriction on the sale and supply of alcohol to minors and intoxicated persons; and
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 5. The events are to be **undesignated**.
- 6. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
  - a. Intoxicated persons and minors are not to be served or supplied alcohol, and
  - b. If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.

Each alcohol tasting is to be no more than 30mL of product per serve.
