Sections 22 and 64, Sale and Supply of Alcohol Act 2012

Conditions

Saturday 9 March 2024 - 12:00pm to 6:00pm

- 2. All alcohol products for consumption off the premises must be sold in a sealed container.
- 3. All off licence purchases may only be collected from the information station upon exiting the licenced area. No sealed vessels are permitted to remain inside or re-enter the licensed area.
- 4. Each alcohol sample size is to be no more than 10mL.
- 5. Drinking water is to be made freely available to customers while alcohol is being supplied free as a sample on the premises.
- 6. A certificated manager must be on duty at all times when the premises are open for the sale, supply and consumption of alcohol.
- 7. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restriction on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 8. The whole of the licensed area is to be designated as: Restricted
- 9. Alcohol may be sold or supplied only to the following types of people: ticket holders only.
- 10. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.
 - (i) Intoxicated persons and minors are not to be served or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.

Duration This licence is in force on 09 March 2024 from 12:00pm midday to 6:00pm



DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of The application is for Gintastic to be held at 58 Moroa Road Alcohol Act 2012. Tauherenikau and known as Greytown Honey where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publicly notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147 with the following conditions 1-10.

Alcohol may be sold or supplied for consumption off the premises only on the 1. following days and hours:

Saturday 9 March 2024 - 12:00pm to 6:00pm

- All alcohol products for consumption off the premises must be sold in a sealed container. 2.
- All off-licence purchases may only be collected from the information station upon exiting 3. the licenced area. No sealed vessels are permitted to remain inside or re-enter the licensed area.
- Each alcohol sample size is to be no more than 10mL. 4.
- Drinking water is to be made freely available to customers while alcohol is being 5. supplied free as a sample on the premises.
- A certificated manager must be on duty at all times when the premises are open for 6. the sale, supply and consumption of alcohol.

- 7. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restriction on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 8. The whole of the licensed area is to be designated as: **Restricted**
- 9. Alcohol may be sold or supplied only to the following types of people: ticket holders only.
- 10. The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons:
 - a. Intoxicated persons and minors are not to be served or supplied alcohol, and
 - b. If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.
