DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for **3x events** to be held at **52 Todds Road, Martinborough**, and known as **Martinborough Golf Club** where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publicly notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147 with the following conditions 1-12.

1. Alcohol may be supplied for consumption on the premises for the hours:

Lamb & Chardonnay Ambrose 13 October 2024 between 10:30am to 4:30pm
ProAm & Sponsors Evening 23 January 2025 between 10:30am to 5:30pm
Beef & Burgundy Ambrose 04 May 2025 between 10:30am to 4:30pm
2. Drinking water must be freely available at the point of alcohol service.
3. The person nominated by the licensee to be responsible for the sale and supply of alcohol must be on duty at all times the premises is open for the supply and consumption of alcohol.
4. Food must be available for consumption on the premises at all times for the supply and consumption of alcohol is available, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.

5. The licensee must have available for consumption on the premises, at all times when on the premises for the supply and consumption of alcohol, a range of non-alcohol and low alcohol options such as those stipulated in the application.
6. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restriction on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
7. Members of the public must be excluded from the event.
8. Alcohol may be sold and supplied only to registered persons only.
9. The events are to be designated: **restricted**.
10. The maximum number of alcoholic drinks per sale transaction is limited to 4.
11. No BYO is to be permitted.
12. The licensee must ensure compliance with the provisions of the Act regarding sale and supply to prohibited persons.
 - a. Intoxicated persons and minors are not to be sold or supplied alcohol, and
 - b. If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.

Special Licence

Sections 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Martinborough Golf Club Incorporated** is authorised to sell and supply alcohol, on the premises situated at **52 Todds Road, Martinborough**, and known as **Martinborough Golf Club** to any person attending the following occasion or event (or series of occasions or events):

3x Golf Club Events

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

1. Alcohol may be supplied for consumption on the premises for the hours:
Lamb & Chardonnay Ambrose 13 October 2024 between 10:30am to 4:30pm
ProAm & Sponsors Evening 23 January 2025 between 10:30am to 5:30pm
Beef & Burgundy Ambrose 04 May 2025 between 10:30am to 4:30pm
2. Drinking water must be freely available at the point of alcohol service.
3. The person nominated by the licensee to be responsible for the sale and supply of alcohol must be on duty at all times the premises is open for the supply and consumption of alcohol.
4. Food must be available for consumption on the premises at all times for the supply and consumption of alcohol is available, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
5. The licensee must have available for consumption on the premises, at all times when on the premises for the supply and consumption of alcohol, a range of non-alcohol and low alcohol options such as those stipulated in the application.
6. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restriction on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and

9. The events are to be designated: **restricted**
10. The maximum number of alcoholic drinks per sale transaction is limited to 4.
11. No BYO is to be permitted.
12. The licensee must ensure compliance with the provisions of the Act regarding sale and supply to prohibited persons.
 - (i) Intoxicated persons and minors are not to be sold or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.
