IN THE MATTER of an application by **South Wairarapa Bridge Club Incorporated** for a Special Licence pursuant to s.22 of the Act in respect of premises situated at **89 Main Street, Greytown**, and known as **Greytown Town Centre**

DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for **Bridge Club Award Dinner** to be held at **89 Main Street, Greytown**, and known as **Greytown Town Centre**, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publicly notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147 with the following conditions 1-8.

1. Alcohol may be sold or supplied for consumption on the premises to event participants only on the following days and hours:

Monday 9 December 2024 – 6:00pm to 10:00pm

2. The event is to be designated as: “**restricted**”.
3. The requirement for a certified duty manager is exempted and replaced by the requirement for a nominated person to be on duty at all times when the premises are open for the supply and consumption of alcohol.
4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
5. Food must be available for consumption on the premises at all times the premises are open for the sale, supply, and consumption of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
6. The licensee must have available for consumption on the premises, a reasonable range of non-alcoholic beverages, at all times when the premises are open for the sale, supply, and consumption of alcohol.

7. The Licensee must display signage as follows:
 - a. At every point of sale/supply detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
8. The licensee must ensure compliance with the provisions of the Act regarding sale and supply of alcohol to prohibited persons:
 - a. Intoxicated persons and minors are not to be served or supplied alcohol, and
 - b. If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.

Special Licence

Sections 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **SOUTH WAIRARAPA BRIDGE CLUB INCORPORATED** is authorised to sell and supply alcohol, on the premises situated at **89 Main Street, Greytown**, and known as **Greytown Town Centre** to any person attending the following occasion or event (or series of occasions or events):

Bridge Club Award Dinner

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption on the premises to event participants only on the following days and hours:

Monday 9 December 2024 – 6:00pm to 10:00pm

2. The event is to be designated as: **“restricted”**.
3. The requirement for a certified duty manager is exempted and replaced by the requirement for a nominated person to be on duty at all times when the premises are open for the supply and consumption of alcohol.
4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
5. Food must be available for consumption on the premises at all times the premises are open for the sale, supply, and consumption of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
6. The licensee must have available for consumption on the premises, a reasonable range of non-alcoholic beverages, at all times when the premises are open for the sale, supply, and consumption of alcohol.
7. The licensee must display signage as follows:
 - a. At every point of sale/supply detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
8. The licensee must ensure compliance with the provisions of the Act regarding sale and supply of alcohol to prohibited persons:
 - (i) Intoxicated persons and minors are not to be served or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.
