 - A copy of the licence attached to the premises so as to be easily read by persons attending the premises;
 and

- 7. Alcohol may be sold or supplied only to the following types of people: event participants and their guests.

 - (i) Intoxicated persons and minors are not to be served or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested



DECISION DETERMINED ON THE PAPERS
