- 6. The licensee must have available for consumption on the premises, a reasonable range of non-alcoholic beverages, at all times when the premises are open for the sale, supply, and consumption of alcohol.
- 7. The Licensee must display signage as follows:
 - a. At every point of sale/supply detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 8. The licensee must ensure compliance with the provisions of the Act regarding sale and supply of alcohol to prohibited persons:
 - (i) Intoxicated persons and minors are not to be served or supplied alcohol
 - (ii) If a person's age is in doubt one of the approved forms of "evidence of age" documents must be requested.



DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for **Big Sky Vines** to be held at **950 White Rock Road**, **RD 2 Martinborough**, and known as **Blue Earth Estate**, where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publicly notified.
