## **DECISION DETERMINED ON THE PAPERS**

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012. The application is for the Truckstop Festival of Christmas to be held at 102 Main Street, Greytown and known as "Truckstop Greytown", where alcohol will be consumed on the premises.

The application was sent to the Police, Inspector and Medical Officer of Health under s. 141 and no reports of opposition were received. The application was not required to be publicly notified.

We are satisfied as to the matters to which we must have regard as set out in s. 3, s. 4 and s.142 and s.143 of the Act. We grant the applicant a special licence in terms of s.22 subject to the restrictions imposed by s.147 with the following conditions 1-8.
