- 5. Food must be available for consumption on the premises at all times the premises are open for the sale, supply and consumption of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.

The Licensee must display signage as follows:

- a. At every point-of-sale detailing restriction on the sale and supply of alcohol to minors and intoxicated persons; and
- b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
- c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.

The events are to be designated: Supervised

The licensee must ensure compliance with the provisions of the Act regarding sale to prohibited persons.

Intoxicated persons and minors are not to be served or supplied alcohol (i)

If a person's age is in doubt one of the approved forms of "evidence of age" documents must be (ii) requested.


